Making the Leap to digital filing

- ❑ Prior to 2003, **manual processes** from registration to extraction of information
- ❑ **Long waiting time during peak periods** - counters served about 800 people during office hours (8 am to 5 pm)
- ❑ **Services were available only during office hours/working days**
- ❑ **Long approval process** - approval of name & incorporation took 14 days, information updated between 14 to 21 days

Making the Leap to digital filing

- ❑ **2003 - Bizfile system commissioned**
- ❑ **Allows for quick and transparent end-to-end transactions from registration to incorporation**
- ❑ **Over 300 e-services available 24/7**
- ❑ **Enables real time corporate information to be made available to the public**
- ❑ **Reduce Business Costs**
- ❑ **Ability for system to monitor statutory disclosure requirements**
