## ACCOUNTANTS ACT 2004

### ACCOUNTANTS (PRESCRIBED STANDARDS AND CODE OF PROFESSIONAL CONDUCT AND ETHICS) ORDER 2023

In exercise of the powers conferred by section 64AA of the Accountants Act 2004, the Public Accountants Oversight Committee makes the following Order:

#### **Citation and commencement**

1. This Order is the Accountants (Prescribed Standards and Code of Professional Conduct and Ethics) Order 2023 and comes into operation on 1 July 2023.

#### **Definitions**

2. In this Order —

“accounting entity” has the meaning given by section 38B of the Act;

“professional standards” has the meaning given by section 32 of the Act;

“quality control standards” has the meaning given by section 38B of the Act.

#### **Prescribed professional standards**

3.—(1) For the purposes of the definition of “professional standards” in section 32 of the Act, the prescribed standards are —

(a) where public accountancy services are provided to a permitted entity —

(i) the Singapore Standards on Auditing issued by the Institute of Singapore Chartered Accountants specified in the First Schedule; or

(ii) the International Standards on Auditing issued by the International Federation of Accountants specified in the Second Schedule; or

(b) where public accountancy services are provided to any other entity — the Singapore Standards on Auditing issued by the Institute of Singapore Chartered Accountants specified in the First Schedule.

(2) In this paragraph —

“corporation” has the meaning given by section 4(1) of the Companies Act 1967;

“entity” means any sole proprietorship, corporation, partnership or other body of persons (whether corporate or incorporate) and includes a trust;

“permitted entity” means any entity that is —

- (a) incorporated, formed, registered or established in Singapore and listed on a stock exchange outside Singapore; or
- (b) incorporated, formed, registered or established outside Singapore and whose shares or stock are quoted or listed on a stock exchange operated by Singapore Exchange Limited.

### **Prescribed quality control standards**

4. For the purposes of the definition of “quality control standards” in section 38B of the Act, the prescribed standards are the following standards issued by the Institute of Singapore Chartered Accountants specified in the Third Schedule:

- (a) Singapore Standards on Quality Control specified in Part 1 of that Schedule;
- (b) Singapore Standards on Quality Management specified in Part 2 of that Schedule.

### **Prescribed code of professional conduct and ethics**

5. The code of professional conduct and ethics prescribed for the purpose of section 64AA(1)(a) of the Act is the Code of Professional Conduct and Ethics applicable to public accountants and accounting entities set out in the Fourth Schedule.

<b>GLOSSARY, INCLUDING LISTS OF ABBREVIATIONS</b>	
SCOPE	
SG010.1	This Code of Professional Conduct and Ethics for Public Accountants and Accounting Entities (Code) establishes ethical requirements for public accountants, accounting firms, accounting corporations and accounting LLPs. Compliance with this Code is mandatory for all public accountants, accounting firms, accounting corporations and accounting LLPs and failure to observe the Code may result in disciplinary action.
SG010.2	This Code applies to the provision of public accountancy services by public accountants, accounting firms, accounting corporations and accounting LLPs. Under the Accountants Act 2004, public



	accountancy services means the audit and reporting on financial statements and the doing of any other acts that are required by any written law to be done by a public accountant. For non-public accountancy services, public accountants should refer to the code of ethics of their professional body.

<b>PART 1 — COMPLYING WITH THE CODE, FUNDAMENTAL PRINCIPLES AND CONCEPTUAL FRAMEWORK</b>	
<b>SECTION 100</b>	
<b>COMPLYING WITH THE CODE</b>	
<b>Introduction</b>	
100.1	A distinguishing mark of the accountancy profession is its acceptance of the responsibility to act in the public interest.
100.2	Confidence in the accountancy profession is a reason why businesses, governments and other organisations involve public accountants in a broad range of areas, including financial and corporate reporting, assurance and other professional activities. Public accountants understand and acknowledge that such confidence is based on the skills and values that public accountants bring to the professional activities they undertake, including — <ul style="list-style-type: none"> <li>(a) Adherence to ethical principles and professional standards;</li> <li>(b) Use of business acumen;</li> <li>(c) Application of expertise on technical and other matters; and</li> </ul>

	<p>(d) Exercise of professional judgment.</p> <p>The application of these skills and values enables public accountants to provide advice or other output that meets the purpose for which it was provided, and which can be relied upon by the intended users of such output.</p>
100.3	The Code sets out high quality standards of ethical behaviour expected of public accountants.
100.4	The Code establishes five fundamental principles to be complied with by all public accountants. It also includes a conceptual framework that sets out the approach to be taken to identify, evaluate and address threats to compliance with those fundamental principles and, for audits and other assurance engagements, threats to independence. The Code also applies the fundamental principles and the conceptual framework to a range of facts and circumstances that public accountants might encounter.
<b>Requirements and Application Material</b>	
100.5 A1	The requirements in the Code, designated with the letter “R”, impose obligations.
100.5 A2	Application material, designated with the letter “A”, provides context, explanations, suggestions for actions or matters to consider, illustrations and other guidance relevant to a proper understanding of the Code. In particular, the application material is intended to help a public accountant to understand how to apply the conceptual framework to a particular set of circumstances and to understand and comply with a specific requirement. While such application material does not of itself impose a requirement, consideration of the material is necessary to the proper application of the requirements of the Code, including application of the conceptual framework.
<b>R100.6</b>	A public accountant shall comply with the Code.
100.6 A1	Upholding the fundamental principles and compliance with the specific requirements of the Code enable public accountants to meet their responsibility to act in the public interest.
100.6 A2	Complying with the Code includes giving appropriate regard to the aim and intent of the specific requirements.
100.6 A3	Compliance with the requirements of the Code does not mean that public accountants will have always met their responsibility to act in the public interest. There might be unusual or exceptional circumstances in which a public accountant believes that complying with a requirement or requirements of the Code might not be in the public interest or would lead to a

	disproportionate outcome. In those circumstances, the public accountant is encouraged to consult with an appropriate body such as a professional or regulatory body.
100.6 A4	In acting in the public interest, a public accountant considers not only the preferences or requirements of an individual client, but also the interests of other stakeholders when performing professional activities.
<b>R100.7</b>	If there are circumstances where laws or regulations preclude a public accountant from complying with certain parts of the Code, those laws and regulations prevail, and the public accountant shall comply with all other parts of the Code.
100.7 A1	The principle of professional behaviour requires a public accountant to comply with relevant laws and regulations. Some jurisdictions might have provisions that differ from or go beyond those set out in the Code. Accountants in those jurisdictions need to be aware of those differences and comply with the more stringent provisions unless prohibited by law or regulation.
<b>Breaches of the Code</b>	
<b>R100.8</b>	Paragraphs R400.80 to R400.89 and R900.50 to R900.55 address a breach of <i>Independence Standards</i> . A public accountant who identifies a breach of any other provision of the Code shall evaluate the significance of the breach and its impact on the public accountant's ability to comply with the fundamental principles. The public accountant shall also — <ul style="list-style-type: none"> <li>(a) Take whatever actions might be available, as soon as possible, to address the consequences of the breach satisfactorily; and</li> <li>(b) Determine whether to report the breach to the relevant parties.</li> </ul>
100.8 A1	Relevant parties to whom such a breach might be reported include those who might have been affected by it, a professional or regulatory body or an oversight authority.
<b>SECTION 110</b>	
<b>THE FUNDAMENTAL PRINCIPLES</b>	
<b>General</b>	
110.1 A1	There are five fundamental principles of ethics for public accountants — <ul style="list-style-type: none"> <li>(a) Integrity — to be straightforward and honest in all professional and business relationships;</li> </ul>

	<p>(b) Objectivity — to exercise professional or business judgments without being compromised by —</p> <ul style="list-style-type: none"> <li>(i) Bias;</li> <li>(ii) Conflict of interest; or</li> <li>(iii) Undue influence of, or undue reliance on, individuals, organisations, technology or other factors;</li> </ul> <p>(c) Professional Competence and Due Care —</p> <ul style="list-style-type: none"> <li>(i) to attain and maintain professional knowledge and skill at the level required to ensure that a client receives competent professional service, based on current technical and professional standards and relevant legislation; and</li> <li>(ii) to act diligently and in accordance with applicable technical and professional standards;</li> </ul> <p>(d) Confidentiality — to respect the confidentiality of information acquired as a result of professional and business relationships; and</p> <p>(e) Professional Behaviour — to —</p> <ul style="list-style-type: none"> <li>(i) Comply with relevant laws and regulations;</li> <li>(ii) Behave in a manner consistent with the profession’s responsibility to act in the public interest in all professional activities and business relationships; and</li> <li>(iii) Avoid any conduct that the public accountant knows or should know might discredit the profession.</li> </ul>
<b>R110.2</b>	A public accountant shall comply with each of the fundamental principles.
110.2 A1	The fundamental principles of ethics establish the standard of behaviour expected of a public accountant. The conceptual framework establishes the approach which a public accountant is required to apply in complying with those fundamental principles. Subsections 111 to 115 set out requirements and application material related to each of the fundamental principles.

110.2 A2	<p>A public accountant might face a situation in which complying with one fundamental principle conflicts with complying with one or more other fundamental principles. In such a situation, the public accountant might consider consulting, on an anonymous basis if necessary, with —</p> <p>(a) Others within the firm;</p> <p>(b) Those charged with governance;</p> <p>(c) A professional body;</p> <p>(d) A regulatory body;</p> <p>(e) Legal counsel.</p> <p>However, such consultation does not relieve the public accountant from the responsibility to exercise professional judgment to resolve the conflict or, if necessary, and unless prohibited by law or regulation, disassociate from the matter creating the conflict.</p>
110.2 A3	The public accountant is encouraged to document the substance of the issue, the details of any discussions, the decisions made and the rationale for those decisions.
<b>SUBSECTION 111 — INTEGRITY</b>	
<b>R111.1</b>	A public accountant shall comply with the principle of integrity, which requires a public accountant to be straightforward and honest in all professional and business relationships.
111.1 A1	Integrity involves fair dealing, truthfulness and having the strength of character to act appropriately, even when facing pressure to do otherwise or when doing so might create potential adverse personal or organisational consequences.
111.1 A2	<p>Acting appropriately involves —</p> <p>(a) Standing one’s ground when confronted by dilemmas and difficult situations; or</p> <p>(b) Challenging others as and when circumstances warrant,</p> <p>in a manner appropriate to the circumstances.</p>
<b>R111.2</b>	<p>A public accountant shall not knowingly be associated with reports, returns, communications or other information where the public accountant believes that the information —</p> <p>(a) Contains a materially false or misleading statement;</p>

	<p>(b) Contains statements or information provided recklessly; or</p> <p>(c) Omits or obscures required information where such omission or obscurity would be misleading.</p>
111.2 A1	If a public accountant provides a modified report in respect of such a report, return, communication or other information, the public accountant is not in breach of paragraph R111.2.
<b>R111.3</b>	When a public accountant becomes aware of having been associated with information described in paragraph R111.2, the public accountant shall take steps to be disassociated from that information.
<b>SUBSECTION 112 — OBJECTIVITY</b>	
<b>R112.1</b>	<p>A public accountant shall comply with the principle of objectivity, which requires a public accountant to exercise professional or business judgment without being compromised by —</p> <p>(a) Bias;</p> <p>(b) Conflict of interest; or</p> <p>(c) Undue influence of, or undue reliance on, individuals, organisations, technology or other factors.</p>
<b>R112.2</b>	A public accountant shall not undertake a professional activity if a circumstance or relationship unduly influences the public accountant's professional judgment regarding that activity.
<b>SUBSECTION 113 — PROFESSIONAL COMPETENCE AND DUE CARE</b>	
<b>R113.1</b>	<p>A public accountant shall comply with the principle of professional competence and due care, which requires a public accountant to —</p> <p>(a) Attain and maintain professional knowledge and skills at the level required to ensure that a client receives competent professional service, based on current technical and professional standards and relevant legislation; and</p> <p>(b) Act diligently and in accordance with applicable technical and professional standards.</p>
113.1 A1	Serving clients with professional competence involves the exercise of sound judgment in applying professional knowledge

	and skills.
113.1 A2	The knowledge and skills necessary for a professional activity vary depending on the nature of the activity being undertaken. For example, in addition to the application of any technical knowledge relevant to the professional activity, interpersonal, communication and organisational skills facilitate the public accountant's interaction with entities and individuals with whom the public accountant interacts.
113.1 A3	Maintaining professional competence requires a public accountant to have a continuing awareness and understanding of technical, professional, business and technology-related developments relevant to the professional activities undertaken by the public accountant. Continuing professional development enables a public accountant to develop and maintain the capabilities to perform competently within the professional environment.
113.1 A4	Diligence encompasses the responsibility to act in accordance with the requirements of an assignment, carefully, thoroughly and on a timely basis.
<b>R113.2</b>	In complying with the principle of professional competence and due care, a public accountant shall take reasonable steps to ensure that those working in a professional capacity under the public accountant's authority have appropriate training and supervision.
<b>R113.3</b>	Where appropriate, a public accountant shall make clients, or other users of the public accountant's professional activities, aware of the limitations inherent in the activities and explain the implications of those limitations.
<b>SUBSECTION 114 — CONFIDENTIALITY</b>	
<b>R114.1</b>	<p>A public accountant shall comply with the principle of confidentiality, which requires a public accountant to respect the confidentiality of information acquired in the course of professional and business relationships. A public accountant shall —</p> <p>(a) Be alert to the possibility of inadvertent disclosure, including in a social environment, and particularly to a close business associate or an immediate or a close family member;</p> <p>(b) Maintain confidentiality of information within the firm;</p>

	<p>(c) Maintain confidentiality of information disclosed by a prospective client; and</p> <p>(d) Take reasonable steps to ensure that personnel under the public accountant’s control, and individuals from whom advice and assistance are obtained, comply with the public accountant’s duty of confidentiality.</p> <p>(e) <i>[Deleted by S 958/2024 wef 15/12/2024]</i></p> <p>(f) <i>[Deleted by S 958/2024 wef 15/12/2024]</i></p> <p>(g) <i>[Deleted by S 958/2024 wef 15/12/2024]</i></p>

<p>114.3 A2</p>	<p>In deciding whether to disclose or use confidential information, factors to consider, depending on the circumstances, include —</p> <p>(a) Whether the interests of any parties, including third parties whose interests might be affected, could be harmed if the client authorises the disclosure or use of information by the public accountant;</p> <p>(b) Whether all the relevant information is known and substantiated, to the extent practicable. Factors affecting the decision to disclose or use the</p>

	<p>information, include —</p> <p>(i) Unsubstantiated facts;</p> <p>(ii) Incomplete information; and</p> <p>(iii) Unsubstantiated conclusions;</p> <p>(c) The proposed means of communicating the information;</p> <p>(d) Whether the parties to whom the information is to be provided or access is to be granted are appropriate recipients; and</p>
	<p>(e) Any applicable law or regulation (including those governing privacy) in a jurisdiction where disclosure might take place and, if different, the jurisdiction where the confidential information originates.</p>
114.3 A3	<p>The circumstances in which a firm seeks authorisation to use or disclose confidential information, include where the information is to be used for training purposes, in the development of products or technology, in research or as source material for industry or other benchmarking data or studies. Such authorisation might be general in its application (for example, in relation to use of the information for internal training purposes or quality enhancement initiatives). When obtaining the authorisation of the individual or entity that provided such information for use in specific circumstances, relevant considerations to be communicated (preferably in writing) might include —</p>
	<p>(a) The nature of the information to be used or disclosed;</p>
	<p>(b) The purpose for which the information is to be used or disclosed (for example, technology development, research or benchmarking data or studies);</p>

<b>R114.4</b>	A public accountant shall continue to comply with the principle of confidentiality even after the end of the relationship between the public accountant and a client. When changing employment or acquiring a new client, the public accountant is entitled to use prior experience but shall not use or disclose any confidential information acquired or received as a result of a professional or business relationship.
<b>SUBSECTION 115 — PROFESSIONAL BEHAVIOUR</b>	
<b>R115.1</b>	<p>A public accountant shall comply with the principle of professional behaviour, which requires a public accountant to —</p> <ul style="list-style-type: none"> <li>(a) Comply with relevant laws and regulations;</li> <li>(b) Behave in a manner consistent with the profession’s responsibility to act in the public interest in all professional activities and business relationships; and</li> <li>(c) Avoid any conduct that the public accountant knows or should know might discredit the profession.</li> </ul> <p>A public accountant shall not knowingly engage in any business, occupation or activity that impairs or might impair the integrity, objectivity or good reputation of the profession, and as a result would be incompatible with the fundamental principles.</p>
115.1 A1	Conduct that might discredit the profession includes conduct that a reasonable and informed third party would be likely to conclude adversely affects the good reputation of the profession.
<b>R115.2</b>	<p>When undertaking marketing or promotional activities, a public accountant shall not bring the profession into disrepute. A public accountant shall be honest and truthful and shall not make —</p> <ul style="list-style-type: none"> <li>(a) Exaggerated claims for the services offered by, or the qualifications or experience of, the public accountant; or</li> <li>(b) Disparaging references or unsubstantiated comparisons to the work of others.</li> </ul>
115.2 A1	If a public accountant is in doubt about whether a form of advertising or marketing is appropriate, the public accountant is encouraged to consult with the relevant professional body.
<b>SECTION 120</b>	
<b>THE CONCEPTUAL FRAMEWORK</b>	
<b>Introduction</b>	
120.1	The circumstances in which public accountants operate might

	create threats to compliance with the fundamental principles. Section 120 sets out requirements and application material, including a conceptual framework, to assist public accountants in complying with the fundamental principles and meeting their responsibility to act in the public interest. Such requirements and application material accommodate the wide range of facts and circumstances, including the various professional activities, interests and relationships, that create threats to compliance with the fundamental principles. In addition, they deter public accountants from concluding that a situation is permitted solely because that situation is not specifically prohibited by the Code.
120.2	The conceptual framework specifies an approach for a public accountant to — <ul style="list-style-type: none"> <li>(a) Identify threats to compliance with the fundamental principles;</li> <li>(b) Evaluate the threats identified; and</li> <li>(c) Address the threats by eliminating or reducing them to an acceptable level.</li> </ul>
<b>Requirements and Application Material</b>	
<b>General</b>	
<b>R120.3</b>	The public accountant shall apply the conceptual framework to identify, evaluate and address threats to compliance with the fundamental principles set out in Section 110.
120.3 A1	Additional requirements and application material that are relevant to the application of the conceptual framework are set out in — <ul style="list-style-type: none"> <li>(a) Part 3 — <i>Public accountants</i>; and</li> <li>(b) <i>Independence Standards</i>, as follows: <ul style="list-style-type: none"> <li>(i) Part 4A — <i>Independence for Audit and Review Engagements</i>; and</li> <li>(ii) Part 4B — <i>Independence for Assurance Engagements Other than Audit and Review Engagements</i>.</li> </ul> </li> </ul>
<b>R120.4</b>	When dealing with an ethics issue, the public accountant shall consider the context in which the issue has arisen or might arise.
<b>R120.5</b>	When applying the conceptual framework, the public accountant shall —

	<ul style="list-style-type: none"> <li>(a) Have an inquiring mind;</li> <li>(b) Exercise professional judgment; and</li> <li>(c) Use the reasonable and informed third party test described in paragraph 120.5 A9.</li> </ul>
<i>Having an Inquiring Mind</i>	
120.5 A1	<p>An inquiring mind is a prerequisite to obtaining an understanding of known facts and circumstances necessary for the proper application of the conceptual framework. Having an inquiring mind involves —</p> <ul style="list-style-type: none"> <li>(a) Considering the source, relevance and sufficiency of information obtained, taking into account the nature, scope and outputs of the professional activity being undertaken; and</li> <li>(b) Being open and alert to a need for further investigation or other action.</li> </ul>
120.5 A2	<p>When considering the source, relevance and sufficiency of information obtained, the public accountant might consider, among other matters, whether —</p> <ul style="list-style-type: none"> <li>(a) New information has emerged or there have been changes in facts and circumstances;</li> <li>(b) The information or its source might be influenced by bias or self-interest;</li> <li>(c) There is reason to be concerned that potentially relevant information might be missing from the facts and circumstances known to the public accountant;</li> <li>(d) There is an inconsistency between the known facts and circumstances and the public accountant's expectations;</li> <li>(e) The information provides a reasonable basis on which to reach a conclusion; and</li> <li>(f) There might be other reasonable conclusions that could be reached from the information obtained.</li> </ul>
120.5 A3	<p>Paragraph R120.5 requires all public accountants to have an inquiring mind when identifying, evaluating and addressing threats to the fundamental principles. This prerequisite for</p>

	<p>applying the conceptual framework applies to all public accountants regardless of the professional activity undertaken. Under auditing, review and other assurance standards, including those issued by the Institute of Singapore Chartered Accountants, public accountants are also required to exercise professional scepticism, which includes a critical assessment of evidence.</p>
<p><i>Exercising Professional Judgment</i></p>	
120.5 A4	<p>Professional judgment involves the application of relevant training, professional knowledge, skill and experience commensurate with the facts and circumstances, taking into account the nature and scope of the particular professional activities, and the interests and relationships involved.</p>
120.5 A5	<p>Professional judgment is required when the public accountant applies the conceptual framework in order to make informed decisions about the courses of actions available, and to determine whether such decisions are appropriate in the circumstances. In making this determination, the public accountant might consider matters such as whether —</p> <ul style="list-style-type: none"> <li>(a) The public accountant’s expertise and experience are sufficient to reach a conclusion;</li> <li>(b) There is a need to consult with others with relevant expertise or experience; and</li> <li>(c) The public accountant’s own preconception or bias might be affecting the public accountant’s exercise of professional judgment.</li> </ul>
120.5 A6	<p>The circumstances in which public accountants carry out professional activities and the factors involved vary considerably in their range and complexity. The professional judgment exercised by public accountants might need to take into account the complexity arising from the compounding effect of the interaction between, and changes in, elements of the facts and circumstances that are uncertain and variables and assumptions that are interconnected or interdependent.</p>
120.5 A7	<p>Managing complexity involves —</p> <ul style="list-style-type: none"> <li>(a) Making the firm and, if appropriate, relevant stakeholders aware of the inherent uncertainties or difficulties arising from the facts and circumstances. (Ref: Para. R113.3); or</li> <li>(b) Being alert to any developments or changes in the facts and circumstances and assessing whether they</li> </ul>

	might impact any judgments the public accountant has made. (Ref: Paras. R120.5 to 120.5 A3, and R120.9 to 120.9 A2).
120.5 A8	Managing complexity might also involve —
	(a) Analysing and investigating as relevant, any uncertain elements, the variables and assumptions and how they are connected or interdependent;
	(b) Using technology to analyse relevant data to inform the public accountant’s judgment; or
	(c) Consulting with others, including experts, to ensure appropriate challenge and additional input as part of the evaluation process.
<i>Reasonable and Informed Third Party</i>	
120.5 A9	The reasonable and informed third party test is a consideration by the public accountant about whether the same conclusions would likely be reached by another party. Such consideration is made from the perspective of a reasonable and informed third party, who weighs all the relevant facts and circumstances that the public accountant knows, or could reasonably be expected to know, at the time the conclusions are made. The reasonable and informed third party does not need to be a public accountant, but would possess the relevant knowledge and experience to understand and evaluate the appropriateness of the public accountant’s conclusions in an impartial manner.
<b>Identifying Threats</b>	
<b>R120.6</b>	The public accountant shall identify threats to compliance with the fundamental principles.
120.6 A1	An understanding of the facts and circumstances, including any professional activities, interests and relationships that might compromise compliance with the fundamental principles, is a prerequisite to the public accountant’s identification of threats to such compliance. The existence of certain conditions, policies and procedures established by the profession, legislation, regulation or the firm that can enhance the public accountant acting ethically might also help identify threats to compliance with the fundamental principles.

	Paragraph 120.8 A2 includes general examples of such conditions, policies and procedures which are also factors that are relevant in evaluating the level of threats.
120.6 A2	Threats to compliance with the fundamental principles might be created by a broad range of facts and circumstances. It is not possible to define every situation that creates threats. In addition, the nature of engagements and work assignments might differ and, consequently, different types of threats might be created.
120.6 A3	<p>Threats to compliance with the fundamental principles fall into one or more of the following categories:</p> <ul style="list-style-type: none"> <li>(a) Self-interest threat — the threat that a financial or other interest will inappropriately influence a public accountant’s judgment or behaviour;</li> <li>(b) Self-review threat — the threat that a public accountant will not appropriately evaluate the results of a previous judgment made, or an activity performed by the public accountant, or by another individual within the public accountant’s firm, on which the public accountant will rely when forming a judgment as part of performing a current activity;</li> <li>(c) Advocacy threat — the threat that a public accountant will promote a client’s position to the point that the public accountant’s objectivity is compromised;</li> <li>(d) Familiarity threat — the threat that due to a long or close relationship with a client, a public accountant will be too sympathetic to their interests or too accepting of their work;</li> <li>(e) Intimidation threat — the threat that a public accountant will be deterred from acting objectively because of actual or perceived pressures, including attempts</li> </ul>



	to exercise undue influence over the public accountant.
120.6 A4	A circumstance might create more than one threat, and a threat might affect compliance with more than one fundamental principle.
<b>Evaluating Threats</b>	
<b>R120.7</b>	When the public accountant identifies a threat to compliance with the fundamental principles, the public accountant shall evaluate whether such a threat is at an acceptable level.
<i>Acceptable Level</i>	
120.7 A1	An acceptable level is a level at which a public accountant using the reasonable and informed third party test would likely conclude that the public accountant complies with the fundamental principles.
<i>Factors Relevant in Evaluating the Level of Threats</i>	
120.8 A1	The consideration of qualitative as well as quantitative factors is relevant in the public accountant's evaluation of threats, as is the combined effect of multiple threats, if applicable.
120.8 A2	<p>The existence of conditions, policies and procedures described in paragraph 120.6 A1 might also be factors that are relevant in evaluating the level of threats to compliance with the fundamental principles. Examples of such conditions, policies and procedures include —</p> <ul style="list-style-type: none"> <li>(a) Corporate governance requirements;</li> <li>(b) Educational, training and experience requirements for the profession;</li> <li>(c) Effective complaint systems which enable the public accountant and the general public to draw attention to unethical behaviour;</li> <li>(d) An explicitly stated duty to report breaches of ethics requirements; and</li> <li>(e) Professional or regulatory monitoring and disciplinary procedures.</li> </ul>

<i>Consideration of New Information or Changes in Facts and Circumstances</i>	
<b>R120.9</b>	If the public accountant becomes aware of new information or changes in facts and circumstances that might impact whether a threat has been eliminated or reduced to an acceptable level, the public accountant shall re-evaluate and address that threat accordingly.
120.9 A1	Remaining alert throughout the professional activity assists the public accountant in determining whether new information has emerged or changes in facts and circumstances have occurred that —  (a) Impact the level of a threat; or  (b) Affect the public accountant’s conclusions about whether safeguards applied continue to be appropriate to address identified threats.
120.9 A2	If new information results in the identification of a new threat, the public accountant is required to evaluate and, as appropriate, address this threat. (Ref: Paras. R120.7 and R120.10).
<b>Addressing Threats</b>	
<b>R120.10</b>	If the public accountant determines that the identified threats to compliance with the fundamental principles are not at an acceptable level, the public accountant shall address the threats by eliminating them or reducing them to an acceptable level. The public accountant shall do so by —  (a) Eliminating the circumstances, including interests or relationships, that are creating the threats;  (b) Applying safeguards, where available and capable of being applied, to reduce the threats to an acceptable level; or  (c) Declining or ending the specific professional activity.
<i>Actions to Eliminate Threats</i>	
120.10 A1	Depending on the facts and circumstances, a threat

	might be addressed by eliminating the circumstance creating the threat. However, there are some situations in which threats can only be addressed by declining or ending the specific professional activity. This is because the circumstances that created the threats cannot be eliminated and safeguards are not capable of being applied to reduce the threat to an acceptable level.
<i>Safeguards</i>	
120.10 A2	Safeguards are actions, individually or in combination, that the public accountant takes that effectively reduce threats to compliance with the fundamental principles to an acceptable level.
<i>Consideration of Significant Judgments Made and Overall Conclusions Reached</i>	
<b>R120.11</b>	<p>The public accountant shall form an overall conclusion about whether the actions that the public accountant takes, or intends to take, to address the threats created will eliminate those threats or reduce them to an acceptable level. In forming the overall conclusion, the public accountant shall —</p> <p>(a) Review any significant judgments made or conclusions reached; and</p> <p>(b) Use the reasonable and informed third party test.</p>
<b>Other Considerations when Applying the Conceptual Framework</b>	
<i>Bias</i>	
120.12 A1	Conscious or unconscious bias affects the exercise of professional judgment when identifying, evaluating and addressing threats to compliance with the fundamental principles.
120.12 A2	<p>Examples of potential bias to be aware of when exercising professional judgment include —</p> <p>(a) Anchoring bias, which is a tendency to use an initial piece of information as an anchor against which subsequent information is inadequately assessed;</p> <p>(b) Automation bias, which is a tendency to favour output generated from automated systems, even when human</p>

	<p>reasoning or contradictory information raises questions as to whether such output is reliable or fit for purpose;</p> <p>(c) Availability bias, which is a tendency to place more weight on events or experiences that immediately come to mind or are readily available than on those that are not;</p> <p>(d) Confirmation bias, which is a tendency to place more weight on information that corroborates an existing belief than information that contradicts or casts doubt on that belief;</p> <p>(e) Groupthink, which is a tendency for a group of individuals to discourage individual creativity and responsibility and as a result reach a decision without critical reasoning or consideration of alternatives;</p> <p>(f) Overconfidence bias, which is a tendency to overestimate one's own ability to make accurate assessments of risk or other judgments or decisions;</p> <p>(g) Representation bias, which is a tendency to base an understanding on a pattern of experiences, events or beliefs that is assumed to be representative; and</p> <p>(h) Selective perception, which is a tendency for a person's expectations to influence how the person views a particular matter or person.</p>
120.12 A3	<p>Actions that might mitigate the effect of bias include —</p> <p>(a) Seeking advice from experts to obtain additional input;</p> <p>(b) Consulting with others to ensure appropriate challenge as part of the evaluation process; and</p>

	(c) Receiving training related to the identification of bias as part of professional development.
<i>Organisational Culture</i>	
120.13 A1	The effective application of the conceptual framework by a public accountant is enhanced when the importance of ethical values that align with the fundamental principles and other provisions set out in the Code is promoted through the internal culture of the public accountant's organisation.
120.13 A2	<p>The promotion of an ethical culture within an organisation is most effective when —</p> <p>(a) Leaders and those in managerial roles promote the importance of, and hold themselves and others accountable for demonstrating, the ethical values of the organisation;</p> <p>(b) Appropriate education and training programs, management processes, and performance evaluation and reward criteria that promote an ethical culture are in place;</p> <p>(c) Effective policies and procedures are in place to encourage and protect those who report actual or suspected illegal or unethical behaviour, including whistle-blowers; and</p> <p>(d) The organisation adheres to ethical values in its dealings with third parties.</p>
120.13 A3	Public accountants are expected to —
	(a) Encourage and promote an ethics-based culture in their organisation, taking into

	account their position and seniority; and
	(b) Exhibit ethical behaviour in dealings with individuals with whom, and entities with which, the public accountants or the firm has a professional or business relationship.
<b>Considerations for Audits, Reviews, Other Assurance and Related Services Engagements</b>	
<i>Firm Culture</i>	
120.14 A1	Singapore Standard on Quality Management 1 (SSQM 1) sets out requirements and application material relating to firm culture in the context of a firm's responsibilities to design, implement and operate a system of quality management for audits or reviews of financial statements, or other assurance or related services engagements.
<i>Independence</i>	
120.15 A1	Public accountants are required by <i>Independence Standards</i> to be independent when performing audits, reviews, or other assurance engagements. Independence is linked to the fundamental principles of objectivity and integrity. It comprises —  (a) Independence of mind — the state of mind that permits the expression of a conclusion without being affected by influences that compromise professional judgment, thereby allowing an individual to act with integrity, and exercise objectivity and

	<p>professional scepticism;</p> <p>(b) Independence in appearance — the avoidance of facts and circumstances that are so significant that a reasonable and informed third party would be likely to conclude that a firm’s or an audit or assurance team member’s integrity, objectivity or professional scepticism has been compromised.</p>
120.15 A2	<p><i>Independence Standards</i> set out requirements and application material on how to apply the conceptual framework to maintain independence when performing audits, reviews or other assurance engagements. Public accountants and firms are required to comply with these standards in order to be independent when conducting such engagements. The conceptual framework to identify, evaluate and address threats to compliance with the fundamental principles applies in the same way to compliance with independence requirements. The categories of threats to compliance with the fundamental principles described in paragraph 120.6 A3 are also the categories of threats to compliance with independence requirements.</p>
120.15 A3	<p>Conditions, policies and procedures described in paragraphs 120.6 A1 and 120.8 A2 that might assist in identifying and evaluating threats to compliance with the fundamental principles might also be factors relevant to identifying and evaluating threats to independence. In the context of audits, reviews and other assurance engagements, a system of quality management designed, implemented and operated by a firm in accordance with the quality management standards issued by the Institute of Singapore Chartered Accountants is an example of such conditions, policies and procedures.</p>
<i>Professional Scepticism</i>	
120.16 A1	<p>Under auditing, review and other assurance standards, including those issued by the Institute of Singapore Chartered Accountants, public accountants are required to exercise professional scepticism when planning and performing audits, reviews and other assurance engagements.</p>

	Professional scepticism and the fundamental principles that are described in Section 110 are inter-related concepts.
120.16 A2	<p>In an audit of financial statements, compliance with the fundamental principles, individually and collectively, supports the exercise of professional scepticism, as shown in the following examples:</p> <p>(a) <i>Integrity</i> requires the public accountant to be straightforward and honest. For example, the public accountant complies with the principle of integrity by —</p> <ul style="list-style-type: none"> <li>(i) Being straightforward and honest when raising concerns about a position taken by a client;</li> <li>(ii) Pursuing inquiries about inconsistent information and seeking further audit evidence to address concerns about statements that might be materially false or misleading in order to make informed decisions about the appropriate course of action in the circumstances; and</li> <li>(iii) Having the strength of character to act appropriately, even when facing pressure to do otherwise or when doing so might create potential adverse personal or organisational consequences. Acting appropriately involves — <ul style="list-style-type: none"> <li>(A) Standing one’s ground when confronted by dilemmas and difficult situations; or</li> <li>(B) Challenging others as and when circumstances warrant,</li> </ul> <p>in a manner appropriate to the circumstances.</p> </li> </ul>



In doing so, the public accountant demonstrates the critical assessment of audit evidence that contributes to the exercise of professional scepticism;

(b) *Objectivity* requires the public accountant to exercise professional or business judgment without being compromised by —

- (i) Bias;
- (ii) Conflict of interest; or
- (iii) Undue influence of, or undue reliance on, individuals, organisations, technology or other factors.

For example, the public accountant complies with the principle of objectivity by —

- (i) Recognising circumstances or relationships such as familiarity with the client, that might compromise the public accountant's professional or business judgment; and
- (ii) Considering the impact of such circumstances and relationships on the public accountant's judgment when evaluating the sufficiency and appropriateness of audit evidence related to a matter material to the client's financial statements.

In doing so, the public accountant behaves in a manner that contributes to the exercise of professional scepticism;

(c) *Professional competence and due care* requires the public accountant to have professional knowledge and skill at the level required to ensure the provision of competent professional service, and

	<p>to act diligently in accordance with applicable standards, laws and regulations. For example, the public accountant complies with the principle of professional competence and due care by —</p> <ul style="list-style-type: none"> <li>(i) Applying knowledge that is relevant to a particular client’s industry and business activities in order to properly identify risks of material misstatement;</li> <li>(ii) Designing and performing appropriate audit procedures; and</li> <li>(iii) Applying relevant knowledge when critically assessing whether audit evidence is sufficient and appropriate in the circumstances.</li> </ul> <p>In doing so, the public accountant behaves in a manner that contributes to the exercise of professional scepticism.</p>

**SECTION 300**

**APPLYING THE CONCEPTUAL FRAMEWORK — PUBLIC ACCOUNTANTS**

**Introduction**

300.1	This Part of the Code sets out requirements and application material for public accountants when applying the conceptual framework set out in Section 120. It does not describe all of the facts and circumstances, including professional activities, interests and relationships, that could be encountered by public accountants, which create or might create threats to compliance with the fundamental principles. Therefore, the conceptual framework requires public accountants to be alert for such facts and circumstances.
300.2	<p>The requirements and application material that apply to public accountants are set out in —</p> <p>(a) Part 3 — <i>Public accountants</i>, Sections 300 to 399, which applies to all public accountants, whether they provide assurance services or not; and</p> <p>(b) <i>Independence Standards</i> as follows:</p> <p>(i) Part 4A — <i>Independence for Audit and Review Engagements</i>, Sections 400 to 899, which applies to public accountants when performing audit and review engagements; and</p> <p>(ii) Part 4B — <i>Independence for Assurance Engagements Other than Audit and Review Engagements</i>, Sections 900 to 999, which applies to public accountants when performing assurance engagements other than audit or review engagements.</p>
300.3	In this Part, the term “public accountant” refers to individual public accountants and their firms.
<b>Requirements and Application Material</b>	
<b>General</b>	
<b>R300.4</b>	A public accountant shall comply with the fundamental principles set out in Section 110 and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to compliance with the fundamental

	principles.
<b>R300.5</b>	When dealing with an ethics issue, the public accountant shall consider the context in which the issue has arisen or might arise.
<b>[Paragraph 300.5 A1 is intentionally left blank]</b>	
300.5 A2	<p>The more senior the position of a public accountant, the greater will be the ability and opportunity to access information, and to influence policies, decisions made and actions taken by others involved with the firm. To the extent that they are able to do so, taking into account their position and seniority in the firm, public accountants are expected to encourage and promote an ethics-based culture in the firm and exhibit ethical behaviour in dealings with individuals with whom, and entities with which, the public accountant or the firm has a professional or business relationship in accordance with paragraph 120.13 A3. Examples of actions that might be taken include the introduction, implementation and oversight of—</p> <p>(a) Ethics education and training programs;</p>

	(b) Firm processes and performance evaluation and reward criteria that promote an ethical culture;
	(c) Ethics and whistle-blowing policies; and
	(d) Policies and procedures designed to prevent non-compliance with laws and regulations.

**Identifying Threats**

300.6 A1

Threats to compliance with the fundamental principles might be created by a broad range of facts and circumstances. The categories of threats are described in paragraph 120.6 A3. The following are examples of facts and circumstances within each of those categories of threats that might create threats for a public accountant when undertaking a professional service:

(a) Self-interest Threats —

- (i) A public accountant having a direct financial interest in a client;
- (ii) A public accountant quoting a low fee to obtain a new engagement and the fee is so low that it might be difficult to perform the professional service in accordance with applicable technical and professional standards for that price;
- (iii) A public accountant having a close business relationship with a client;
- (iv) A public accountant having access

to confidential information that might be used for personal gain; and

- (v) A public accountant discovering a significant error when evaluating the results of a previous professional service performed by a member of the public accountant's firm;

(b) Self-review Threats —

- (i) A public accountant issuing an assurance report on the effectiveness of the operation of financial systems after implementing the systems; and
- (ii) A public accountant having prepared the original data used to generate records that are the subject matter of the assurance engagement;

(c) Advocacy Threats —

- (i) A public accountant promoting the interests of, or shares in, a client;
- (ii) A public accountant acting as an advocate on behalf of a client in litigation or disputes with third parties; and
- (iii) A public accountant lobbying in favour of legislation on behalf of a client;

(d) Familiarity Threats —

- (i) A public accountant having a close or immediate family member who is a director or officer of the client;
- (ii) A director or officer of the client, or an employee in a position to

	<p>exert significant influence over the subject matter of the engagement, having recently served as the engagement partner;</p> <p>(iii) An audit team member having a long association with the audit client; and</p> <p>(iv) An individual who is being considered to serve as an appropriate reviewer as a safeguard to address a threat, having a close relationship with the individual who performed the work;</p> <p>(e) Intimidation Threats —</p> <p>(i) A public accountant being threatened with dismissal from a client engagement or the firm because of a disagreement about a professional matter;</p> <p>(ii) A public accountant feeling pressured to agree with the judgment of a client because the client has more expertise on the matter in question;</p> <p>(iii) A public accountant being informed that a planned promotion will not occur unless the public accountant agrees with an inappropriate accounting treatment; and</p> <p>(iv) A public accountant having accepted a significant gift from a client and being threatened that acceptance of this gift will be made public.</p>

*Identifying Threats Associated with the Use of Technology*

300.6 A2	The following are examples of facts and circumstances relating to the use of technology that might create threats for a public accountant when undertaking a professional activity:
	(a) Self-interest Threats —
	(i) The data available might not be sufficient for the effective use of the technology;
	(ii) The technology might not be appropriate for the purpose for which it is to be used; and
	(iii) The public accountant might not have sufficient information and expertise, or access to an expert with sufficient understanding, to use and explain the technology and its appropriateness for the purpose



		intended.
		(b) Self-review Threats — The technology was designed or developed using the knowledge, expertise or judgment of the public accountant or the firm.
<b>Evaluating Threats</b>		
300.7 A1	<p>The conditions, policies and procedures described in paragraphs 120.6 A1 and 120.8 A2 might impact the evaluation of whether a threat to compliance with the fundamental principles is at an acceptable level. Such conditions, policies and procedures might relate to —</p> <p>(a) The client and its operating environment; and</p> <p>(b) The firm and its operating environment.</p>	
300.7 A2	<p>The public accountant’s evaluation of the level of a threat is also impacted by the nature and scope of the professional service.</p>	
<i>The Client and its Operating Environment</i>		
300.7 A3	<p>The public accountant’s evaluation of the level of a threat might be impacted by whether the client is —</p> <p>(a) An audit client and whether the audit client is a public interest entity;</p> <p>(b) An assurance client that is not an audit client; or</p> <p>(c) A non-assurance client.</p> <p>For example, providing a non-assurance service to an audit client that is a public interest entity might be perceived to result in a higher level of threat to</p>	

	compliance with the principle of objectivity with respect to the audit.
300.7 A4	<p>The corporate governance structure, including the leadership of a client might promote compliance with the fundamental principles. Accordingly, a public accountant's evaluation of the level of a threat might also be impacted by a client's operating environment. For example —</p> <ul style="list-style-type: none"> <li>(a) The client requires appropriate individuals other than management to ratify or approve the appointment of a firm to perform an engagement;</li> <li>(b) The client has competent employees with experience and seniority to make managerial decisions;</li> <li>(c) The client has implemented internal procedures that facilitate objective choices in tendering non-assurance engagements; and</li> <li>(d) The client has a corporate governance structure that provides appropriate oversight and communications regarding the firm's services.</li> </ul>
<i>The Firm and its Operating Environment</i>	
300.7 A5	<p>A public accountant's evaluation of the level of a threat might be impacted by the work environment within the public accountant's firm and its operating environment. For example —</p> <ul style="list-style-type: none"> <li>(a) Leadership of the firm that promotes compliance with the fundamental principles and establishes the expectation that assurance team members will act in the public interest;</li> <li>(b) Policies or procedures for establishing and monitoring compliance with the fundamental principles by all personnel;</li> <li>(c) Compensation, performance appraisal and disciplinary policies and</li> </ul>

	<p>procedures that promote compliance with the fundamental principles;</p> <p>(d) Management of the reliance on revenue received from a single client;</p> <p>(e) The engagement partner having authority within the firm for decisions concerning compliance with the fundamental principles, including any decisions about accepting or providing services to a client;</p> <p>(f) Educational, training and experience requirements; and</p> <p>(g) Processes to facilitate and address internal and external concerns or complaints.</p>
300.7 A6	<p>The public accountant's evaluation of the level of a threat associated with the use of technology might also be impacted by the work environment within the public accountant's firm and its operating environment. For example —</p>
	<p>(a) Level of corporate oversight and internal controls over the technology;</p>
	<p>(b) Assessments of the quality and functionality of technology that are undertaken by a third-party; and</p>
	<p>(c) Training that is provided</p>

	<p>regularly to all relevant employees so they obtain and maintain the professional competence to sufficiently understand, use and explain the technology and its appropriateness for the purpose intended.</p>
<p><i>Consideration of New Information or Changes in Facts and Circumstances</i></p>	
<p>300.7 A7</p>	<p>New information or changes in facts and circumstances might —</p> <ul style="list-style-type: none"> <li>(a) Impact the level of a threat; or</li> <li>(b) Affect the public accountant’s conclusions about whether safeguards applied continue to address identified threats as intended.</li> </ul> <p>In these situations, actions that were already implemented as safeguards might no longer be effective in addressing threats. Accordingly, the application of the conceptual framework requires that the public accountant re-evaluate and address the threats accordingly. (Ref: Paras. R120.9 and R120.10).</p>
<p>300.7 A8</p>	<p>Examples of new information or changes in facts and circumstances that might impact the level of a threat include —</p> <ul style="list-style-type: none"> <li>(a) When the scope of a professional service is expanded;</li> <li>(b) When the client becomes a publicly traded entity or acquires another business unit;</li> <li>(c) When the firm merges with another firm;</li> </ul>

	<p>(d) When the public accountant is jointly engaged by two clients and a dispute emerges between the two clients; and</p> <p>(e) When there is a change in the public accountant's personal or immediate family relationships.</p>
<b>Addressing Threats</b>	
300.8 A1	Paragraphs R120.10 to 120.10 A2 set out requirements and application material for addressing threats that are not at an acceptable level.
<i>Examples of Safeguards</i>	
300.8 A2	<p>Safeguards vary depending on the facts and circumstances. Examples of actions that in certain circumstances might be safeguards to address threats include —</p> <p>(a) Assigning additional time and qualified personnel to required tasks when an engagement has been accepted might address a self-interest threat;</p> <p>(b) Having an appropriate reviewer who was not a member of the team review the work performed or advise as necessary might address a self-review threat;</p> <p>(c) Using different partners and teams with separate reporting lines for the provision of non-assurance services to an assurance client might address self-review, advocacy or familiarity threats;</p> <p>(d) Involving another firm to perform or re-perform part of the engagement might address self-interest, self-review, advocacy, familiarity or intimidation threats;</p> <p>(e) Disclosing to clients any referral fees or commission arrangements received for recommending services or products</p>

	<p>might address a self-interest threat; and</p> <p>(f) Separating teams when dealing with matters of a confidential nature might address a self-interest threat.</p>
300.8 A3	The remaining sections of Part 3 and <i>Independence Standards</i> describe certain threats that might arise during the course of performing professional services and include examples of actions that might address threats.
Appropriate Reviewer	
300.8 A4	An appropriate reviewer is a professional with the necessary knowledge, skills, experience and authority to review, in an objective manner, the relevant work performed or service provided. Such an individual might be a professional accountant.
<b>Communicating with Those Charged with Governance</b>	
<b>R300.9</b>	When communicating with those charged with governance in accordance with the Code, a public accountant shall determine the appropriate individual(s) within the entity's governance structure with whom to communicate. If the public accountant communicates with a subgroup of those charged with governance, the public accountant shall determine whether communication with all of those charged with governance is also necessary so that they are adequately informed.
300.9 A1	<p>In determining with whom to communicate, a public accountant might consider —</p> <p>(a) The nature and importance of the circumstances; and</p> <p>(b) The matter to be communicated.</p>
300.9 A2	Examples of a subgroup of those charged with governance include an audit committee or an individual member of those charged with governance.
<b>R300.10</b>	If a public accountant communicates with individuals who have management responsibilities as well as governance responsibilities, the public accountant shall be satisfied that communication with those individuals adequately informs all of

	those in a governance role with whom the public accountant would otherwise communicate.
300.10 A1	In some circumstances, all of those charged with governance are involved in managing the entity, for example, a small business where a single owner manages the entity and no one else has a governance role. In these cases, if matters are communicated to individual(s) with management responsibilities, and those individual(s) also have governance responsibilities, the public accountant has satisfied the requirement to communicate with those charged with governance.
<b>SECTION 310</b>	
<b>CONFLICTS OF INTEREST</b>	
<b>Introduction</b>	
310.1	Public accountants are required to comply with the fundamental principles and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats.
310.2	<p>A conflict of interest creates threats to compliance with the principle of objectivity and might create threats to compliance with the other fundamental principles. Such threats might be created when —</p> <p>(a) A public accountant provides a professional service related to a particular matter for two or more clients whose interests with respect to that matter are in conflict; or</p> <p>(b) The interests of a public accountant with respect to a particular matter and the interests of the client for whom the public accountant provides a professional service related to that matter are in conflict.</p>
310.3	This section sets out specific requirements and application material relevant to applying the conceptual framework to conflicts of interest. When a public accountant provides an audit, review or other assurance service, independence is also required in accordance with <i>Independence Standards</i> .
<b>Requirements and Application Material</b>	

<b>General</b>	
<b>R310.4</b>	A public accountant shall not allow a conflict of interest to compromise professional or business judgment.
310.4 A1	<p>Examples of circumstances that might create a conflict of interest include —</p> <ul style="list-style-type: none"> <li data-bbox="818 495 1427 695">(a) Providing a transaction advisory service to a client seeking to acquire an audit client, where the firm has obtained confidential information during the course of the audit that might be relevant to the transaction;</li> <li data-bbox="818 730 1427 930">(b) Providing advice to two clients at the same time where the clients are competing to acquire the same company and the advice might be relevant to the parties' competitive positions;</li> <li data-bbox="818 966 1427 1060">(c) Providing services to a seller and a buyer in relation to the same transaction;</li> <li data-bbox="818 1096 1427 1190">(d) Preparing valuations of assets for two parties who are in an adversarial position with respect to the assets;</li> <li data-bbox="818 1226 1427 1402">(e) Representing two clients in the same matter who are in a legal dispute with each other, such as during divorce proceedings, or the dissolution of a partnership;</li> <li data-bbox="818 1438 1427 1614">(f) In relation to a license agreement, providing an assurance report for a licensor on the royalties due while advising the licensee on the amounts payable;</li> <li data-bbox="818 1650 1427 1780">(g) Advising a client to invest in a business in which, for example, the spouse of the public accountant has a financial interest;</li> <li data-bbox="818 1816 1427 1860">(h) Providing strategic advice to a client on</li> </ul>



	<p>its competitive position while having a joint venture or similar interest with a major competitor of the client;</p> <p>(i) Advising a client on acquiring a business which the firm is also interested in acquiring; and</p> <p>(j) Advising a client on buying a product or service while having a royalty or commission agreement with a potential seller of that product or service.</p>
<b>Conflict Identification</b>	
<i>General</i>	
<b>R310.5</b>	<p>Before accepting a new client relationship, engagement, or business relationship, a public accountant shall take reasonable steps to identify circumstances that might create a conflict of interest, and therefore a threat to compliance with one or more of the fundamental principles. Such steps shall include identifying —</p> <p>(a) The nature of the relevant interests and relationships between the parties involved; and</p> <p>(b) The service and its implication for relevant parties.</p>
310.5 A1	<p>An effective conflict identification process assists a public accountant when taking reasonable steps to identify interests and relationships that might create an actual or potential conflict of interest, both before determining whether to accept an engagement and throughout the engagement. Such a process includes considering matters identified by external parties, for example clients or potential clients. The earlier an actual or potential conflict of interest is identified, the greater the likelihood of the public accountant being able to address threats created by the conflict of interest.</p>
310.5 A2	<p>An effective process to identify actual or potential conflicts of interest will take into account factors such as —</p> <p>(a) The nature of the professional services</p>

	<p>provided;</p> <p>(b) The size of the firm;</p> <p>(c) The size and nature of the client base; and</p> <p>(d) The structure of the firm, for example, the number and geographic location of offices.</p>
310.5 A3	More information on client acceptance is set out in Section 320, <i>Professional Appointments</i> .
<i>Changes in Circumstances</i>	
<b>R310.6</b>	A public accountant shall remain alert to changes over time in the nature of services, interests and relationships that might create a conflict of interest while performing an engagement.
310.6 A1	The nature of services, interests and relationships might change during the engagement. This is particularly true when a public accountant is asked to conduct an engagement in a situation that might become adversarial, even though the parties who engage the public accountant initially might not be involved in a dispute.
<i>Network Firms</i>	
<b>R310.7</b>	If the firm is a member of a network, a public accountant shall consider conflicts of interest that the public accountant has reason to believe might exist or arise due to interests and relationships of a network firm.
310.7 A1	<p>Factors to consider when identifying interests and relationships involving a network firm include —</p> <p>(a) The nature of the professional services provided;</p> <p>(b) The clients served by the network; and</p> <p>(c) The geographic locations of all relevant parties.</p>
<b>Threats Created by Conflicts of Interest</b>	
310.8 A1	In general, the more direct the connection between the professional service and the matter on which

	the parties' interests conflict, the more likely the level of the threat is not at an acceptable level.
310.8 A2	<p>Factors that are relevant in evaluating the level of a threat created by a conflict of interest include measures that prevent unauthorised disclosure of confidential information when performing professional services related to a particular matter for two or more clients whose interests with respect to that matter are in conflict. These measures include —</p> <ul style="list-style-type: none"> <li>(a) The existence of separate practice areas for specialty functions within the firm, which might act as a barrier to the passing of confidential client information between practice areas;</li> <li>(b) Policies and procedures to limit access to client files;</li> <li>(c) Confidentiality agreements signed by personnel and partners of the firm;</li> <li>(d) Separation of confidential information physically and electronically; and</li> <li>(e) Specific and dedicated training and communication.</li> </ul>
310.8 A3	<p>Examples of actions that might be safeguards to address threats created by a conflict of interest include —</p> <ul style="list-style-type: none"> <li>(a) Having separate teams who are provided with clear policies and procedures on maintaining confidentiality; and</li> <li>(b) Having an appropriate reviewer, who is not involved in providing the service or otherwise affected by the conflict, review the work performed to assess whether the key judgments and conclusions are appropriate.</li> </ul>
<b>Disclosure and Consent</b>	
<i>General</i>	

<p><b>R310.9</b></p>	<p>A public accountant shall exercise professional judgment to determine whether the nature and significance of a conflict of interest are such that specific disclosure and explicit consent are necessary when addressing the threat created by the conflict of interest.</p>
<p>310.9 A1</p>	<p>Factors to consider when determining whether specific disclosure and explicit consent are necessary include —</p> <ul style="list-style-type: none"> <li>(a) The circumstances creating the conflict of interest;</li> <li>(b) The parties that might be affected;</li> <li>(c) The nature of the issues that might arise; and</li> <li>(d) The potential for the particular matter to develop in an unexpected manner.</li> </ul>
<p>310.9 A2</p>	<p>Disclosure and consent might take different forms, for example —</p> <ul style="list-style-type: none"> <li>(a) General disclosure to clients of circumstances where, as is common commercial practice, the public accountant does not provide professional services exclusively to any one client (for example, in a particular professional service and market sector). This enables the client to provide general consent accordingly. For example, a public accountant might make general disclosure in the standard terms and conditions for the engagement;</li> <li>(b) Specific disclosure to affected clients of the circumstances of the particular conflict in sufficient detail to enable the client to make an informed decision about the matter and to provide explicit consent accordingly. Such disclosure might include a detailed presentation of the circumstances and a comprehensive explanation of any planned safeguards and the risks involved; and</li> </ul>

	<p>(c) Consent might be implied by clients' conduct in circumstances where the public accountant has sufficient evidence to conclude that clients know the circumstances at the outset and have accepted the conflict of interest if they do not raise an objection to the existence of the conflict.</p>
310.9 A3	<p>It is generally necessary —</p> <p>(a) To disclose the nature of the conflict of interest and how any threats created were addressed to clients affected by a conflict of interest; and</p> <p>(b) To obtain consent of the affected clients to perform the professional services when safeguards are applied to address the threat.</p>
310.9 A4	<p>If such disclosure or consent is not in writing, the public accountant is encouraged to document —</p> <p>(a) The nature of the circumstances giving rise to the conflict of interest;</p> <p>(b) The safeguards applied to address the threats when applicable; and</p> <p>(c) The consent obtained.</p>
<i>When Explicit Consent is Refused</i>	
<b>R310.10</b>	<p>If a public accountant has determined that explicit consent is necessary in accordance with paragraph R310.9 and the client has refused to provide consent, the public accountant shall either —</p> <p>(a) End or decline to perform professional services that would result in the conflict of interest; or</p> <p>(b) End relevant relationships or dispose of relevant interests to eliminate the threat or reduce it to an acceptable level.</p>
<b>Confidentiality</b>	

<i>General</i>	
<b>R310.11</b>	A public accountant shall remain alert to the principle of confidentiality, including when making disclosures or sharing information within the firm or network and seeking guidance from third parties.
310.11 A1	Subsection 114 sets out requirements and application material relevant to situations that might create a threat to compliance with the principle of confidentiality.
<i>When Disclosure to Obtain Consent would Breach Confidentiality</i>	
<b>R310.12</b>	<p>When making specific disclosure for the purpose of obtaining explicit consent would result in a breach of confidentiality, and such consent cannot therefore be obtained, the firm shall only accept or continue an engagement if —</p> <ul style="list-style-type: none"> <li>(a) The firm does not act in an advocacy role for one client in an adversarial position against another client in the same matter;</li> <li>(b) Specific measures are in place to prevent disclosure of confidential information between the teams serving the two clients; and</li> <li>(c) The firm is satisfied that a reasonable and informed third party would be likely to conclude that it is appropriate for the firm to accept or continue the engagement because a restriction on the firm's ability to provide the professional service would produce a disproportionate adverse outcome for the clients or other relevant third parties.</li> </ul>
310.12 A1	<p>A breach of confidentiality might arise, for example, when seeking consent to perform —</p> <ul style="list-style-type: none"> <li>(a) A transaction-related service for a client in a hostile takeover of another client of the firm;</li> <li>(b) A forensic investigation for a client</li> </ul>

	regarding a suspected fraud, where the firm has confidential information from its work for another client who might be involved in the fraud.
<b>Documentation</b>	
<b>R310.13</b>	<p>In the circumstances set out in paragraph R310.12, the public accountant shall document —</p> <p>(a) The nature of the circumstances, including the role that the public accountant is to undertake;</p> <p>(b) The specific measures in place to prevent disclosure of information between the teams serving the two clients; and</p> <p>(c) Why it is appropriate to accept or continue the engagement.</p>
<b>SECTION 320</b>	
<b>PROFESSIONAL APPOINTMENTS</b>	
<b>Introduction</b>	
320.1	Public accountants are required to comply with the fundamental principles and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats.
320.2	Acceptance of a new client relationship or changes in an existing engagement might create a threat to compliance with one or more of the fundamental principles. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirements and Application Material</b>	
<b>Client and Engagement Acceptance</b>	
<i>General</i>	
320.3 A1	Threats to compliance with the principles of integrity or professional behaviour might be created, for example, from questionable issues associated with the client (its owners, management or activities). Issues that, if known, might create such a threat include client involvement in illegal

	activities, dishonesty, questionable financial reporting practices or other unethical behaviour.
320.3 A2	<p>Factors that are relevant in evaluating the level of such a threat include —</p> <p>(a) Knowledge and understanding of the client, its owners, management and those charged with governance and business activities; and</p> <p>(b) The client’s commitment to address the questionable issues, for example, through improving corporate governance practices or internal controls.</p>
320.3 A3	A self-interest threat to compliance with the principle of professional competence and due care is created if the team does not possess, or cannot acquire, the competencies to perform the professional services.
320.3 A4	<p>Factors that are relevant in evaluating the level of such a threat include —</p> <p>(a) An appropriate understanding of —</p> <p>(i) The nature of the client’s business;</p> <p>(ii) The complexity of its operations;</p> <p>(iii) The requirements of the engagement; and</p> <p>(iv) The purpose, nature and scope of the work to be performed;</p> <p>(b) Knowledge of relevant industries or subject matter;</p> <p>(c) Experience with relevant regulatory or reporting requirements;</p> <p>(d) Policies and procedures that the firm has implemented, as part of a system of quality management in accordance with quality management standards such as SSQM 1, that respond to</p>



	<p>quality risks relating to the firm's ability to perform the engagement in accordance with professional standards and applicable legal and regulatory requirements; and</p> <p>(e) The level of fees and the extent to which they have regard to the resources required, taking into account the public accountant's commercial and market priorities.</p>
320.3 A5	<p>Examples of actions that might be safeguards to address a self-interest threat include —</p> <p>(a) Assigning sufficient engagement personnel with the necessary competencies;</p> <p>(b) Agreeing on a realistic time frame for the performance of the engagement; and</p> <p>(c) Using experts where necessary.</p>
<b>Changes in a Professional Appointment</b>	
<i>General</i>	
<b>R320.4</b>	<p>A public accountant shall determine whether there are any reasons for not accepting an engagement when the public accountant —</p> <p>(a) Is asked by a potential client to replace another public accountant;</p> <p>(b) Considers tendering for an engagement held by another public accountant; or</p> <p>(c) Considers undertaking work that is complementary or additional to that of another public accountant.</p>
320.4 A1	<p>There might be reasons for not accepting an engagement. One such reason might be if a threat created by the facts and circumstances cannot be addressed by applying safeguards. For example, there might be a self-interest threat to compliance with the principle of professional competence and due care if a public accountant accepts the</p>

	engagement before knowing all the relevant facts.
320.4 A2	If a public accountant is asked to undertake work that is complementary or additional to the work of an existing or predecessor accountant, a self-interest threat to compliance with the principle of professional competence and due care might be created, for example, as a result of incomplete information.
320.4 A3	A factor that is relevant in evaluating the level of such a threat is whether tenders state that, before accepting the engagement, contact with the existing or predecessor accountant will be requested. This contact gives the proposed public accountant the opportunity to inquire whether there are any reasons why the engagement should not be accepted.
320.4 A4	<p>Examples of actions that might be safeguards to address such a self-interest threat include —</p> <p>(a) Asking the existing or predecessor accountant to provide any known information of which, in the existing or predecessor accountant’s opinion, the proposed public accountant needs to be aware before deciding whether to accept the engagement. For example, inquiry might reveal previously undisclosed pertinent facts and might indicate disagreements with the existing or predecessor accountant that might influence the decision to accept the appointment; and</p> <p>(b) Obtaining information from other sources such as through inquiries of third parties or background investigations regarding senior management or those charged with governance of the client.</p>
<i>Communicating with the Existing or Predecessor Accountant</i>	
320.5 A1	A proposed public accountant will usually need the client’s permission, preferably in writing, to initiate discussions with the existing or predecessor accountant.
<b>R320.6</b>	If unable to communicate with the existing or

	predecessor accountant, the proposed public accountant shall take other reasonable steps to obtain information about any possible threats.
<i>Communicating with the Proposed Public Accountant</i>	
<b>R320.7</b>	<p>When an existing or predecessor accountant is asked to respond to a communication from a proposed public accountant, the existing or predecessor accountant shall —</p> <p>(a) Comply with relevant laws and regulations governing the request; and</p> <p>(b) Provide any information honestly and unambiguously.</p>
320.7 A1	<p>An existing or predecessor accountant is bound by confidentiality. Whether the existing or predecessor accountant is permitted or required to discuss the affairs of a client with a proposed public accountant will depend on the nature of the engagement and —</p> <p>(a) Whether the existing or predecessor accountant has permission from the client for the discussion; and</p> <p>(b) The legal and ethics requirements relating to such communications and disclosure, which might vary by jurisdiction.</p>
320.7 A2	<p>Circumstances where a public accountant is or might be required to disclose confidential information, or when disclosure might be appropriate, are set out in paragraph 114.3 A1 of the Code.</p>
<i>Changes in Audit or Review Appointments</i>	
<b>R320.8</b>	<p>In the case of an audit or review of financial statements, a public accountant shall request the existing or predecessor accountant to provide known information regarding any facts or other information of which, in the existing or predecessor accountant's opinion, the proposed public accountant needs to be aware before deciding whether to accept the engagement. Except for the circumstances involving non-compliance or suspected non-compliance with laws and</p>

	<p>regulations set out in paragraphs R360.21 and R360.22 —</p> <p>(a) If the client consents to the existing or predecessor accountant disclosing any such facts or other information, the existing or predecessor accountant shall provide the information honestly and unambiguously; and</p> <p>(b) If the client fails or refuses to grant the existing or predecessor accountant permission to discuss the client's affairs with the proposed public accountant, the existing or predecessor accountant shall disclose this fact to the proposed public accountant, who shall carefully consider such failure or refusal when determining whether to accept the appointment.</p>
<b>SG320.8A</b>	The existing or predecessor accountant shall, on receipt of any request referred to in paragraph R320.8, reply to the proposed public accountant in writing within a reasonable time.
<b>SG320.8B</b>	If the proposed public accountant does not receive a reply from the existing or predecessor accountant to his or her request within a reasonable time and the proposed public accountant has no reason to believe that there are any exceptional circumstances surrounding the proposed change, the proposed public accountant shall use such other reasonable means to communicate with the existing or predecessor accountant.
<b>SG320.8C</b>	If the proposed public accountant is unable to obtain a satisfactory outcome pursuant to paragraph SG320.8B, the proposed public accountant shall send a final letter by registered post to the existing or predecessor accountant, stating that he or she assumes there is no professional or other reason why he or she should not accept the appointment and that he or she intends to do so. The proposed public accountant may accept the engagement if he or she is satisfied that there are no professional or other reasons for the proposed change after taking into account guidance set out in paragraphs R320.4 to R320.8.

<b>Client and Engagement Continuance</b>	
<b>R320.9</b>	For a recurring client engagement, a public accountant shall periodically review whether to continue with the engagement.
320.9 A1	Potential threats to compliance with the fundamental principles might be created after acceptance which, had they been known earlier, would have caused the public accountant to decline the engagement. For example, a self-interest threat to compliance with the principle of integrity might be created by improper earnings management or balance sheet valuations.
<b>Using the Work of an Expert</b>	
<b>R320.10</b>	When a public accountant intends to use the work of an expert in the course of undertaking a professional activity, the public accountant shall determine whether the use is appropriate for the intended purpose.
320.10 A1	Factors to consider when a public accountant intends to use the work of an expert include —
	(a) The reputation and expertise of, and the resources available to, the expert; and
	(b) Whether the expert is subject to applicable professional and ethics standards.
	Such information might be gained from prior association with, or

	from consulting others about, the expert.
<b>Using the Output of Technology</b>	
<b>R320.11</b>	When a public accountant intends to use the output of technology in the course of undertaking a professional activity, the public accountant shall determine whether the use is appropriate for the intended purpose.
320.11 A1	Factors to consider when a public accountant intends to use the output of technology include —  (a) The nature of the activity to be performed by the technology;  (b) The expected use of, or extent of reliance on, the output of the technology;
	(c) Whether the public accountant has the ability, or access to an expert with the ability, to understand, use and explain the technology and its appropriateness for the purpose intended;
	(d) Whether the technology used

	has been appropriately tested and evaluated for the purpose intended;
	(e) Prior experience with the technology and whether its use for specific purposes is generally accepted;
	(f) The firm's oversight of the design, development, implementation, operation, maintenance, monitoring, updating or upgrading of the technology;
	(g) The controls relating to the use of the technology, including procedures for authorising user access to the technology and overseeing such use; and
	(h) The appropriateness of the inputs to the technology, including data and any related decisions, and

	decisions made by individuals in the course of using the technology.
<b>Other Considerations</b>	
320.12 A1	When a public accountant is considering using the work of experts or the output of technology, a consideration is whether the public accountant is in a position within the firm to obtain information in relation to the factors necessary to determine whether such use is appropriate.
<b>SECTION 321</b>	
<b>SECOND OPINIONS</b>	
<b>Introduction</b>	
321.1	Public accountants are required to comply with the fundamental principles and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats.
321.2	Providing a second opinion to an entity that is not an existing client might create a self-interest or other threat to compliance with one or more of the fundamental principles. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirements and Application Material</b>	
<b>General</b>	
321.3 A1	A public accountant might be asked to provide a second opinion on the application of accounting, auditing, reporting or other standards or principles to (a) specific circumstances, or (b) transactions by or on behalf of a company or an entity that is not an existing client. A threat, for example, a self-interest threat to compliance with the principle of professional competence and due care, might be



	created if the second opinion is not based on the same facts that the existing or predecessor accountant had, or is based on inadequate evidence.
321.3 A2	A factor that is relevant in evaluating the level of such a self-interest threat is the circumstances of the request and all the other available facts and assumptions relevant to the expression of a professional judgment.
321.3 A3	Examples of actions that might be safeguards to address such a self-interest threat include — <ul style="list-style-type: none"> <li>(a) With the client’s permission, obtaining information from the existing or predecessor accountant;</li> <li>(b) Describing the limitations surrounding any opinion in communications with the client; and</li> <li>(c) Providing the existing or predecessor accountant with a copy of the opinion.</li> </ul>
<i>When Permission to Communicate is Not Provided</i>	
<b>R321.4</b>	If an entity seeking a second opinion from a public accountant will not permit the public accountant to communicate with the existing or predecessor accountant, the public accountant shall determine whether the public accountant may provide the second opinion sought.
<b>SECTION 325</b>	
<b>OBJECTIVITY OF AN ENGAGEMENT QUALITY REVIEWER AND OTHER APPROPRIATE REVIEWERS</b>	
<b>Introduction</b>	
325.1	Public accountants are required to comply with the fundamental principles and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats.
325.2	Appointing an engagement quality reviewer who has involvement in the work being reviewed or close relationships with those responsible for performing that work might create threats to compliance with the principle of objectivity.
325.3	This section sets out specific application material

	relevant to applying the conceptual framework in relation to the objectivity of an engagement quality reviewer.
325.4	An engagement quality reviewer is also an example of an appropriate reviewer as described in paragraph 300.8 A4. Therefore, the application material in this section might apply in circumstances where a public accountant appoints an appropriate reviewer to review work performed as a safeguard to address identified threats.
<b>Application Material</b>	
<b>General</b>	
325.5 A1	Quality engagements are achieved through planning and performing engagements and reporting on them in accordance with professional standards and applicable legal and regulatory requirements. SSQM 1 establishes the firm's responsibilities for its system of quality management and requires the firm to design and implement responses to address quality risks related to engagement performance. Such responses include establishing policies or procedures addressing engagement quality reviews in accordance with Singapore Standard on Quality Management 2 (SSQM 2).
325.5 A2	An engagement quality reviewer is a partner, other individual in the firm, or an external individual, appointed by the firm to perform the engagement quality review.
<b>Identifying Threats</b>	
325.6 A1	<p>The following are examples of circumstances where threats to the objectivity of a professional accountant appointed as an engagement quality reviewer might be created:</p> <p>(a) Self-interest threat — Two engagement partners each serving as an engagement quality reviewer for the other's engagement;</p> <p>(b) Self-review threat — A professional accountant serving as an engagement quality reviewer on an audit engagement after previously serving as the engagement partner;</p>

	<p>(c) Familiarity threat — A professional accountant serving as an engagement quality reviewer has a close relationship with or is an immediate family member of another individual who is involved in the engagement; and</p> <p>(d) Intimidation threat — A professional accountant serving as an engagement quality reviewer for an engagement has a direct reporting line to the partner responsible for the engagement.</p>
<b>Evaluating Threats</b>	
325.7 A1	<p>Factors that are relevant in evaluating the level of threats to the objectivity of an individual appointed as an engagement quality reviewer include —</p> <p>(a) The role and seniority of the individual;</p> <p>(b) The nature of the individual's relationship with others involved on the engagement;</p> <p>(c) The length of time the individual was previously involved with the engagement and the individual's role;</p> <p>(d) When the individual was last involved in the engagement prior to being appointed as engagement quality reviewer and any subsequent relevant changes to the circumstances of the engagement; and</p> <p>(e) The nature and complexity of issues that required significant judgment from the individual in any previous involvement in the engagement.</p>
<b>Addressing Threats</b>	
325.8 A1	An example of an action that might eliminate an intimidation threat is reassigning reporting responsibilities within the firm.
325.8 A2	An example of an action that might be a safeguard

	to address a self-review threat is implementing a period of sufficient duration (a cooling-off period) before the individual who was on the engagement is appointed as an engagement quality reviewer.
<i>Cooling-off Period</i>	
325.8 A3	SSQM 2 requires the firm to establish policies or procedures that specify, as a condition for eligibility, a cooling-off period of two years before the engagement partner can assume the role of engagement quality reviewer. This serves to enable compliance with the principle of objectivity and the consistent performance of quality engagements.
325.8 A4	The cooling-off period required by SSQM 2 is distinct from, and does not modify, the partner rotation requirements in Section 540, which are designed to address threats to independence created by long association with an audit client.
<b>SECTION 330</b>	
<b>FEES AND OTHER TYPES OF REMUNERATION</b>	
<b>Introduction</b>	
330.1	Public accountants are required to comply with the fundamental principles and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats.
330.2	The level and nature of fee and other remuneration arrangements might create a self-interest threat to compliance with one or more of the fundamental principles. This section sets out specific application material relevant to applying the conceptual framework in such circumstances.
<b>Application Material</b>	
<b>Level of Fees</b>	
330.3 A1	The level of fees might impact a public accountant's ability to perform professional services in accordance with technical and professional standards.
330.3 A2	A public accountant might quote whatever fee is considered appropriate. Quoting a fee lower than another public accountant is not in itself unethical. However, the level of fees quoted creates a self-interest threat to compliance with the principle of professional competence and due care if the fee

	quoted is so low that it might be difficult to perform the engagement in accordance with applicable technical and professional standards.
330.3 A3	<p>Factors that are relevant in evaluating the level of such a threat include —</p> <p>(a) Whether the client is aware of the terms of the engagement and, in particular, the basis on which fees are determined and which professional services are covered; and</p> <p>(b) Whether the level of the fee is set by an independent third party such as a regulatory body.</p>
330.3 A4	<p>Examples of actions that might be safeguards to address such a self-interest threat include —</p> <p>(a) Adjusting the level of fees or the scope of the engagement; and</p> <p>(b) Having an appropriate reviewer review the work performed.</p>
<b>Contingent Fees</b>	
330.4 A1	Contingent fees are used for certain types of non-assurance services. However, contingent fees might create threats to compliance with the fundamental principles, particularly a self-interest threat to compliance with the principle of objectivity, in certain circumstances.
330.4 A2	<p>Factors that are relevant in evaluating the level of such threats include —</p> <p>(a) The nature of the engagement;</p> <p>(b) The range of possible fee amounts;</p> <p>(c) The basis for determining the fee;</p> <p>(d) Disclosure to intended users of the work performed by the public accountant and the basis of remuneration;</p> <p>(e) Quality management policies and</p>

	<p>procedures;</p> <p>(f) Whether an independent third party is to review the outcome or result of the transaction; and</p> <p>(g) Whether the level of the fee is set by an independent third party such as a regulatory body.</p>
330.4 A3	<p>Examples of actions that might be safeguards to address such a self-interest threat include —</p> <p>(a) Having an appropriate reviewer who was not involved in performing the non-assurance service review the work performed by the public accountant; and</p> <p>(b) Obtaining an advance written agreement with the client on the basis of remuneration.</p>
330.4 A4	<p>Requirements and application material related to contingent fees for services provided to audit or review clients and other assurance clients are set out in <i>Independence Standards</i>.</p>
<b>Referral Fees or Commissions</b>	
330.5 A1	<p>A self-interest threat to compliance with the principles of objectivity and professional competence and due care is created if a public accountant pays or receives a referral fee or receives a commission relating to a client. Such referral fees or commissions include, for example —</p> <p>(a) A fee paid to another public accountant for the purposes of obtaining new client work when the client continues as a client of the existing accountant but requires specialist services not offered by that public accountant;</p> <p>(b) A fee received for referring a continuing client to another public accountant or other expert where the existing accountant does not provide</p>

	<p>the specific professional service required by the client; and</p> <p>(c) A commission received from a third party (for example, a software vendor) in connection with the sale of goods or services to a client.</p>
330.5 A2	<p>Examples of actions that might be safeguards to address such a self-interest threat include —</p> <p>(a) Obtaining an advance agreement from the client for commission arrangements in connection with the sale by another party of goods or services to the client might address a self-interest threat; and</p> <p>(b) Disclosing to clients any referral fees or commission arrangements paid to, or received from, another public accountant or third party for recommending services or products might address a self-interest threat.</p>
<b>Purchase or Sale of a Firm</b>	
330.6 A1	A public accountant may purchase all or part of another firm on the basis that payments will be made to individuals formerly owning the firm or to their heirs or estates. Such payments are not referral fees or commissions for the purposes of this section.
<b>SECTION 340</b>	
<b>INDUCEMENTS, INCLUDING GIFTS AND HOSPITALITY</b>	
<b>Introduction</b>	
340.1	Public accountants are required to comply with the fundamental principles and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats.
340.2	Offering or accepting inducements might create a self-interest, familiarity or intimidation threat to compliance with the fundamental principles, particularly the principles of integrity, objectivity and professional behaviour.
340.3	This section sets out requirements and application material relevant to applying the conceptual

	framework in relation to the offering and accepting of inducements when performing professional services that does not constitute non-compliance with laws and regulations. This section also requires a public accountant to comply with relevant laws and regulations when offering or accepting inducements.
<b>Requirements and Application Material</b>	
<b>General</b>	
340.4 A1	<p>An inducement is an object, situation, or action that is used as a means to influence another individual's behaviour, but not necessarily with the intent to improperly influence that individual's behaviour. Inducements can range from minor acts of hospitality between public accountants and existing or prospective clients to acts that result in non-compliance with laws and regulations. An inducement can take many different forms, for example —</p> <ul style="list-style-type: none"> <li>(a) Gifts;</li> <li>(b) Hospitality;</li> <li>(c) Entertainment;</li> <li>(d) Political or charitable donations;</li> <li>(e) Appeals to friendship and loyalty;</li> <li>(f) Employment or other commercial opportunities; and</li> <li>(g) Preferential treatment, rights or privileges.</li> </ul>
<b>Inducements Prohibited by Laws and Regulations</b>	
R340.5	In many jurisdictions, there are laws and regulations, such as those related to bribery and corruption, that prohibit the offering or accepting of inducements in certain circumstances. The public accountant shall obtain an understanding of relevant laws and regulations and comply with them when the public accountant encounters such circumstances.
<b>Inducements Not Prohibited by Laws and Regulations</b>	



340.6 A1	The offering or accepting of inducements that is not prohibited by laws and regulations might still create threats to compliance with the fundamental principles.
<i>Inducements with Intent to Improperly Influence Behaviour</i>	
<b>R340.7</b>	A public accountant shall not offer, or encourage others to offer, any inducement that is made, or which the public accountant considers a reasonable and informed third party would be likely to conclude is made, with the intent to improperly influence the behaviour of the recipient or of another individual.
<b>R340.8</b>	A public accountant shall not accept, or encourage others to accept, any inducement that the public accountant concludes is made, or considers a reasonable and informed third party would be likely to conclude is made, with the intent to improperly influence the behaviour of the recipient or of another individual.
340.9 A1	An inducement is considered as improperly influencing an individual's behaviour if it causes the individual to act in an unethical manner. Such improper influence can be directed either towards the recipient or towards another individual who has some relationship with the recipient. The fundamental principles are an appropriate frame of reference for a public accountant in considering what constitutes unethical behaviour on the part of the public accountant and, if necessary by analogy, other individuals.
340.9 A2	A breach of the fundamental principle of integrity arises when a public accountant offers or accepts, or encourages others to offer or accept, an inducement where the intent is to improperly influence the behaviour of the recipient or of another individual.
340.9 A3	<p>The determination of whether there is actual or perceived intent to improperly influence behaviour requires the exercise of professional judgment. Relevant factors to consider might include —</p> <ul style="list-style-type: none"> <li>(a) The nature, frequency, value and cumulative effect of the inducement;</li> <li>(b) Timing of when the inducement is</li> </ul>

	<p>offered relative to any action or decision that it might influence;</p> <p>(c) Whether the inducement is a customary or cultural practice in the circumstances, for example, offering a gift on the occasion of a religious holiday or wedding;</p> <p>(d) Whether the inducement is an ancillary part of a professional service, for example, offering or accepting lunch in connection with a business meeting;</p> <p>(e) Whether the offer of the inducement is limited to an individual recipient or available to a broader group. The broader group might be internal or external to the firm, such as other suppliers to the client;</p> <p>(f) The roles and positions of the individuals at the firm or the client offering or being offered the inducement;</p> <p>(g) Whether the public accountant knows, or has reason to believe, that accepting the inducement would breach the policies and procedures of the client;</p> <p>(h) The degree of transparency with which the inducement is offered;</p> <p>(i) Whether the inducement was required or requested by the recipient; and</p> <p>(j) The known previous behaviour or reputation of the offeror.</p>
<i>Consideration of Further Actions</i>	
340.10 A1	If the public accountant becomes aware of an inducement offered with actual or perceived intent to improperly influence behaviour, threats to compliance with the fundamental principles might still be created even if the requirements in paragraphs R340.7 and R340.8 are met.

340.10 A2	<p>Examples of actions that might be safeguards to address such threats include —</p> <p>(a) Informing senior management of the firm or those charged with governance of the client regarding the offer; and</p> <p>(b) Amending or terminating the business relationship with the client.</p>
<i>Inducements with No Intent to Improperly Influence Behaviour</i>	
340.11 A1	The requirements and application material set out in the conceptual framework apply when a public accountant has concluded there is no actual or perceived intent to improperly influence the behaviour of the recipient or of another individual.
340.11 A2	If such an inducement is trivial and inconsequential, any threats created will be at an acceptable level.
340.11 A3	<p>Examples of circumstances where offering or accepting such an inducement might create threats even if the public accountant has concluded there is no actual or perceived intent to improperly influence behaviour include —</p> <p>(a) Self-interest threats — A public accountant is offered hospitality from the prospective acquirer of a client while providing corporate finance services to the client;</p> <p>(b) Familiarity threats — A public accountant regularly takes an existing or prospective client to sporting events; and</p> <p>(c) Intimidation threats — A public accountant accepts hospitality from a client, the nature of which could be perceived to be inappropriate were it to be publicly disclosed.</p>
340.11 A4	Relevant factors in evaluating the level of such threats created by offering or accepting such an inducement include the same factors set out in paragraph 340.9 A3 for determining intent.
340.11 A5	Examples of actions that might eliminate threats

	<p>created by offering or accepting such an inducement include —</p> <ul style="list-style-type: none"> <li>(a) Declining or not offering the inducement; and</li> <li>(b) Transferring responsibility for the provision of any professional services to the client to another individual who the public accountant has no reason to believe would be, or would be perceived to be, improperly influenced when providing the services.</li> </ul>
340.11 A6	<p>Examples of actions that might be safeguards to address such threats created by offering or accepting such an inducement include —</p> <ul style="list-style-type: none"> <li>(a) Being transparent with senior management of the firm or of the client about offering or accepting an inducement;</li> <li>(b) Registering the inducement in a log monitored by senior management of the firm or another individual responsible for the firm's ethics compliance or maintained by the client;</li> <li>(c) Having an appropriate reviewer, who is not otherwise involved in providing the professional service, review any work performed or decisions made by the public accountant with respect to the client from which the public accountant accepted the inducement;</li> <li>(d) Donating the inducement to charity after receipt and appropriately disclosing the donation, for example, to a member of senior management of the firm or the individual who offered the inducement;</li> <li>(e) Reimbursing the cost of the inducement, such as hospitality, received; and</li> </ul>

	(f) As soon as possible, returning the inducement, such as a gift, after it was initially accepted.
<b>Immediate or Close Family Members</b>	
<b>R340.12</b>	<p>A public accountant shall remain alert to potential threats to the public accountant's compliance with the fundamental principles created by the offering of an inducement —</p> <p>(a) By an immediate or close family member of the public accountant to an existing or prospective client of the public accountant;</p> <p>(b) To an immediate or close family member of the public accountant by an existing or prospective client of the public accountant.</p>
<b>R340.13</b>	<p>Where the public accountant becomes aware of an inducement being offered to or made by an immediate or close family member and concludes there is intent to improperly influence the behaviour of the public accountant or of an existing or prospective client of the public accountant, or considers a reasonable and informed third party would be likely to conclude such intent exists, the public accountant shall advise the immediate or close family member not to offer or accept the inducement.</p>
340.13 A1	<p>The factors set out in paragraph 340.9 A3 are relevant in determining whether there is actual or perceived intent to improperly influence the behaviour of the public accountant or of the existing or prospective client. Another factor that is relevant is the nature or closeness of the relationship, between —</p> <p>(a) The public accountant and the immediate or close family member;</p> <p>(b) The immediate or close family member and the existing or prospective client; and</p> <p>(c) The public accountant and the existing</p>

	<p>or prospective client.</p> <p>For example, the offer of employment, outside of the normal recruitment process, to the spouse of the public accountant by a client for whom the public accountant is providing a business valuation for a prospective sale might indicate such intent.</p>
340.13 A2	The application material in paragraph 340.10 A2 is also relevant in addressing threats that might be created when there is actual or perceived intent to improperly influence the behaviour of the public accountant, or of the existing or prospective client even if the immediate or close family member has followed the advice given pursuant to paragraph R340.13.
<i>Application of the Conceptual Framework</i>	
340.14 A1	<p>Where the public accountant becomes aware of an inducement offered in the circumstances addressed in paragraph R340.12, threats to compliance with the fundamental principles might be created where —</p> <p>(a) The immediate or close family member offers or accepts the inducement contrary to the advice of the public accountant pursuant to paragraph R340.13; or</p> <p>(b) The public accountant does not have reason to believe an actual or perceived intent to improperly influence the behaviour of the public accountant or of the existing or prospective client exists.</p>
340.14 A2	The application material in paragraphs 340.11 A1 to 340.11 A6 is relevant for the purposes of identifying, evaluating and addressing such threats. Factors that are relevant in evaluating the level of threats in these circumstances also include the nature or closeness of the relationships set out in paragraph 340.13 A1.
<b>Other Considerations</b>	
340.15 A1	If a public accountant encounters or is made aware of inducements that might result in non-compliance or suspected non-compliance with

	laws and regulations by a client or individuals working for or under the direction of the client, the requirements and application material in Section 360 apply.
340.15 A2	If a firm, network firm or an audit team member is being offered gifts or hospitality from an audit client, the requirement and application material set out in Section 420 apply.
340.15 A3	If a firm or an assurance team member is being offered gifts or hospitality from an assurance client, the requirement and application material set out in Section 906 apply.
<b>SECTION 350</b>	
<b>CUSTODY OF CLIENT ASSETS</b>	
<b>Introduction</b>	
350.1	Public accountants are required to comply with the fundamental principles and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats.
350.2	Holding client assets creates a self-interest or other threat to compliance with the principles of professional behaviour and objectivity. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirements and Application Material</b>	
<b>Before Taking Custody</b>	
<b>R350.3</b>	A public accountant shall not assume custody of client money or other assets unless permitted to do so by law and in accordance with any conditions under which such custody may be taken.
<b>SG350.3A</b>	A public accountant may hold non-assurance client money or other assets for the purpose of providing accounting-related, corporate secretarial and regulated financial services, provided that such money or other assets are held in accordance with this section and other relevant sections of this Code and all relevant laws and regulations relevant to the holding of and accounting for such assets.
<b>R350.4</b>	As part of client and engagement acceptance procedures related to assuming custody of client money or assets, a public accountant shall —

	<p>(a) Make inquiries about the source of the assets; and</p> <p>(b) Consider related legal and regulatory obligations.</p>
350.4 A1	Inquiries about the source of client assets might reveal, for example, that the assets were derived from illegal activities, such as money laundering. In such circumstances, a threat would be created and the provisions of Section 360 would apply.
<b>After Taking Custody</b>	
<b>R350.5</b>	<p>A public accountant entrusted with money or other assets belonging to others shall —</p> <p>(a) Comply with the laws and regulations relevant to holding and accounting for the assets;</p> <p>(b) Keep the assets separately from personal or firm assets;</p> <p>(c) Use the assets only for the purpose for which they are intended; and</p> <p>(d) Be ready at all times to account for the assets and any income, dividends, or gains generated, to any individuals entitled to that accounting.</p>
<b>SECTION 360</b>	
<b>RESPONDING TO NON-COMPLIANCE WITH LAWS AND REGULATIONS</b>	
<b>Introduction</b>	
360.1	Public accountants are required to comply with the fundamental principles and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats.
360.2	A self-interest or intimidation threat to compliance with the principles of integrity and professional behaviour is created when a public accountant becomes aware of non-compliance or suspected non-compliance with laws and regulations.
360.3	A public accountant might encounter or be made aware of non-compliance or suspected non-compliance in the course of providing a



	<p>professional service to a client. This section guides the public accountant in assessing the implications of the matter and the possible courses of action when responding to non-compliance or suspected non-compliance with —</p> <p>(a) Laws and regulations generally recognised to have a direct effect on the determination of material amounts and disclosures in the client’s financial statements; and</p> <p>(b) Other laws and regulations that do not have a direct effect on the determination of the amounts and disclosures in the client’s financial statements, but compliance with which might be fundamental to the operating aspects of the client’s business, to its ability to continue its business, or to avoid material penalties.</p>
<b>Objectives of the Public Accountant in Relation to Non-compliance with Laws and Regulations</b>	
360.4	<p>A distinguishing mark of the accountancy profession is its acceptance of the responsibility to act in the public interest. When responding to non-compliance or suspected non-compliance, the objectives of the public accountant are —</p> <p>(a) To comply with the principles of integrity and professional behaviour;</p> <p>(b) By alerting management or, where appropriate, those charged with governance of the client, to seek to —</p> <p style="padding-left: 40px;">(i) Enable them to rectify, remediate or mitigate the consequences of the identified or suspected non-compliance; or</p> <p style="padding-left: 40px;">(ii) Deter the commission of the non-compliance where it has not yet occurred; and</p> <p>(c) To take such further action as appropriate in the public interest.</p>

<b>Requirements and Application Material</b>	
<b>General</b>	
360.5 A1	<p>Non-compliance with laws and regulations (“non-compliance”) comprises acts of omission or commission, intentional or unintentional, which are contrary to the prevailing laws or regulations committed by the following parties:</p> <ul style="list-style-type: none"> <li>(a) A client;</li> <li>(b) Those charged with governance of a client;</li> <li>(c) Management of a client; or</li> <li>(d) Other individuals working for or under the direction of a client.</li> </ul>
360.5 A2	<p>Examples of laws and regulations which this section addresses include those that deal with —</p> <ul style="list-style-type: none"> <li>(a) Fraud, corruption and bribery;</li> <li>(b) Money laundering, terrorist financing and proceeds of crime;</li> <li>(c) Securities markets and trading;</li> <li>(d) Banking and other financial products and services;</li> <li>(e) Data protection;</li> <li>(f) Tax and pension liabilities and payments;</li> <li>(g) Environmental protection; and</li> <li>(h) Public health and safety.</li> </ul>
360.5 A3	<p>Non-compliance might result in fines, litigation or other consequences for the client, potentially materially affecting its financial statements. Importantly, such non-compliance might have wider public interest implications in terms of potentially substantial harm to investors, creditors, employees or the general public. For the purposes</p>

	<p>of this section, an act that causes substantial harm is one that results in serious adverse consequences to any of these parties in financial or non-financial terms. Examples include the perpetration of a fraud resulting in significant financial losses to investors, and breaches of environmental laws and regulations endangering the health or safety of employees or the public.</p>
<b>R360.6</b>	<p>In some jurisdictions, there are legal or regulatory provisions governing how public accountants should address non-compliance or suspected non-compliance. These legal or regulatory provisions might differ from or go beyond the provisions in this section. When encountering such non-compliance or suspected non-compliance, the public accountant shall obtain an understanding of those legal or regulatory provisions and comply with them, including —</p> <p>(a) Any requirement to report the matter to an appropriate authority; and</p> <p>(b) Any prohibition on alerting the client.</p>
360.6 A1	<p>A prohibition on alerting the client might arise, for example, pursuant to anti-money laundering legislation.</p>
360.7 A1	<p>This section applies regardless of the nature of the client, including whether or not it is a public interest entity.</p>
360.7 A2	<p>A public accountant who encounters or is made aware of matters that are clearly inconsequential is not required to comply with this section. Whether a matter is clearly inconsequential is to be judged with respect to its nature and its impact, financial or otherwise, on the client, its stakeholders and the general public.</p>
360.7 A3	<p>This section does not address —</p> <p>(a) Personal misconduct unrelated to the business activities of the client; and</p> <p>(b) Non-compliance by parties other than those specified in paragraph 360.5 A1. This includes, for example, circumstances where a public</p>

	<p>accountant has been engaged by a client to perform a due diligence assignment on a third party entity and the identified or suspected non-compliance has been committed by that third-party.</p> <p>The public accountant might nevertheless find the guidance in this section helpful in considering how to respond in these situations.</p>
<b>Responsibilities of Management and Those Charged with Governance</b>	
360.8 A1	<p>Management, with the oversight of those charged with governance, is responsible for ensuring that the client's business activities are conducted in accordance with laws and regulations. Management and those charged with governance are also responsible for identifying and addressing any non-compliance by —</p> <p>(a) The client;</p> <p>(b) An individual charged with governance of the entity;</p> <p>(c) A member of management; or</p> <p>(d) Other individuals working for or under the direction of the client.</p>
<b>Responsibilities of All Public Accountants</b>	
R360.9	<p>Where a public accountant becomes aware of a matter to which this section applies, the steps that the public accountant takes to comply with this section shall be taken on a timely basis. In taking timely steps, the public accountant shall have regard to the nature of the matter and the potential harm to the interests of the entity, investors, creditors, employees or the general public.</p>
<b>Audits of Financial Statements</b>	
<i>Obtaining an Understanding of the Matter</i>	
R360.10	<p>If a public accountant engaged to perform an audit of financial statements becomes aware of information concerning non-compliance or suspected non-compliance, the public accountant shall obtain an understanding of the matter. This</p>

	understanding shall include the nature of the non-compliance or suspected non-compliance and the circumstances in which it has occurred or might occur.
360.10 A1	The public accountant might become aware of the non-compliance or suspected non-compliance in the course of performing the engagement or through information provided by other parties.
360.10 A2	The public accountant is expected to apply knowledge and expertise, and exercise professional judgment. However, the public accountant is not expected to have a level of knowledge of laws and regulations greater than that which is required to undertake the engagement. Whether an act constitutes non-compliance is ultimately a matter to be determined by a court or other appropriate adjudicative body.
360.10 A3	Depending on the nature and significance of the matter, the public accountant might consult on a confidential basis with others within the firm, a network firm or a professional body, or with legal counsel.
<b>R360.11</b>	If the public accountant identifies or suspects that non-compliance has occurred or might occur, the public accountant shall discuss the matter with the appropriate level of management and, where appropriate, those charged with governance.
360.11 A1	The purpose of the discussion is to clarify the public accountant's understanding of the facts and circumstances relevant to the matter and its potential consequences. The discussion also might prompt management or those charged with governance to investigate the matter.
360.11 A2	The appropriate level of management with whom to discuss the matter is a question of professional judgment. Relevant factors to consider include — <ul style="list-style-type: none"> <li>(a) The nature and circumstances of the matter;</li> <li>(b) The individuals actually or potentially involved;</li> <li>(c) The likelihood of collusion;</li> </ul>

	<p>(d) The potential consequences of the matter; and</p> <p>(e) Whether that level of management is able to investigate the matter and take appropriate action.</p>
360.11 A3	The appropriate level of management is usually at least one level above the individual or individuals involved or potentially involved in the matter. In the context of a group, the appropriate level might be management at an entity that controls the client.
360.11 A4	The public accountant might also consider discussing the matter with internal auditors, where applicable.
<b>R360.12</b>	If the public accountant believes that management is involved in the non-compliance or suspected non-compliance, the public accountant shall discuss the matter with those charged with governance.
<i>Addressing the Matter</i>	
<b>R360.13</b>	<p>In discussing the non-compliance or suspected non-compliance with management and, where appropriate, those charged with governance, the public accountant shall advise them to take appropriate and timely actions, if they have not already done so, to —</p> <p>(a) Rectify, remediate or mitigate the consequences of the non-compliance;</p> <p>(b) Deter the commission of the non-compliance where it has not yet occurred; or</p> <p>(c) Disclose the matter to an appropriate authority where required by law or regulation or where considered necessary in the public interest.</p>
<b>R360.14</b>	The public accountant shall consider whether management and those charged with governance understand their legal or regulatory responsibilities with respect to the non-compliance or suspected non-compliance.
360.14 A1	If management and those charged with governance

	do not understand their legal or regulatory responsibilities with respect to the matter, the public accountant might suggest appropriate sources of information or recommend that they obtain legal advice.
<b>R360.15</b>	<p>The public accountant shall comply with applicable —</p> <p>(a) Laws and regulations, including legal or regulatory provisions governing the reporting of non-compliance or suspected non-compliance to an appropriate authority; and</p> <p>(b) Requirements under auditing standards, including those relating to —</p> <p>(i) Identifying and responding to non-compliance, including fraud;</p> <p>(ii) Communicating with those charged with governance; and</p> <p>(iii) Considering the implications of the non-compliance or suspected non-compliance for the auditor’s report.</p>
360.15 A1	Some laws and regulations might stipulate a period within which reports of non-compliance or suspected non-compliance are to be made to an appropriate authority.
<i>Communication with Respect to Groups</i>	
<b>R360.16</b>	<p>Where a public accountant becomes aware of non-compliance or suspected non-compliance in either of the following two situations in the context of a group, the public accountant shall communicate the matter to the group engagement partner unless prohibited from doing so by law or regulation:</p> <p>(a) The public accountant performs audit work related to a component for purposes of the group audit; or</p> <p>(b) The public accountant is engaged to perform an audit of the financial</p>

	<p>statements of a legal entity or business unit that is part of a group for purposes other than the group audit, for example, a statutory audit.</p> <p>The communication to the group engagement partner shall be in addition to responding to the matter in accordance with the provisions of this section.</p>
360.16 A1	<p>The purpose of the communication is to enable the group engagement partner to be informed about the matter and to determine, in the context of the group audit, whether and, if so, how to address it in accordance with the provisions in this section. The communication requirement in paragraph R360.16 applies regardless of whether the group engagement partner's firm or network is the same as or different from the public accountant's firm or network.</p>
<b>R360.17</b>	<p>Where the group engagement partner becomes aware of non-compliance or suspected non-compliance in the course of a group audit, the group engagement partner shall consider whether the matter might be relevant to —</p> <ul style="list-style-type: none"> <li>(a) One or more components subject to audit work for purposes of the group audit; or</li> <li>(b) One or more legal entities or business units that are part of the group and whose financial statements are subject to audit for purposes other than the group audit, for example, a statutory audit.</li> </ul> <p>This consideration shall be in addition to responding to the matter in the context of the group audit in accordance with the provisions of this section.</p>
<b>R360.18</b>	<p>If the non-compliance or suspected non-compliance might be relevant to one or more of the components specified in paragraph R360.17(a) and legal entities or business units specified in paragraph R360.17(b), the group engagement partner shall take steps to have the matter communicated to those performing audit</p>



	work at the components, legal entities or business units, unless prohibited from doing so by law or regulation. If necessary, the group engagement partner shall arrange for appropriate inquiries to be made (either of management or from publicly available information) as to whether the relevant legal entities or business units specified in paragraph R360.17(b) are subject to audit and, if so, to ascertain to the extent practicable the identity of the auditors.
360.18 A1	The purpose of the communication is to enable those responsible for audit work at the components, legal entities or business units to be informed about the matter and to determine whether and, if so, how to address it in accordance with the provisions in this section. The communication requirement applies regardless of whether the group engagement partner's firm or network is the same as or different from the firms or networks of those performing audit work at the components, legal entities or business units.
<i>Determining Whether Further Action is Needed</i>	
<b>R360.19</b>	The public accountant shall assess the appropriateness of the response of management and, where applicable, those charged with governance.
360.19 A1	Relevant factors to consider in assessing the appropriateness of the response of management and, where applicable, those charged with governance include whether — <ul style="list-style-type: none"> <li>(a) The response is timely;</li> <li>(b) The non-compliance or suspected non-compliance has been adequately investigated;</li> <li>(c) Action has been, or is being, taken to rectify, remediate or mitigate the consequences of any non-compliance;</li> <li>(d) Action has been, or is being, taken to deter the commission of any non-compliance where it has not yet occurred;</li> </ul>

	<p>(e) Appropriate steps have been, or are being, taken to reduce the risk of re-occurrence, for example, additional controls or training; and</p> <p>(f) The non-compliance or suspected non-compliance has been disclosed to an appropriate authority where appropriate and, if so, whether the disclosure appears adequate.</p>
<b>R360.20</b>	In light of the response of management and, where applicable, those charged with governance, the public accountant shall determine if further action is needed in the public interest.
360.20 A1	<p>The determination of whether further action is needed, and the nature and extent of it, will depend on various factors, including —</p> <p>(a) The legal and regulatory framework;</p> <p>(b) The urgency of the situation;</p> <p>(c) The pervasiveness of the matter throughout the client;</p> <p>(d) Whether the public accountant continues to have confidence in the integrity of management and, where applicable, those charged with governance;</p> <p>(e) Whether the non-compliance or suspected non-compliance is likely to recur; and</p> <p>(f) Whether there is credible evidence of actual or potential substantial harm to the interests of the entity, investors, creditors, employees or the general public.</p>
360.20 A2	Examples of circumstances that might cause the public accountant no longer to have confidence in the integrity of management and, where applicable, those charged with governance include situations where —

	<p>(a) The public accountant suspects or has evidence of their involvement or intended involvement in any non-compliance; or</p> <p>(b) The public accountant is aware that they have knowledge of such non-compliance and, contrary to legal or regulatory requirements, have not reported, or authorised the reporting of, the matter to an appropriate authority within a reasonable period.</p>
<b>R360.21</b>	The public accountant shall exercise professional judgment in determining the need for, and nature and extent of, further action. In making this determination, the public accountant shall take into account whether a reasonable and informed third party would be likely to conclude that the public accountant has acted appropriately in the public interest.
360.21 A1	<p>Further action that the public accountant might take includes —</p> <p>(a) Disclosing the matter to an appropriate authority even when there is no legal or regulatory requirement to do so;</p> <p>(b) Withdrawing from the engagement and the professional relationship where permitted by law or regulation.</p>
360.21 A2	Withdrawing from the engagement and the professional relationship is not a substitute for taking other actions that might be needed to achieve the public accountant's objectives under this section. In some jurisdictions, however, there might be limitations as to the further actions available to the public accountant. In such circumstances, withdrawal might be the only available course of action.
<b>R360.22</b>	Where the public accountant has withdrawn from the professional relationship pursuant to paragraphs R360.20 and 360.21 A1, the public accountant shall, on request by the proposed public accountant pursuant to paragraph R320.8, provide all relevant facts and other information concerning

	the identified or suspected non-compliance to the proposed public accountant. The predecessor accountant shall do so, even in the circumstances addressed in paragraph R320.8(b) where the client fails or refuses to grant the predecessor accountant permission to discuss the client's affairs with the proposed public accountant, unless prohibited by law or regulation.
360.22 A1	The facts and other information to be provided are those that, in the predecessor accountant's opinion, the proposed public accountant needs to be aware of before deciding whether to accept the audit appointment. Section 320 addresses communications from proposed public accountants.
<b>R360.23</b>	If the proposed public accountant is unable to communicate with the predecessor accountant, the proposed public accountant shall take reasonable steps to obtain information about the circumstances of the change of appointment by other means.
360.23 A1	Other means to obtain information about the circumstances of the change of appointment include inquiries of third parties or background investigations of management or those charged with governance.
360.24 A1	As assessment of the matter might involve complex analysis and judgments, the public accountant might consider — <ul style="list-style-type: none"> <li>(a) Consulting internally;</li> <li>(b) Obtaining legal advice to understand the public accountant's options and the professional or legal implications of taking any particular course of action;</li> <li>(c) Consulting on a confidential basis with a regulatory or professional body.</li> </ul>
<i>Determining Whether to Disclose the Matter to an Appropriate Authority</i>	
360.25 A1	Disclosure of the matter to an appropriate authority would be precluded if doing so would be contrary to law or regulation. Otherwise, the purpose of making disclosure is to enable an appropriate authority to cause the matter to be investigated and action to be taken in the public interest.

360.25 A2	<p>The determination of whether to make such a disclosure depends in particular on the nature and extent of the actual or potential harm that is or might be caused by the matter to investors, creditors, employees or the general public. For example, the public accountant might determine that disclosure of the matter to an appropriate authority is an appropriate course of action if —</p> <ul style="list-style-type: none"> <li>(a) The entity is engaged in bribery (for example, of local or foreign government officials for purposes of securing large contracts);</li> <li>(b) The entity is regulated and the matter is of such significance as to threaten its license to operate;</li> <li>(c) The entity is listed on a securities exchange and the matter might result in adverse consequences to the fair and orderly market in the entity’s securities or pose a systemic risk to the financial markets;</li> <li>(d) It is likely that the entity would sell products that are harmful to public health or safety; or</li> <li>(e) The entity is promoting a scheme to its clients to assist them in evading taxes.</li> </ul>
360.25 A3	<p>The determination of whether to make such a disclosure will also depend on external factors such as —</p> <ul style="list-style-type: none"> <li>(a) Whether there is an appropriate authority that is able to receive the information, and cause the matter to be investigated and action to be taken. The appropriate authority will depend on the nature of the matter. For example, the appropriate authority would be a securities regulator in the case of fraudulent financial reporting or an environmental protection agency in the case of a breach of environmental laws and regulations;</li> </ul>

	<p>(b) Whether there exists robust and credible protection from civil, criminal or professional liability or retaliation afforded by legislation or regulation, such as under whistle-blowing legislation or regulation; and</p> <p>(c) Whether there are actual or potential threats to the physical safety of the public accountant or other individuals.</p>
<b>R360.26</b>	<p>If the public accountant determines that disclosure of the non-compliance or suspected non-compliance to an appropriate authority is an appropriate course of action in the circumstances, that disclosure is permitted pursuant to paragraph R114.3 of the Code. When making such disclosure, the public accountant shall act in good faith and exercise caution when making statements and assertions. The public accountant shall also consider whether it is appropriate to inform the client of the public accountant's intentions before disclosing the matter.</p>
<i>Imminent Breach</i>	
<b>R360.27</b>	<p>In exceptional circumstances, the public accountant might become aware of actual or intended conduct that the public accountant has reason to believe would constitute an imminent breach of a law or regulation that would cause substantial harm to investors, creditors, employees or the general public. Having first considered whether it would be appropriate to discuss the matter with management or those charged with governance of the entity, the public accountant shall exercise professional judgment and determine whether to disclose the matter immediately to an appropriate authority in order to prevent or mitigate the consequences of such imminent breach. If disclosure is made, that disclosure is permitted pursuant to paragraph R114.3 of the Code.</p>
<i>Documentation</i>	
<b>R360.28</b>	<p>In relation to non-compliance or suspected non-compliance that falls within the scope of this section, the public accountant shall document —</p>

	<p>(a) How management and, where applicable, those charged with governance have responded to the matter;</p> <p>(b) The courses of action the public accountant considered, the judgments made and the decisions that were taken, having regard to the reasonable and informed third party test; and</p> <p>(c) How the public accountant is satisfied that the public accountant has fulfilled the responsibility set out in paragraph R360.20.</p>
360.28 A1	<p>This documentation is in addition to complying with the documentation requirements under applicable auditing standards. <i>Purpose of Communication</i>	
360.35 A1	<p>In the circumstances addressed in paragraphs R360.31 to R360.33, the purpose of the communication is to enable the audit engagement partner to be informed about the non-compliance or suspected non-compliance and to determine</p>

	whether and, if so, how to address it in accordance with the provisions of this section.
<i>Considering Whether Further Action is Needed</i>	
<b>R360.36</b>	The public accountant shall also consider whether further action is needed in the public interest.
360.36 A1	Whether further action is needed, and the nature and extent of it, will depend on factors such as — <ul style="list-style-type: none"> <li>(a) The legal and regulatory framework;</li> <li>(b) The appropriateness and timeliness of the response of management and, where applicable, those charged with governance;</li> <li>(c) The urgency of the situation;</li> <li>(d) The involvement of management or those charged with governance in the matter; and</li> <li>(e) The likelihood of substantial harm to the interests of the client, investors, creditors, employees or the general public.</li> </ul>
360.36 A2	Further action by the public accountant might include — <ul style="list-style-type: none"> <li>(a) Disclosing the matter to an appropriate authority even when there is no legal or regulatory requirement to do so;</li> <li>(b) Withdrawing from the engagement and the professional relationship where permitted by law or regulation.</li> </ul>
360.36 A3	In considering whether to disclose to an appropriate authority, relevant factors to take into account include — <ul style="list-style-type: none"> <li>(a) Whether doing so would be contrary to law or regulation;</li> <li>(b) Whether there are restrictions about disclosure imposed by a regulatory agency or prosecutor in an ongoing</li> </ul>

	<p>investigation into the non-compliance or suspected non-compliance; and</p> <p>(c) Whether the purpose of the engagement is to investigate potential non-compliance within the entity to enable it to take appropriate action.</p>

<b>SECTION 400</b>	
<b>APPLYING THE CONCEPTUAL FRAMEWORK TO INDEPENDENCE FOR AUDIT AND REVIEW ENGAGEMENTS</b>	
<b>Introduction</b>	
<b>General</b>	
400.1	It is in the public interest and required by the Code

	that public accountants be independent when performing audit or review engagements.
400.2	This Part applies to both audit and review engagements unless otherwise stated. The terms “audit”, “audit team”, “audit engagement”, “audit client” and “audit report” apply equally to review, review team, review engagement, review client, and review engagement report.
400.3	In this Part, the term “public accountant” refers to individual public accountants and their firms.
400.4	SSQM 1 requires a firm to design, implement and operate a system of quality management for audits or reviews of financial statements performed by the firm. As part of this system of quality management, SSQM 1 requires the firm to establish quality objectives that address the fulfilment of responsibilities in accordance with relevant ethical requirements, including those related to independence. Under SSQM 1, relevant ethical requirements are those related to the firm, its personnel and, when applicable, others subject to the independence requirements to which the firm and the firm’s engagements are subject. SSAs and Singapore Standards on Review Engagements (SSREs) establish responsibilities for engagement partners and engagement teams at the level of the engagement for audits and reviews, respectively. The allocation of responsibilities within a firm will depend on its size, structure and organisation. Many of the provisions of this Part do not prescribe the specific responsibility of individuals within the firm for actions related to independence, instead referring to “firm” for ease of reference. A firm assigns operational responsibility for compliance with independence requirements to an individual(s) in accordance with SSQM 1. In addition, an individual public accountant remains responsible for compliance with any provisions that apply to that public accountant’s activities, interests or relationships.
400.5	Independence is linked to the principles of objectivity and integrity. It comprises —  (a) Independence of mind — the state of mind that permits the expression of a conclusion without being affected by

	<p>influences that compromise professional judgment, thereby allowing an individual to act with integrity, and exercise objectivity and professional scepticism;</p> <p>(b) Independence in appearance — the avoidance of facts and circumstances that are so significant that a reasonable and informed third party would be likely to conclude that a firm’s, or an audit team member’s, integrity, objectivity or professional scepticism has been compromised.</p> <p>In this Part, references to an individual or firm being “independent” mean that the individual or firm has complied with the provisions of this Part.</p>
400.6	<p>When performing audit engagements, the Code requires firms to comply with the fundamental principles and be independent. This Part sets out specific requirements and application material on how to apply the conceptual framework to maintain independence when performing such engagements. The conceptual framework set out in Section 120 applies to independence as it does to the fundamental principles set out in Section 110. Section 405 sets out specific requirements and application material applicable in a group audit.</p>
400.7	<p>This Part describes —</p> <p>(a) Facts and circumstances, including professional activities, interests and relationships, that create or might create threats to independence;</p> <p>(b) Potential actions, including safeguards, that might be appropriate to address any such threats; and</p> <p>(c) Some situations where the threats cannot be eliminated or there can be no safeguards to reduce them to an acceptable level.</p>
<b>Engagement Team and Audit Team</b>	
400.8	<p>This Part applies to all audit team members,</p>



	including engagement team members.
400.9	<p>An engagement team for an audit engagement includes all partners and staff in the firm who perform audit work on the engagement, and any other individuals who perform audit procedures who are from —</p> <p>(a) A network firm; or</p> <p>(b) A firm that is not a network firm, or another service provider.</p> <p>For example, an individual from a component auditor firm who performs audit procedures on the financial information of a component for purposes of a group audit is a member of the engagement team for the group audit.</p>
400.10	<p>In SSQM 1, a service provider includes an individual or organisation external to the firm that provides a resource that is used in the performance of engagements. Service providers exclude the firm, a network firm or other structures or organisations in the network.</p>
400.11	<p>An audit engagement might involve experts within, or engaged by, the firm, a network firm, or a component auditor firm outside a group auditor firm's network, who assist in the engagement. Depending on the role of the individuals, they might be engagement team or audit team members. For example —</p> <p>(a) Individuals with expertise in a specialised area of accounting or auditing who perform audit procedures are engagement team members. These include, for example, individuals with expertise in accounting for income taxes or in analysing complex information produced by automated tools and techniques for the purpose of identifying unusual or unexpected relationships.</p> <p>(b) Individuals within, or engaged by, the firm who have direct influence over the outcome of the audit engagement through consultation regarding</p>

	<p>technical or industry-specific issues, transactions or events for the engagement are audit team members but not engagement team members.</p> <p>However, individuals who are external experts are neither engagement team nor audit team members.</p>
400.12	<p>If the audit engagement is subject to an engagement quality review, the engagement quality reviewer and any other individuals performing the engagement quality review are audit team members but not engagement team members.</p>
<b>Public Interest Entities</b>	
400.13	<p>Some of the requirements and application material set out in this Part are applicable only to the audit of financial statements of public interest entities, reflecting significant public interest in the financial condition of these entities due to the potential impact of their financial well-being on stakeholders.</p>
400.14	<p>Factors to consider in evaluating the extent of public interest in the financial condition of an entity include —</p> <p>(a) The nature of the business or activities, such as taking on financial obligations to the public as part of the entity's primary business;</p> <p>(b) Whether the entity is subject to regulatory</p>

	supervision designed to provide confidence that the entity will meet its financial obligations;
	(c) Size of the entity;
	(d) The importance of the entity to the sector in which it operates including how easily replaceable it is in the event of financial failure;
	(e) Number and nature of stakeholders including investors, customers, creditors and employees; and
	(f) The potential systemic impact on other sectors and the economy as a whole in the event of financial failure of the entity.
400.15	Stakeholders have heightened expectations regarding the independence of a firm performing an audit engagement for a public interest entity because of the significance of the public interest in the

	financial condition of the entity. The purpose of the requirements and application material for public interest entities as described in paragraph 400.13 is to meet these expectations, thereby enhancing stakeholders' confidence in the entity's financial statements that can be used when assessing the entity's financial condition.
<b>Reports that Include a Restriction on Use and Distribution</b>	
400.16	An audit report might include a restriction on use and distribution. If it does and the conditions set out in Section 800 are met, then the independence requirements in this Part may be modified as provided in Section 800.
<b>Assurance Engagements other than Audit and Review Engagements</b>	
400.17	Independence standards for assurance engagements that are not audit or review engagements are set out in Part 4B — <i>Independence for Assurance Engagements Other than Audit and Review Engagements</i> .
<b>Requirements and Application Material</b>	
<b>General</b>	
<b>R400.18</b>	A firm performing an audit engagement shall be independent.
<b>R400.19</b>	A firm shall apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence in relation to an audit engagement.
<b>Prohibition on Assuming Management Responsibilities</b>	
<b>R400.20</b>	A firm or a network firm shall not assume a management responsibility for an audit client.
400.20 A1	Management responsibilities involve controlling, leading and directing an entity, including making decisions regarding the acquisition, deployment and control of human, financial, technological, physical and intangible resources.
	When a firm or a network firm assumes a

400.20 A2	management responsibility for an audit client, self-review, self-interest and familiarity threats are created. Assuming a management responsibility might also create an advocacy threat because the firm or network firm becomes too closely aligned with the views and interests of management.
400.20 A3	<p>Determining whether an activity is a management responsibility depends on the circumstances and requires the exercise of professional judgment. Examples of activities that would be considered a management responsibility include —</p> <ul style="list-style-type: none"> <li>(a) Setting policies and strategic direction;</li> <li>(b) Hiring or dismissing employees;</li> <li>(c) Directing and taking responsibility for the actions of employees in relation to the employees' work for the entity;</li> <li>(d) Authorising transactions;</li> <li>(e) Controlling or managing bank accounts or investments;</li> <li>(f) Deciding which recommendations of the firm or network firm or other third parties to implement;</li> <li>(g) Reporting to those charged with governance on behalf of management; and</li> <li>(h) Taking responsibility for — <ul style="list-style-type: none"> <li>(i) The preparation and fair presentation of the financial statements in accordance with the applicable financial reporting framework; and</li> <li>(ii) Designing, implementing, monitoring or maintaining internal control.</li> </ul> </li> </ul>
400.20 A4	Subject to compliance with paragraph R400.21, providing advice and recommendations to assist the management of an audit client in discharging

	<p>its responsibilities is not assuming a management responsibility. The provision of advice and recommendations to an audit client might create a self-review threat and is addressed in Section 600.</p>
<p><b>R400.21</b></p>	<p>When performing a professional activity for an audit client, the firm shall be satisfied that client management makes all judgments and decisions that are the proper responsibility of management. This includes ensuring that the client's management —</p> <p>(a) Designates an individual who possesses suitable skill, knowledge and experience to be responsible at all times for the client's decisions and to oversee the activities. Such an individual, preferably within senior management, would understand —</p> <p>(i) The objectives, nature and results of the activities; and</p> <p>(ii) The respective client and firm or network firm responsibilities.</p> <p>However, the individual is not required to possess the expertise to perform or re-perform the activities;</p> <p>(b) Provides oversight of the activities and evaluates the adequacy of the results of the activities performed for the client's purpose; and</p> <p>(c) Accepts responsibility for the actions, if any, to be taken arising from the results of the activities.</p>
<p>400.21 A1</p>	<p>When technology is used in performing a professional activity for an audit client, the requirements in paragraphs R400.20 and R400.21 apply regardless of the nature or extent of such use of the technology.</p>

<b>Public Interest Entities</b>		
<b>R400.22</b>		For the purposes of this Part, a firm shall treat an entity as a public interest entity when it falls within any of the following categories:
		(a) A publicly traded entity;
		(b) An entity one of whose main functions is to take deposits from the public;
		(c) An entity one of whose main functions is to provide insurance to the public; or
		(d) An entity specified as such by law, regulation or professional standards to meet the purpose described in paragraph 400.15.
400.22 A1		When terms other than public interest entity are applied to entities by law, regulation or professional standards to meet the purpose described in paragraph 400.15, such terms are regarded as equivalent terms. However, if law, regulation or

	<p>professional standards designate entities as “public interest entities” for reasons unrelated to the purpose described in paragraph 400.15, that designation does not necessarily mean that such entities are public interest entities for the purposes of the Code.</p>
<p><b>R400.23</b></p>	<p>In complying with the requirement in paragraph R400.22, a firm shall take into account more explicit definitions established by law, regulation or professional standards for the categories set out in paragraph R400.22(a) to (c).</p>
<p>400.23 A1</p>	<p>The categories set out in paragraph R400.22(a) to (c) are broadly defined and no recognition is given to any size or other factors that can be relevant in a specific jurisdiction. The Code therefore provides for those bodies responsible for setting ethics standards for professional accountants to more explicitly define these categories by, for example —</p>
	<p>(a) Making reference to specific public markets for trading securities;</p>



	(b) Making reference to the local law or regulation defining banks or insurance companies;
	(c) Incorporating exemptions for specific types of entities, such as an entity with mutual ownership; and
	(d) Setting size criteria for certain types of entities.
400.23 A2	Paragraph R400.22(d) anticipates that those bodies responsible for setting ethics standards for professional accountants will add categories of public interest entities to meet the purpose described in paragraph 400.15, taking into account factors such as those set out in paragraph 400.14. Depending on the facts and circumstances in a specific jurisdiction, such categories could include —
	(a) Pension funds;
	(b) Collective investment vehicles;

	(c) Private entities with large numbers of stakeholders (other than investors);
	(d) Not-for-profit organisations or governmental entities; and
	(e) Public utilities.
400.24 A1	A firm is encouraged to determine whether to treat other entities as public interest entities for the purposes of this Part. When making this determination, the firm might consider the factors set out in paragraph 400.14 as well as the following factors:
	(a) Whether the entity is likely to become a public interest entity in the near future;
	(b) Whether in similar circumstances, a predecessor firm has applied independence requirements for public interest entities to the entity;

	(c) Whether in similar circumstances, the firm has applied independence requirements for public interest entities to other entities;
	(d) Whether the entity has been specified as not being a public interest entity by law, regulation or professional standards;
	(e) Whether the entity or other stakeholders requested the firm to apply independence requirements for public interest entities to the entity and, if so, whether there are any reasons for not meeting this request;
	(f) The entity's corporate governance arrangements, for example, whether those charged with governance are distinct from the owners or

<i>Public Disclosure — Application of Independence Requirements for Public Interest Entities</i>		
<b>R400.25</b>		Subject to paragraph R400.26, when a firm has applied the independence requirements for public interest entities as described in paragraph 400.13 in performing an audit of the financial statements of an entity, the firm shall publicly disclose that fact in a manner deemed appropriate, taking into account the timing and accessibility of the information to stakeholders.
<b>R400.26</b>		As an exception to paragraph R400.25, a firm may not make such a disclosure if doing so will result in disclosing confidential future plans of the entity.
<i>[Deleted by S 741/2023 wef 15/12/2023]</i>		
<b>Related Entities</b>		
<b>R400.27</b>		As defined, an audit client that is a publicly traded entity in accordance with paragraphs R400.22 and R400.23 includes all of its related entities. For all other entities, references to an audit client in this Part include related entities over which the client has direct or indirect control. When the audit team knows, or has reason to believe, that a relationship or circumstance involving any other related entity of the client is relevant to the evaluation of the firm's independence from the client, the audit team

	shall include that related entity when identifying, evaluating and addressing threats to independence.
<b>[Paragraphs 400.21 to 400.29 are intentionally left blank]</b>	
<b>Period During which Independence is Required</b>	
<b>R400.30</b>	Independence, as required by this Part, shall be maintained during both —  (a) The engagement period; and  (b) The period covered by the financial statements.
400.30 A1	The engagement period starts when the engagement team begins to perform the audit. The engagement period ends when the audit report is issued. When the engagement is of a recurring nature, it ends at the later of the notification by either party that the professional relationship has ended or the issuance of the final audit report.
<b>R400.31</b>	If an entity becomes an audit client during or after the period covered by the financial statements on which the firm will express an opinion, the firm shall determine whether any threats to independence are created by —  (a) Financial or business relationships with the audit client during or after the period covered by the financial statements but before accepting the audit engagement; or  (b) Previous services provided to the audit client by the firm or a network firm.
400.31 A1	Threats to independence are created if a non-assurance service was provided to an audit client during, or after the period covered by the financial statements, but before the engagement team begins to perform the audit, and the service would not be permitted during the engagement period.
400.31 A2	A factor to be considered in such circumstances is whether the results of the service provided might form part of or affect the accounting records, the internal controls over financial reporting, or the financial statements on which the firm will express

	an opinion.
400.31 A3	<p>Examples of actions that might be safeguards to address threats to independence include —</p> <p>(a) Not assigning professionals who performed the non-assurance service to be members of the engagement team;</p> <p>(b) Having an appropriate reviewer review the audit work or non-assurance service as appropriate; and</p> <p>(c) Engaging another firm outside of the network to evaluate the results of the non-assurance service or having another firm outside of the network re-perform the non-assurance service to the extent necessary to enable the other firm to take responsibility for the service.</p>
400.31 A4	A threat to independence created by the provision of a non-assurance service by a firm or a network firm prior to the audit engagement period or prior to the period covered by the financial statements on which the firm will express an opinion is eliminated or reduced to an acceptable level if the results of such service have been used or implemented in a period audited by another firm.

Such communication enables those charged with governance to —</p> <p>(a) Consider the firm's judgments in identifying and evaluating threats;</p> <p>(b) Consider how threats have been addressed including the appropriateness of safeguards when they are available and capable of being applied; and</p> <p>(c) Take appropriate action.</p> <p>Such an approach can be particularly helpful with respect to intimidation and familiarity threats.</p>

<b>Network Firms</b>	
400.50 A1	Firms frequently form larger structures with other firms and entities to enhance their ability to provide professional services. <b>R400.51</b>	A network firm shall be independent of the audit clients of the other firms within the network as required by this Part.
400.51 A1	The independence requirements in this Part that apply to a network firm apply to any entity that meets the definition of a network firm. It is not necessary for the entity also to meet the definition of a firm. For example, a consulting practice or professional law practice might be a network firm but not a firm.

400.53 A2	The sharing of immaterial costs does not in itself create a network. In addition, if the sharing of costs is limited only to those costs related to the development of audit methodologies, manuals or training courses, this would not in itself create a network. Further, an association between a firm and an otherwise unrelated entity jointly to provide a service or develop a product does not in itself create a network. (Ref: Para. R400.53(a)).
400.53 A3	Common ownership, control or management might be achieved by contract or other means. (Ref: Para. R400.53(b)).
400.53 A4	Common quality management policies and procedures are those designed, implemented and operated across the larger structure. (Ref: Para. R400.53(c)).
400.53 A5	Sharing a common business strategy involves an agreement by the entities to achieve common strategic objectives. An entity is not a network firm merely because it co-operates with another entity solely to respond jointly to a request for a proposal for the provision of a professional service. (Ref: Para. R400.53(d)).
400.53 A6	A common brand name includes common initials or a common name. A firm is using a common brand name if it includes, for example, the common brand name as part of, or along with, its firm name when a partner of the firm signs an audit report. (Ref: Para. R400.53(e)).
400.53 A7	Even if a firm does not belong to a network and does not use a common brand name as part of its firm name, it might appear to belong to a network if its stationery or promotional materials refer to the firm being a member of an association of firms. Accordingly, if care is not taken in how a firm describes such membership, a perception might be created that the firm belongs to a network. (Ref: Para. R400.53(e)).
400.53 A8	Professional resources include — <ul style="list-style-type: none"> <li data-bbox="820 1669 1427 1774">(a) Common systems that enable firms to exchange information such as client data, billing and time records;</li> <li data-bbox="820 1795 1427 1854">(b) Partners and other personnel;</li> </ul>

	<p>(c) Technical departments that consult on technical or industry specific issues, transactions or events for assurance engagements;</p> <p>(d) Audit methodology or audit manuals; and</p> <p>(e) Training courses and facilities. (Ref: Para. R400.53(f)).</p>
400.53 A9	<p>Whether the shared professional resources are significant depends on the circumstances. For example —</p> <p>(a) The shared resources might be limited to common audit methodology or audit manuals, with no exchange of personnel or client or market information. In such circumstances, it is unlikely that the shared resources would be significant. The same applies to a common training endeavour;</p> <p>(b) The shared resources might involve the exchange of personnel or information, such as where personnel are drawn from a shared pool, or where a common technical department is created within the larger structure to provide participating firms with technical advice that the firms are required to follow. In such circumstances, a reasonable and informed third party is more likely to conclude that the shared resources are significant. (Ref: Para. R400.53(f)).</p>
<b>R400.54</b>	<p>If a firm or a network sells a component of its practice, and the component continues to use all or part of the firm's or network's name for a limited time, the relevant entities shall determine how to disclose that they are not network firms when presenting themselves to outside parties.</p>
400.54 A1	<p>The agreement for the sale of a component of a practice might provide that, for a limited period of time, the sold component can continue to use all or part of the name of the firm or the network, even</p>

	though it is no longer connected to the firm or the network. In such circumstances, while the two entities might be practicing under a common name, the facts are such that they do not belong to a larger structure aimed at cooperation. The two entities are therefore not network firms.

<b>General Documentation of Independence for Audit and Review Engagements</b>	
<b>R400.60</b>	A firm shall document conclusions regarding compliance with this Part, and the substance of any relevant discussions that support those conclusions. 400.60 A1	Documentation provides evidence of the firm's judgments in forming conclusions regarding compliance with this Part. However, a lack of documentation does not determine whether a firm considered a particular matter or whether the firm is independent.

<b>Mergers and Acquisitions</b>	
<i>When a Client Merger Creates a Threat</i>	
400.70 A1	An entity might become a related entity of an audit client because of a merger or acquisition. A threat to independence and, therefore, to the ability of a firm to continue an audit engagement might be created by previous or current interests or relationships between a firm or network firm and such a related entity.
<b>R400.71</b>	In the circumstances set out in paragraph 400.70 A1 —

	<p>(d) Evaluate the significance of the breach and its impact on the firm’s objectivity and ability to issue an audit report; and</p> <p>(e) Depending on the significance of the breach, determine —</p> <p>(i) Whether to end the audit engagement; or</p> <p>(ii) Whether it is possible to take action that satisfactorily addresses the consequences of the breach and whether such action can be taken and is appropriate in the circumstances.</p> <p>In making this determination, the firm shall exercise professional judgment and take into account whether a reasonable and informed third party would be likely to conclude that the firm’s objectivity would be compromised, and therefore, the firm would be unable to issue an audit report.</p>
400.80 A1	A breach of a provision of this Part might occur despite the firm having a system of quality management designed to address independence requirements. It might be necessary to end the audit engagement because of the breach.

	<p>(e) If the breach relates to an audit team member, the role of that individual;</p> <p>(f) If the breach was created by providing a professional service, the impact of that service, if any, on the accounting records or the amounts recorded in the financial statements on which the firm will express an opinion; and</p> <p>(g) The extent of the self-interest, advocacy, intimidation or other threats created by the breach.</p>
400.80 A3	<p>Depending upon the significance of the breach, examples of actions that the firm might consider to address the breach satisfactorily include —</p> <p>(a) Removing the relevant individual from the audit team;</p> <p>(b) Using different individuals to conduct an additional review of the affected audit work or to re-perform that work to the extent necessary;</p> <p>(c) Recommending that the audit client engage another firm to review or re-perform the affected audit work to the extent necessary; and</p> <p>(d) If the breach relates to a non-assurance service that affects the accounting records or an amount recorded in the financial statements, engaging another firm to evaluate the results of the non-assurance service or having another firm re-perform the non-assurance service to the extent necessary to enable the other firm to take responsibility for the service.</p>

<b>R400.82</b>	<p>If the firm determines that action can be taken to address the consequences of the breach satisfactorily, the firm shall discuss with those charged with governance —</p> <ul style="list-style-type: none"> <li>(a) The significance of the breach, including its nature and duration;</li> <li>(b) How the breach occurred and how it was identified;</li> <li>(c) The action proposed or taken and why the action will satisfactorily address the consequences of the breach and enable the firm to issue an audit report;</li> <li>(d) The conclusion that, in the firm’s professional judgment, objectivity has not been compromised and the rationale for that conclusion; and</li> <li>(e) Any steps proposed or taken by the firm to reduce or avoid the risk of further breaches occurring.</li> </ul> <p>Such discussion shall take place as soon as possible unless an alternative timing is specified by those charged with governance for reporting less significant breaches.</p>
<i>Communication of Breaches to Those Charged with Governance</i>	
400.83 A1	Paragraphs R300.9 and R300.10 set out requirements with respect to communicating with those charged with governance.
<b>R400.84</b>	<p>With respect to breaches, the firm shall communicate in writing to those charged with governance —</p> <ul style="list-style-type: none"> <li>(a) All matters discussed in accordance with paragraph R400.82 and obtain the concurrence of those charged with governance that action can be, or has been, taken to satisfactorily address the</li> </ul>

	<p>consequences of the breach; and</p> <p>(b) A description of —</p> <p>(i) The firm’s policies and procedures relevant to the breach designed to provide it with reasonable assurance that independence is maintained; and</p> <p>(ii) Any steps that the firm has taken, or proposes to take, to reduce or avoid the risk of further breaches occurring.</p>
<b>R400.85</b>	If those charged with governance do not concur that the action proposed by the firm in accordance with paragraph R400.80(e)(ii) satisfactorily addresses the consequences of the breach, the firm shall take the steps necessary to end the audit engagement in accordance with paragraph R400.81.
<i>Breaches Before the Previous Audit Report was Issued</i>	
<b>R400.86</b>	If the breach occurred prior to the issuance of the previous audit report, the firm shall comply with the provisions of Part 4A in evaluating the significance of the breach and its impact on the firm’s objectivity and its ability to issue an audit report in the current period.
<b>R400.87</b>	<p>The firm shall also —</p> <p>(a) Consider the impact of the breach, if any, on the firm’s objectivity in relation to any previously issued audit reports, and the possibility of withdrawing such audit reports; and</p> <p>(b) Discuss the matter with those charged with governance.</p>
<i>Documentation</i>	
<b>R400.88</b>	<p>In complying with the requirements in paragraphs R400.80 to R400.87, the firm shall document —</p> <p>(a) The breach;</p>

<b>R400.89</b>	<p>If the firm continues with the audit engagement, it shall document —</p> <p>(a) The conclusion that, in the firm’s professional judgment, objectivity has not been compromised; and</p> <p>(b) The rationale for why the action taken satisfactorily addressed the consequences of the breach so that the firm could issue an audit report.</p>
<b>SECTION 405</b>	
<b>GROUP AUDITS</b>	
<b>Introduction</b>	
405.1	Section 400 requires a firm to be independent when performing an audit engagement, and to apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence. This section sets out specific requirements and application material relevant to applying the conceptual framework when performing a group audit engagement.
<b>Requirements and Application Material</b>	
<b>General</b>	
405.2 A1	SSAs apply to an audit of group financial statements. SSA 600 (Revised) deals with special considerations that apply to an audit of group financial statements, including when component auditors are involved. SSA 600 (Revised) requires the group engagement partner to take responsibility for confirming whether the component auditors understand and will comply with the relevant ethical requirements, including those related to independence, that apply to the group audit. The

	independence requirements referred to in SSA 600 (Revised), or other relevant auditing standards applicable to group audits that are equivalent to SSA 600 (Revised), are those specified in this section.
405.2 A2	A component auditor firm that participates in a group audit engagement might separately issue an audit opinion on the financial statements of the component audit client. Depending on the circumstances, the component auditor firm might need to comply with different independence requirements when performing audit work for a group audit and separately issuing an audit opinion on the financial statements of the component audit client for statutory, regulatory or other reasons.
<b>Communication Between a Group Auditor Firm and a Component Auditor Firm</b>	
<b>R405.3</b>	SSA 600 (Revised) requires the group engagement partner to take responsibility to make a component auditor aware of the relevant ethical requirements that are applicable given the nature and the circumstances of the group audit engagement. When making the component auditor firm aware of the relevant ethical requirements, the group auditor firm shall communicate at appropriate times the necessary information to enable the component auditor firm to meet its responsibilities under this section.
405.3 A1	Examples of matters the group auditor firm might communicate include — <ul style="list-style-type: none"> <li>(a) Whether the group audit client is a public interest entity and the relevant ethical requirements applicable to the group audit engagement;</li> <li>(b) The related entities and other components within the group audit client that are relevant to the independence considerations applicable to the component auditor firm and the group audit team members within, or engaged by, that firm;</li> <li>(c) The period during which the component auditor firm is required to be independent; and</li> </ul>

	<p>(d) Whether an audit partner who performs audit work at the component for purposes of the group audit is a key audit partner for the group audit.</p>
<b>R405.4</b>	<p>SSA 600 (Revised) also requires the group engagement partner to request the component auditor to communicate whether the component auditor has complied with the relevant ethical requirements, including those related to independence, that apply to the group audit engagement. For the purposes of this section, such a request shall include the communication of —</p> <p>(a) Any independence matters that require significant judgment; and</p> <p>(b) In relation to those matters, the component auditor firm’s conclusion whether the threats to its independence are at an acceptable level, and the rationale for that conclusion.</p>
405.4 A1	<p>If a matter comes to the attention of the group engagement partner that indicates that a threat to independence exists, SSA 220 (Revised) requires the group engagement partner to evaluate the threat and take appropriate action.</p>
<b>Independence Considerations Applicable to Individuals</b>	
<i>Members of the Group Audit Team Within, or Engaged by, a Group Auditor Firm and Its Network Firms</i>	
<b>R405.5</b>	<p>Members of the group audit team within, or engaged by, the group auditor firm and its network firms shall be independent of the group audit client in accordance with the requirements of this Part that are applicable to the audit team.</p>
<i>Other Members of the Group Audit Team</i>	
<b>R405.6</b>	<p>Members of the group audit team within, or engaged by, a component auditor firm outside the group auditor firm’s network shall be independent of —</p> <p>(a) The component audit client;</p> <p>(b) The entity on whose group financial statements the group auditor firm</p>

	<p>expresses an opinion; and</p> <p>(c) Any entity over which the entity in sub-paragraph (b) has direct or indirect control, provided that such entity has direct or indirect control over the component audit client,</p> <p>in accordance with the requirements of this Part that are applicable to the group audit team.</p>
<b>R405.7</b>	<p>In relation to related entities or components within the group audit client other than those covered in paragraph R405.6, a member of the group audit team within, or engaged by, a component auditor firm outside the group auditor firm's network shall notify the component auditor firm about any relationship or circumstance the individual knows, or has reason to believe, might create a threat to the individual's independence in the context of the group audit.</p>
405.7 A1	<p>Examples of relationships or circumstances involving the individual or any of the individual's immediate family members, as applicable, that are relevant to the individual's consideration when complying with paragraph R405.7 include —</p> <p>(a) A direct or material indirect financial interest in an entity that has control over the group audit client if the group audit client is material to that entity (see Section 510);</p> <p>(b) A loan or guarantee involving (see Section 511) —</p> <p>(i) An entity that is not a bank or similar institution unless the loan or guarantee is immaterial; or</p> <p>(ii) A bank or similar institution unless the loan or guarantee is made under normal lending procedures, terms and conditions;</p> <p>(c) A business relationship that is significant or involves a material financial interest (see Section 520);</p>

<b>R405.9</b>	A group auditor firm shall be independent of the group audit client in accordance with the requirements of this Part that are applicable to a firm.
<b>Independence Considerations Applicable to Network Firms of a Group Auditor Firm</b>	
<b>R405.10</b>	A network firm of the group auditor firm shall be independent of the group audit client in accordance with the requirements of this Part that are applicable to a network firm.
<b>Independence Considerations Applicable to Component Auditor Firms outside a Group Auditor Firm's Network</b>	
<i>All Group Audit Clients</i>	
<b>R405.11</b>	A component auditor firm outside the group

	<p>auditor firm's network shall —</p> <p>(a) Be independent of the component audit client in accordance with the requirements set out in this Part that are applicable to a firm with respect to all audit clients;</p> <p>(b) Apply the relevant requirements in paragraphs R510.4(a), R510.7 and R510.9 with respect to financial interests in the entity on whose group financial statements the group auditor firm expresses an opinion; and</p> <p>(c) Apply the relevant requirements in Section 511 with respect to loans and guarantees involving the entity on whose group financial statements the group auditor firm expresses an opinion.</p>
<b>R405.12</b>	When a component auditor firm outside the group auditor firm's network knows, or has reason to believe, that a relationship or circumstance involving the group audit client, beyond those addressed in paragraph R405.11(b) and (c), is relevant to the evaluation of the component auditor firm's independence from the component audit client, the component auditor firm shall include that relationship or circumstance when identifying, evaluating and addressing threats to independence.
<b>R405.13</b>	When a component auditor firm outside the group auditor firm's network knows, or has reason to believe, that a relationship or circumstance of a firm within the component auditor firm's network with the component audit client or the group audit client creates a threat to the component auditor firm's independence, the component auditor firm shall evaluate and address any such threat.
<i>Period During which Independence is Required</i>	
405.14 A1	The references to the financial statements and the audit report in paragraphs R400.30 and 400.30 A1 mean the group financial statements and the audit report on the group financial statements, respectively, when applied in this section.
<i>Group Audit Clients that are Not Public Interest Entities</i>	

<b>R405.15</b>	When the group audit client is not a public interest entity, a component auditor firm outside the group auditor firm's network shall be independent of the component audit client in accordance with the requirements set out in this Part that are applicable to audit clients that are not public interest entities for the purposes of the group audit.
405.15 A1	Where a component auditor firm outside the group auditor firm's network also performs an audit engagement for a component audit client that is a public interest entity for reasons other than the group audit, for example, a statutory audit, the independence requirements that are relevant to audit clients that are public interest entities apply to that engagement.
<i>Group Audit Clients that are Public Interest Entities</i>	
Non-Assurance Services	
<b>R405.16</b>	Subject to paragraph R405.17, when the group audit client is a public interest entity, a component auditor firm outside the group auditor firm's network shall comply with the provisions in Section 600 that are applicable to public interest entities with respect to the provision of non-assurance services to the component audit client.

<b>R405.19</b>	When an entity that is not a related entity becomes a component within the group audit client, the group auditor firm shall apply paragraphs R400.71 to R400.76.
<b>Changes in Component Auditor Firms</b>	
<i>All Group Audit Clients</i>	
405.20 A1	<p>There might be circumstances in which the group auditor firm requests another firm to perform audit work as a component auditor firm during or after the period covered by the group financial statements, for example due to a client merger or acquisition. A threat to the component auditor firm's independence might be created by —</p> <p>(a) Financial or business relationships of the component auditor firm with the component audit client during or after the period covered by the group financial statements but before the component auditor firm agrees to perform the audit work; or</p> <p>(b) Previous services provided to the component audit client by the component auditor firm.</p>
405.20 A2	Paragraphs 400.31 A1 to 400.31 A3 set out application material that is applicable for a component auditor firm's assessment of threats to independence if a non-assurance service was provided by the component auditor firm to the component audit client during or after the period covered by the group financial statements, but

	before the component auditor firm begins to perform the audit work for the purposes of the group audit, and the service would not be permitted during the engagement period.
405.20 A3	Paragraph 400.31 A4 sets out application material that is applicable for a component auditor firm's assessment of threats to independence if a non-assurance service was provided by the component auditor firm to the component audit client prior to the period covered by the group financial statements.
<i>Group Audit Clients that are Public Interest Entities</i>	
405.21 A1	Paragraphs R400.32 and 400.32 A1 are applicable when a component auditor firm agrees to perform audit work for group audit purposes in relation to a group audit client that is a public interest entity if the component auditor firm has previously provided a non-assurance service to the component audit client.
405.21 A2	Paragraphs R600.26 and 600.26 A1 are applicable in relation to a non-assurance service provided, either currently or previously, by a component auditor firm to a component audit client when the group audit client subsequently becomes a public interest entity.
<b>Breach of an Independence Provision at a Component Auditor Firm</b>	
405.22 A1	A breach of a provision of this section might occur despite a component auditor firm having a system of quality management designed to address independence requirements. Paragraphs R405.23 to R405.29 are relevant to a group auditor firm's determination as to whether it would be able to use a component auditor firm's work if a breach has occurred at the component auditor firm.
405.22 A2	In the case of a breach at a component auditor firm within the group auditor firm's network, paragraphs R400.80 to R400.89 also apply to the group auditor firm in relation to the group audit, as applicable.
<i>When a Component Auditor Firm Identifies a Breach</i>	
<b>R405.23</b>	If a component auditor firm concludes that a breach of this section has occurred, the component auditor firm shall —

	<p>(a) End, suspend or eliminate the interest or relationship that created the breach and address the consequences of the breach;</p> <p>(b) Evaluate the significance of the breach and its impact on the component auditor firm's objectivity and ability to perform audit work for the purposes of the group audit;</p> <p>(c) Depending on the significance of the breach, determine whether it is possible to take action that satisfactorily addresses the consequences of the breach and whether such action can be taken and is appropriate in the circumstances; and</p> <p>(d) Promptly communicate in writing the breach to the group engagement partner, including the component auditor firm's assessment of the significance of the breach and any actions proposed or taken to address the consequences of the breach.</p>
405.23 A1	<p>Paragraphs 400.80 A2 and 400.80 A3 set out application material relevant to the component auditor firm's evaluation of the significance and impact of the breach on the component auditor firm's objectivity and ability to issue an opinion or conclusion on the audit work performed at the component for purposes of the group audit, and its consideration of any actions that might be taken to address the consequences of the breach satisfactorily.</p>
<b>R405.24</b>	<p>Upon receipt of the component auditor firm's communication of the breach, the group engagement partner shall —</p> <p>(a) Review the component auditor firm's assessment of the significance of the breach and its impact on the component auditor firm's objectivity, and any action that can be or has been taken to address the consequences of the breach;</p>

	<p>(b) Evaluate the group auditor firm's ability to use the work of the component auditor firm for the purposes of the group audit; and</p> <p>(c) Determine the need for any further action.</p>
<b>R405.25</b>	In applying paragraph R405.24, the group engagement partner shall exercise professional judgment and take into account whether a reasonable and informed third party would be likely to conclude that the component auditor firm's objectivity is compromised, and therefore, the group auditor firm is unable to use the work of the component auditor firm for the purposes of the group audit.
405.25 A1	If the group engagement partner determines that the consequences of the breach have been satisfactorily addressed by the component auditor firm and does not compromise the component auditor firm's objectivity, the group auditor firm may continue to use the work of the component auditor firm for the group audit. In certain circumstances, the group engagement partner might determine that additional actions are needed to satisfactorily address the breach in order to use the component auditor firm's work. Examples of such action include the group auditor firm performing specific procedures on the areas impacted by the breach or requesting the component auditor firm to perform appropriate remedial work on the affected areas.
405.25 A2	SSA 600 (Revised) sets out that if there has been a breach by a component auditor and the breach has not been satisfactorily addressed, the group auditor cannot use the work of that component auditor. In those circumstances, the group engagement partner might find other means to obtain the necessary audit evidence on the component audit client's financial information. Examples of such means include the group auditor firm performing the necessary audit work on the component audit client's financial information or requesting another component auditor firm to perform such audit work.
<i>Discussion with Those Charged with Governance of the Group Audit Client</i>	



405.26 A1	With respect to breaches by a component auditor firm within the group auditor firm's network, paragraph R400.84 applies.
<b>R405.27</b>	<p>With respect to breaches by a component auditor firm outside the group auditor firm's network, the group auditor firm shall discuss with those charged with governance of the group audit client —</p> <p>(a) The component auditor firm's assessment of the significance and impact of the breach on the component auditor firm's objectivity, including the nature and duration of the breach, and the action that can be or has been taken; and</p> <p>(b) Whether —</p> <p>(i) The action will satisfactorily address, or has addressed, the consequences of the breach; or</p> <p>(ii) The group auditor firm will use other means to obtain the necessary audit evidence on the component audit client's financial information.</p> <p>Such discussion shall take place as soon as possible unless an alternative timing is specified by those charged with governance for reporting less significant breaches.</p>
<b>R405.28</b>	The group auditor firm shall communicate in writing to those charged with governance of the group audit client all matters discussed in accordance with paragraph R405.27 and obtain the concurrence of those charged with governance that the action can be or has been taken to satisfactorily address the consequences of the breach.
<b>R405.29</b>	If those charged with governance do not concur that the action that can be or has been taken would satisfactorily address the consequences of the breach at the component auditor firm, the group auditor firm shall not use the work performed by the component auditor firm for the purposes of the group audit.

<b>SECTION 410</b>	
<b>FEES</b>	
<b>Introduction</b>	
410.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
410.2	Section 330 sets out application material relevant to applying the conceptual framework where the level and nature of fee and other remuneration arrangements might create a self-interest threat to compliance with one or more of the fundamental principles. This section sets out specific requirements and application material relevant to applying the conceptual framework to identify, evaluate and address threats to independence arising from fees charged to audit clients.
<b>Requirements and Application Material</b>	
<b>General</b>	
410.3 A1	Fees for professional services are usually negotiated with and paid by an audit client and might create threats to independence. This practice is generally recognised and accepted by intended users of financial statements.
410.3 A2	When the audit client is a public interest entity, stakeholders have heightened expectations regarding the firm's independence. As transparency can serve to better inform the views and decisions of those charged with governance and a wide range of stakeholders, this section provides for disclosure of fee-related information to both those charged with governance and stakeholders more generally for audit clients that are public interest entities.
410.3 A3	For the purposes of this section, audit fees comprise fees or other types of remuneration for an audit or review of financial statements. Where reference is made to the fee for the audit of the financial statements, this does not include any fee for an audit of special purpose financial statements or a review of financial statements. (Ref: Paras. R410.23(a), 410.25 A1 and R410.31(a)).

<i>Fees Paid by an Audit Client</i>	
410.4 A1	When fees are negotiated with and paid by an audit client, this creates a self-interest threat and might create an intimidation threat to independence.
410.4 A2	The application of the conceptual framework requires that before a firm or network firm accepts an audit or any other engagement for an audit client, the firm determines whether the threats to independence created by the fees proposed to the client are at an acceptable level. The application of the conceptual framework also requires the firm to re-evaluate such threats when facts and circumstances change during the engagement period for the audit.
410.4 A3	<p>Factors that are relevant in evaluating the level of threats created when fees for an audit or any other engagement are paid by the audit client include —</p> <ul style="list-style-type: none"> <li>(a) The level of the fees and the extent to which they have regard to the resources required, taking into account the firm's commercial and market priorities;</li> <li>(b) Any linkage between fees for the audit and those for services other than audit and the relative size of both elements;</li> <li>(c) The extent of any dependency between the level of the fee for, and the outcome of, the service;</li> <li>(d) Whether the fee is for services to be provided by the firm or a network firm;</li> <li>(e) The level of the fee in the context of the service to be provided by the firm or a network firm;</li> <li>(f) The operating structure and the compensation arrangements of the firm and network firms;</li> <li>(g) The significance of the client, or a third party referring the client, to the firm, network firm, partner or office;</li> </ul>

	<p>(h) The nature of the client, for example whether the client is a public interest entity;</p> <p>(i) The relationship of the client to the related entities to which the services other than audit are provided, for example when the related entity is a sister entity;</p> <p>(j) The involvement of those charged with governance in appointing the auditor and agreeing fees, and the apparent emphasis they and client management place on the quality of the audit and the overall level of the fees;</p> <p>(k) Whether the level of the fee is set by an independent third party, such as a regulatory body; and</p> <p>(l) Whether the quality of the firm's audit work is subject to the review of an independent third party, such as an oversight body.</p>
410.4 A4	The conditions, policies and procedures described in paragraph 120.15 A3 (particularly a system of quality management designed, implemented and operated by the firm in accordance with quality management standards issued by the Institute of Singapore Chartered Accountants) might also impact the evaluation of whether the threats to independence are at an acceptable level.
410.4 A5	The requirements and application material that follow identify circumstances which might need to be further evaluated when determining whether the threats are at an acceptable level. For those circumstances, application material includes examples of additional factors that might be relevant in evaluating the threats.
<b>Level of Audit Fees</b>	
410.5 A1	Determining the fees to be charged to an audit client, whether for audit or other services, is a business decision of the firm taking into account the facts and circumstances relevant to that specific

	engagement, including the requirements of technical and professional standards.
410.5 A2	<p>Factors that are relevant in evaluating the level of self-interest and intimidation threats created by the level of the audit fee paid by the audit client include —</p> <p>(a) The firm’s commercial rationale for the audit fee; and</p> <p>(b) Whether undue pressure has been, or is being, applied by the client to reduce the audit fee.</p>
410.5 A3	<p>Examples of actions that might be safeguards to address such threats include —</p> <p>(a) Having an appropriate reviewer who does not take part in the audit engagement assess the reasonableness of the fee proposed, having regard to the scope and complexity of the engagement; and</p> <p>(b) Having an appropriate reviewer who did not take part in the audit engagement review the work performed.</p>
<i>Impact of Other Services Provided to an Audit Client</i>	
<b>R410.6</b>	Subject to paragraph R410.7, a firm shall not allow the audit fee to be influenced by the provision of services other than audit to an audit client by the firm or a network firm.
410.6 A1	The audit fee ordinarily reflects a combination of matters, such as those identified in paragraph 410.23 A1. However, the provision of other services to an audit client is not an appropriate consideration in determining the audit fee.
<b>R410.7</b>	As an exception to paragraph R410.6, when determining the audit fee, the firm may take into consideration the cost savings achieved as a result of experience derived from the provision of services other than audit to an audit client.
<b>Contingent Fees</b>	
410.8 A1	Contingent fees are fees calculated on a

	<p>predetermined basis relating to the outcome of a transaction or the result of the services performed. A contingent fee charged through an intermediary is an example of an indirect contingent fee. In this section, a fee is not regarded as being contingent if established by a court or other public authority.</p>
<b>R410.9</b>	A firm shall not charge directly or indirectly a contingent fee for an audit engagement.
<b>R410.10</b>	<p>A firm or network firm shall not charge directly or indirectly a contingent fee for a non-assurance service provided to an audit client, if —</p> <p>(a) The fee is charged by the firm expressing the opinion on the financial statements and the fee is material or expected to be material to that firm;</p> <p>(b) The fee is charged by a network firm that participates in a significant part of the audit and the fee is material or expected to be material to that firm; or</p> <p>(c) The outcome of the non-assurance service, and therefore the amount of the fee, is dependent on a future or contemporary judgment related to the audit of a material amount in the financial statements.</p>
410.10 A1	<p>Paragraphs R410.9 and R410.10 preclude a firm or a network firm from entering into certain contingent fee arrangements with an audit client. Even if a contingent fee arrangement is not precluded when providing a non-assurance service to an audit client, it might still impact the level of the self-interest threat.</p>
410.10 A2	<p>Factors that are relevant in evaluating the level of such a threat include —</p> <p>(a) The range of possible fee amounts;</p> <p>(b) Whether an appropriate authority determines the outcome on which the contingent fee depends;</p> <p>(c) Disclosure to intended users of the work performed by the firm and the</p>

	<p>basis of remuneration;</p> <p>(d) The nature of the service; and</p> <p>(e) The effect of the event or transaction on the financial statements.</p>
410.10 A3	<p>Examples of actions that might be safeguards to address such a self-interest threat include —</p> <p>(a) Having an appropriate reviewer who was not involved in performing the non-assurance service review the work performed; and</p> <p>(b) Obtaining an advance written agreement with the client on the basis of remuneration.</p>
<b>Total Fees – Proportion of Fees for Services Other than Audit to Audit Fee</b>	
410.11 A1	<p>The level of the self-interest threat might be impacted when a large proportion of fees charged by the firm or network firms to an audit client is generated by providing services other than audit to the client, due to concerns about the potential loss of either the audit engagement or other services. Such circumstances might also create an intimidation threat. A further consideration is a perception that the firm or network firm focuses on the non-audit relationship, which might create a threat to the auditor's independence.</p>
410.11 A2	<p>Factors that are relevant in evaluating the level of such threats include —</p> <p>(a) The ratio of fees for services other than audit to the audit fee;</p> <p>(b) The length of time during which a large proportion of fees for services other than audit to the audit fee has existed; and</p> <p>(c) The nature, scope and purposes of the services other than audit, including —</p> <p>(i) Whether they are recurring services;</p>

	(ii) Whether law or regulation mandates the services to be performed by the firm.
410.11 A3	<p>Examples of actions that might be safeguards to address such self-interest or intimidation threats include —</p> <p>(a) Having an appropriate reviewer who was not involved in the audit or the service other than audit review the relevant audit work; and</p> <p>(b) Reducing the extent of services other than audit provided to the audit client.</p>
<b>Total Fees — Overdue Fees</b>	
410.12 A1	The level of the self-interest threat might be impacted if fees payable by an audit client for the audit or services other than audit are overdue during the period of the audit engagement.
410.12 A2	It is generally expected that the firm will obtain payment of such fees before the audit report is issued.
410.12 A3	<p>Factors that are relevant in evaluating the level of such a self-interest threat include —</p> <p>(a) The significance of the overdue fees to the firm;</p> <p>(b) The length of time the fees have been overdue; and</p> <p>(c) The firm's assessment of the ability and willingness of the audit client to pay the overdue fees.</p>
410.12 A4	<p>Examples of actions that might be safeguards to address such a threat include —</p> <p>(a) Obtaining partial payment of overdue fees; and</p> <p>(b) Having an appropriate reviewer who did not take part in the audit engagement review the audit work.</p>
<b>R410.13</b>	When a significant part of the fees due from an



	<p>audit client remains unpaid for a long time, the firm shall determine —</p> <p>(a) Whether the overdue fees might be equivalent to a loan to the client, in which case the requirements and application material set out in Section 511 are applicable; and</p> <p>(b) Whether it is appropriate for the firm to be re-appointed or continue the audit engagement.</p>
<b>Total Fees — Fee Dependency</b>	
<i>All Audit Clients</i>	
410.14 A1	When the total fees generated from an audit client by the firm expressing the audit opinion represent a large proportion of the total fees of that firm, the dependence on, and concern about the potential loss of, fees from audit and other services from that client impact the level of the self-interest threat and create an intimidation threat.
410.14 A2	In calculating the total fees of the firm, the firm might use financial information available from the previous financial year and estimate the proportion based on that information if appropriate.
410.14 A3	<p>Factors that are relevant in evaluating the level of such self-interest and intimidation threats include —</p> <p>(a) The operating structure of the firm; and</p> <p>(b) Whether the firm is expected to diversify such that any dependence on the audit client is reduced.</p>
410.14 A4	<p>Examples of actions that might be safeguards to address such threats include —</p> <p>(a) Having an appropriate reviewer who is not a member of the firm review the audit work;</p> <p>(b) Reducing the extent of services other than audit provided to the audit client;</p> <p>(c) Increasing the client base of the firm to</p>

	<p>reduce dependence on the client; and</p> <p>(d) Increasing the extent of services provided to other clients.</p>
410.14 A5	A self-interest or intimidation threat is created when the fees generated by a firm from an audit client represent a large proportion of the revenue of one partner or one office of the firm.
410.14 A6	<p>Factors that are relevant in evaluating the level of such threats include —</p> <p>(a) The qualitative and quantitative significance of the audit client to the partner or office; and</p> <p>(b) The extent to which the compensation of the partner, or the partners in the office, is dependent upon the fees generated from the client.</p>
410.14 A7	<p>Examples of actions that might be safeguards to address such self-interest or intimidation threats include —</p> <p>(a) Having an appropriate reviewer who was not involved in the audit engagement review the audit work;</p> <p>(b) Ensuring that the compensation of the partner is not significantly influenced by the fees generated from the client;</p> <p>(c) Reducing the extent of services other than audit provided by the partner or office to the audit client;</p> <p>(d) Increasing the client base of the partner or the office to reduce dependence on the client; and</p> <p>(e) Increasing the extent of services provided by the partner or the office to other clients.</p>
Audit Clients that are Not Public Interest Entities	
<b>R410.15</b>	When for each of five consecutive years total fees from an audit client that is not a public interest

	<p>entity represent, or are likely to represent, more than 30% of the total fees received by the firm, the firm shall determine whether either of the following actions might be a safeguard to reduce the threats created to an acceptable level, and if so, apply it:</p> <p>(a) Prior to the audit opinion being issued on the fifth year's financial statements, have a professional accountant, who is not a member of the firm expressing the opinion on the financial statements, review the fifth year's audit work; or</p> <p>(b) After the audit opinion on the fifth year's financial statements has been issued, and before the audit opinion is issued on the sixth year's financial statements, have a professional accountant, who is not a member of the firm expressing the opinion on the financial statements, or a professional body review the fifth year's audit work.</p>

<b>R410.18</b>	When for each of two consecutive years the total fees from an audit client that is a public interest entity represent, or are likely to represent, more than 15% of the total fees received by the firm, the firm shall determine whether, prior to the audit opinion being issued on the second year's financial statements, a review, consistent with the objective of an engagement quality review, performed by a professional accountant who is not a member of the firm expressing the opinion on the financial statements ("pre-issuance review") might be a safeguard to reduce the threats to an acceptable level, and if so, apply it.
<b>R410.19</b>	When two or more firms are engaged to conduct an audit of the client's financial statements, the involvement of the other firm in the audit may be regarded each year as an action equivalent to that in paragraph R410.18, if —  (a) The circumstances addressed by paragraph R410.18 apply to only one of the firms expressing the audit opinion; and  (b) Each firm performs sufficient work to take full individual responsibility for the audit opinion.
<b>R410.20</b>	Subject to paragraph R410.21, if the circumstances described in paragraph R410.18 continue for five consecutive years, the firm shall cease to be the auditor after the audit opinion for the fifth year is issued.
<b>R410.21</b>	As an exception to paragraph R410.20, the firm may continue to be the auditor after five consecutive years if there is a compelling reason to do so having regard to the public interest, provided that —  (a) The firm consults with a regulatory or professional body in the relevant jurisdiction and it concurs that having the firm continue as the auditor would be in the public interest; and  (b) Before the audit opinion on the sixth and any subsequent year's financial

	statements is issued, the firm engages a professional accountant, who is not a member of the firm expressing the opinion on the financial statements, to perform a pre-issuance review.
410.21 A1	A factor which might give rise to a compelling reason is the lack of viable alternative firms to carry out the audit engagement, having regard to the nature and location of the client's business.
<b>Transparency of Information Regarding Fees for Audit Clients that are Public Interest Entities</b>	
<i>Communication About Fee-related Information with Those Charged with Governance</i>	
410.22 A1	Communication by the firm of fee-related information (for both audit and services other than audit) with those charged with governance assists in their assessment of the firm's independence. Effective communication in this regard also allows for a two-way open exchange of views and information about, for example, the expectations that those charged with governance might have regarding the scope and extent of audit work and impact on the audit fee.
<b>Fees for the Audit of the Financial Statements</b>	
<b>R410.23</b>	Subject to paragraph R410.24, the firm shall communicate in a timely manner with those charged with governance of an audit client that is a public interest entity — <ul style="list-style-type: none"> <li>(a) Fees paid or payable to the firm or network firms for the audit of the financial statements on which the firm expresses an opinion; and</li> <li>(b) Whether the threats created by the level of those fees are at an acceptable level, and if not, any actions the firm has taken or proposes to take to reduce such threats to an acceptable level.</li> </ul>
410.23 A1	The objective of such communication is to provide the background and context to the fees for the audit of the financial statements on which the firm expresses an opinion to enable those charged with governance to consider the independence of the firm. The nature and extent of matters to be communicated will depend on the facts and

<b>R410.24</b>	<p>As an exception to paragraph R410.23, the firm may determine not to communicate the information set out in paragraph R410.23 to those charged with governance of an entity that is (directly or indirectly) wholly-owned by another public interest entity provided that —</p> <ul style="list-style-type: none"> <li>(a) The entity is consolidated into group financial statements prepared by that other public interest entity; and</li> <li>(b) The firm or a network firm expresses an opinion on those group financial statements.</li> </ul>

Fees for Other Services

**R410.25**

Subject to paragraph R410.27, the firm shall communicate in a timely manner with those charged with governance of an audit client that is a public interest entity —

- (a) The fees, other than those disclosed under paragraph R410.23(a), charged to the client for the provision of services by the firm or a network firm during the period covered by the financial statements on which the firm expresses an opinion. For this purpose, such fees shall only include fees charged to the client and its related entities over which the client has direct or indirect control that are consolidated in the financial statements on which the firm will express an opinion; and
- (b) As set out in paragraph 410.11 A1, where the firm has identified that there is an impact on the level of the self-interest threat or that there is an intimidation threat to independence created by the proportion of fees for services other than audit relative to the audit fee —
  - (i) Whether such threats are at an acceptable level; and
  - (ii) If not, any actions that the firm has taken or proposes to take to reduce such threats to an acceptable level.

410.25 A1

The objective of such communication is to provide the background and context to the fees for other services to enable those charged with governance to consider the independence of the firm. The nature and extent of matters to be communicated will depend on the facts and circumstances and might include for example —

- (a) The amount of fees for other services that are required by law or regulation;
- (b) The nature of other services provided

<b>Requirements and Application Material</b>	
<b>General</b>	
411.3 A1	<p>When an audit team member for a particular audit client is evaluated on or compensated for selling non-assurance services to that audit client, the level of the self-interest threat will depend on —</p> <p>(a) What proportion of the compensation or evaluation is based on the sale of such services;</p>

	<p>(b) The role of the individual on the audit team; and</p> <p>(c) Whether the sale of such non-assurance services influences promotion decisions.</p>
411.3 A2	<p>Examples of actions that might eliminate such a self-interest threat include —</p> <p>(a) Revising the compensation plan or evaluation process for that individual; and</p> <p>(b) Removing that individual from the audit team.</p>
411.3 A3	<p>An example of an action that might be a safeguard to address such a self-interest threat is having an appropriate reviewer review the work of the audit team member.</p>
<b>R411.4</b>	<p>A firm shall not evaluate or compensate a key audit partner based on that partner's success in selling non-assurance services to the partner's audit client. This requirement does not preclude normal profit-sharing arrangements between partners of a firm.</p>
<b>SECTION 420</b>	
<b>GIFTS AND HOSPITALITY</b>	
<b>Introduction</b>	
420.1	<p>Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.</p>
420.2	<p>Accepting gifts and hospitality from an audit client might create a self-interest, familiarity or intimidation threat. This section sets out a specific requirement and application material relevant to applying the conceptual framework in such circumstances.</p>
<b>Requirement and Application Material</b>	
<b>R420.3</b>	<p>A firm, network firm or an audit team member shall not accept gifts and hospitality from an audit client, unless the value is trivial and inconsequential.</p>
420.3 A1	<p>Where a firm, network firm or audit team member is offering or accepting an inducement to or from an audit client, the requirements and application material set out in Section 340 apply and non-compliance with these requirements might create threats to independence.</p>
420.3 A2	<p>The requirements set out in Section 340 relating to offering or accepting inducements do not allow a firm, network firm or audit team member to accept gifts and hospitality where the intent is to improperly influence behaviour even if the value is trivial and inconsequential.</p>
<b>SECTION 430</b>	
<b>ACTUAL OR THREATENED LITIGATION</b>	

<b>Introduction</b>	
430.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
430.2	When litigation with an audit client occurs, or appears likely, self-interest and intimidation threats are created. This section sets out specific application material relevant to applying the conceptual framework in such circumstances.
<b>Application Material</b>	
<b>General</b>	
430.3 A1	The relationship between client management and audit team members must be characterised by complete candour and full disclosure regarding all aspects of a client's operations. Adversarial positions might result from actual or threatened litigation between an audit client and the firm, a network firm or an audit team member. Such adversarial positions might affect management's willingness to make complete disclosures and create self-interest and intimidation threats.
430.3 A2	Factors that are relevant in evaluating the level of such threats include —  (a) The materiality of the litigation; and  (b) Whether the litigation relates to a prior audit engagement.
430.3 A3	If the litigation involves an audit team member, an example of an action that might eliminate such self-interest and intimidation threats is removing that individual from the audit team.
430.3 A4	An example of an action that might be a safeguard to address such self-interest and intimidation threats is to have an appropriate reviewer review the work performed.
<b>SECTION 510</b>	
<b>FINANCIAL INTERESTS</b>	
<b>Introduction</b>	
510.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
510.2	Holding a financial interest in an audit client might create a self-interest threat. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirements and Application Material</b>	
<b>General</b>	
510.3 A1	A financial interest might be held directly or indirectly through an intermediary such as a collective investment vehicle, an estate or a trust. When a beneficial owner has control over the intermediary or ability to influence its investment

	decisions, the Code defines that financial interest to be direct. Conversely, when a beneficial owner has no control over the intermediary or ability to influence its investment decisions, the Code defines that financial interest to be indirect.
510.3 A2	This section contains references to the “materiality” of a financial interest. In determining whether such an interest is material to an individual, the combined net worth of the individual and the individual’s immediate family members may be taken into account.
510.3 A3	Factors that are relevant in evaluating the level of a self-interest threat created by holding a financial interest in an audit client include —  (a) The role of the individual holding the financial interest;  (b) Whether the financial interest is direct or indirect; and  (c) The materiality of the financial interest.
<b>Financial Interests Held by the Firm, a Network Firm, Audit Team Members and Others</b>	
<b>R510.4</b>	Subject to paragraph R510.5, a direct financial interest or a material indirect financial interest in the audit client shall not be held by —  (a) The firm or a network firm;  (b) An audit team member, or any of that individual’s immediate family;  (c) Any other partner in the office in which an engagement partner practices in connection with the audit engagement, or any of that other partner’s immediate family; or  (d) Any other partner or managerial employee who provides non-audit services to the audit client, except for any whose involvement is minimal, or any of that individual’s immediate family.
510.4 A1	The office in which the engagement partner practices in connection with an audit engagement is not necessarily the office to which that partner is assigned. When the engagement partner is located in a different office from that of the other engagement team members, professional judgment is needed to determine the office in which the partner practices in connection with the engagement.
<b>R510.5</b>	As an exception to paragraph R510.4, an immediate family member identified in paragraph R510.4(c) or (d) may hold a direct or material indirect financial interest in an audit client, provided that —  (a) The family member received the financial interest because of employment rights, for example through pension or share option plans, and, when necessary, the firm addresses the threat created by the financial interest; and



	<p>(b) The family member disposes of or forfeits the financial interest as soon as practicable when the family member has or obtains the right to do so, or in the case of a stock option, when the family member obtains the right to exercise the option.</p>
<b>Financial Interests in an Entity Controlling an Audit Client</b>	
<b>R510.6</b>	When an entity has a controlling interest in an audit client and the client is material to the entity, neither the firm, nor a network firm, nor an audit team member, nor any of that individual's immediate family shall hold a direct or material indirect financial interest in that entity.
<b>Financial Interests Held as Trustee</b>	
<b>R510.7</b>	<p>Paragraph R510.4 shall also apply to a financial interest in an audit client held in a trust for which the firm, network firm or individual acts as trustee, unless —</p> <p>(a) None of the following is a beneficiary of the trust: the trustee, the audit team member or any of that individual's immediate family, the firm or a network firm;</p> <p>(b) The interest in the audit client held by the trust is not material to the trust;</p> <p>(c) The trust is not able to exercise significant influence over the audit client; and</p> <p>(d) None of the following can significantly influence any investment decision involving a financial interest in the audit client: the trustee, the audit team member or any of that individual's immediate family, the firm or a network firm.</p>
<b>Financial Interests in Common with the Audit Client</b>	
<b>R510.8</b>	<p>(a) A firm, or a network firm, or an audit team member, or any of that individual's immediate family shall not hold a financial interest in an entity when an audit client also has a financial interest in that entity, unless —</p> <p>(i) The financial interests are immaterial to the firm, the network firm, the audit team member and that individual's immediate family member and the audit client, as applicable; or</p> <p>(ii) The audit client cannot exercise significant influence over the entity.</p> <p>(b) Before an individual who has a financial interest described in paragraph R510.8(a) can become an audit team member, the individual or that individual's immediate family member shall</p>

	<p>either —</p> <p>(i) Dispose of the interest; or</p> <p>(ii) Dispose of enough of the interest so that the remaining interest is no longer material.</p>
<b>Financial Interests Received Unintentionally</b>	
<b>R510.9</b>	<p>If a firm, a network firm or a partner or employee of the firm or a network firm, or any of that individual's immediate family, receives a direct financial interest or a material indirect financial interest in an audit client by way of an inheritance, gift, as a result of a merger or in similar circumstances and the interest would not otherwise be permitted to be held under this section, then —</p> <p>(a) If the interest is received by the firm or a network firm, or an audit team member or any of that individual's immediate family, the financial interest shall be disposed of immediately, or enough of an indirect financial interest shall be disposed of so that the remaining interest is no longer material; or</p> <p>(b) (i) If the interest is received by an individual who is not an audit team member, or by any of that individual's immediate family, the financial interest shall be disposed of as soon as possible, or enough of an indirect financial interest shall be disposed of so that the remaining interest is no longer material; and</p> <p>(ii) Pending the</p>

	disposal of the financial interest, when necessary the firm shall address the threat created.
<b>Financial Interests — Other Circumstances</b>	
<i>Immediate Family</i>	
510.10 A1	A self-interest, familiarity, or intimidation threat might be created if an audit team member, or any of that individual's immediate family, or the firm or a network firm has a financial interest in an entity when a director or officer or controlling owner of the audit client is also known to have a financial interest in that entity.
510.10 A2	Factors that are relevant in evaluating the level of such threats include — <ul style="list-style-type: none"> <li>(a) The role of the individual on the audit team;</li> <li>(b) Whether ownership of the entity is closely or widely held;</li> <li>(c) Whether the interest allows the investor to control or significantly influence the entity; and</li> <li>(d) The materiality of the financial interest.</li> </ul>
510.10 A3	An example of an action that might eliminate such a self-interest, familiarity, or intimidation threat is removing the audit team member with the financial interest from the audit team.
510.10 A4	An example of an action that might be a safeguard to address such a self-interest threat is having an appropriate reviewer review the work of the audit team member.
<i>Close Family</i>	
510.10 A5	A self-interest threat might be created if an audit team member knows that a close family member has a direct financial interest or a material indirect financial interest in the audit client.
510.10 A6	Factors that are relevant in evaluating the level of such a threat include — <ul style="list-style-type: none"> <li>(a) The nature of the relationship between the audit team member and the close family member;</li> <li>(b) Whether the financial interest is direct or indirect; and</li> <li>(c) The materiality of the financial interest to the close family member.</li> </ul>

510.10 A7	<p>Examples of actions that might eliminate such a self-interest threat include —</p> <p>(a) Having the close family member dispose, as soon as practicable, of all of the financial interest or dispose of enough of an indirect financial interest so that the remaining interest is no longer material; and</p> <p>(b) Removing the individual from the audit team.</p>
510.10 A8	<p>An example of an action that might be a safeguard to address such a self-interest threat is having an appropriate reviewer review the work of the audit team member.</p>
<i>Other Individuals</i>	
510.10 A9	<p>A self-interest threat might be created if an audit team member knows that a financial interest in the audit client is held by individuals such as —</p> <p>(a) Partners and professional employees of the firm or network firm, apart from those who are specifically not permitted to hold such financial interests by paragraph R510.4, or their immediate family members; and</p> <p>(b) Individuals with a close personal relationship with an audit team member.</p>
510.10 A10	<p>Factors that are relevant in evaluating the level of such a threat include —</p> <p>(a) The firm’s organisational, operating and reporting structure; and</p> <p>(b) The nature of the relationship between the individual and the audit team member.</p>

<b>Requirements and Application Material</b>

511.3 A1	This section contains references to the “materiality” of a loan or guarantee. In determining whether such a loan or guarantee is material to an individual, the combined net worth of the individual and the individual’s immediate family members may be taken into account.
<b>Loans and Guarantees with an Audit Client</b>	
<b>R511.4</b>	A firm, a network firm, an audit team member, or any of that individual’s immediate family shall not make or guarantee a loan to an audit client unless the loan or guarantee is immaterial to —  (a) The firm, the network firm or the individual making the loan or guarantee, as applicable; and  (b) The client.
<b>Loans and Guarantees with an Audit Client that is a Bank or Similar Institution</b>	
<b>R511.5</b>	A firm, a network firm, an audit team member, or any of that individual’s immediate family shall not accept a loan, or a guarantee of a loan, from an audit client that is a bank or a similar institution unless the loan or guarantee is made under normal lending procedures, terms and conditions.
511.5 A1	Examples of loans include mortgages, bank overdrafts, car loans, and credit card balances.
511.5 A2	Even if a firm or network firm receives a loan from an audit client that is a bank or similar institution under normal lending procedures, terms and conditions, the loan might create a self-interest threat if it is material to the audit client or firm receiving the loan.
511.5 A3	An example of an action that might be a safeguard to address such a self-interest threat is having the work reviewed by an appropriate reviewer, who is not an audit team member, from a network firm that is not a beneficiary of the loan.
<i>Deposits or Brokerage Accounts</i>	

<b>R511.6</b>	A firm, a network firm, an audit team member, or any of that individual's immediate family shall not have deposits or a brokerage account with an audit client that is a bank, broker or similar institution, unless the deposit or account is held under normal commercial terms.
<b>Loans and Guarantees with an Audit Client that is Not a Bank or Similar Institution</b>	
<b>R511.7</b>	<p>A firm, a network firm, an audit team member, or any of that individual's immediate family shall not accept a loan from, or have a borrowing guaranteed by, an audit client that is not a bank or similar institution, unless the loan or guarantee is immaterial to —</p> <p>(a) The firm, the network firm, or the individual receiving the loan or guarantee, as applicable; and</p> <p>(b) The client.</p>
<b>SECTION 520</b>	
<b>BUSINESS RELATIONSHIPS</b>	
<b>Introduction</b>	
520.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
520.2	A close business relationship with an audit client or its management might create a self-interest or intimidation threat. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirements and Application Material</b>	
<b>General</b>	
520.3 A1	This section contains references to the “materiality” of a financial interest and the “significance” of a business relationship. In determining whether such a financial interest is material to an individual, the combined net worth of the individual and the individual's immediate family members may be taken into account.
520.3 A2	<p>Examples of a close business relationship arising from a commercial relationship or common financial interest include —</p> <p>(a) Having a financial interest in a joint venture with either the client or a controlling owner, director or officer or other individual who performs senior managerial activities for that client;</p> <p>(b) Arrangements to combine one or more services or products of the firm or a network firm with one or more services or products of the client and to market the package with reference to both parties;</p>

	<p>(c) Arrangements under which the firm or a network firm sells, resells, distributes or markets the client's products or services, or the client sells, resells, distributes or markets the firm's or a network firm's products or services; and</p>
	<p>(d) Arrangements under which the firm or a network firm develops jointly with the client, products or solutions which one or both parties sell or license to third parties.</p>
520.3 A3	<p>An example that might create a close business relationship, depending on the facts and circumstances, is an arrangement under which the firm or a network firm licenses</p>

	products or solutions to or from a client.
<b>Firm, Network Firm, Audit Team Member or Immediate Family Business Relationships</b>	
<b>R520.4</b>	A firm, a network firm or an audit team member shall not have a close business relationship with an audit client or its management unless any financial interest is immaterial and the business relationship is insignificant to the client or its management and the firm, the network firm or the audit team member, as applicable.
520.4 A1	A self-interest or intimidation threat might be created if there is a close business relationship between the audit client or its management and the immediate family of an audit team member.
<b>Common Interests in Closely-Held Entities</b>	
<b>R520.5</b>	A firm, a network firm, an audit team member, or any of that individual's immediate family shall not have a business relationship involving the holding of an interest in a closely-held entity when an audit client or a director or officer of the client, or any group thereof, also holds an interest in that entity, unless — <ul style="list-style-type: none"> <li>(a) The business relationship is insignificant to the firm, the network firm, or the individual as applicable, and the client;</li> <li>(b) The financial interest is immaterial to the investor or group of investors; and</li> <li>(c) The financial interest does not give the investor, or group of investors, the ability to control the closely-held entity.</li> </ul>
<b>Buying Goods or Services</b>	
520.6 A1	The purchase of goods and services, including the licensing of technology from an audit client by a firm, a network firm, an audit team member, or any of that individual's immediate family does not usually create a threat to independence if the transaction is in the normal course of business and at arm's length. However, such transactions might be of such a nature and magnitude that they create a self-interest threat.
520.6 A2	Examples of actions that might eliminate such a self-interest threat include — <ul style="list-style-type: none"> <li>(a) Eliminating or reducing the magnitude of the transaction; and</li> <li>(b) Removing the individual from the audit team.</li> </ul>
<b>Providing, Selling, Reselling or Licensing Technology</b>	
520.7 A1	Where a firm or a network firm provides, sells, resells



	or licenses technology —	
		(a) To an audit client; or
	(b) To an entity that provides services using such technology to audit clients of the firm or network firm,	
	depending on the facts and circumstances, the requirements and application material in Section 600 apply.	
<b>SECTION 521</b>		
<b>FAMILY AND PERSONAL RELATIONSHIPS</b>		
<b>Introduction</b>		
521.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.	
521.2	Family or personal relationships with client personnel might create a self-interest, familiarity or intimidation threat. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.	
<b>Requirements and Application Material</b>		
<b>General</b>		
521.3 A1	A self-interest, familiarity or intimidation threat might be created by family and personal relationships between an audit team member and a director or officer or, depending on their role, certain employees of the audit client.	
521.3 A2	Factors that are relevant in evaluating the level of such threats include —	
	(a)	The individual's responsibilities on the audit team; and
	(b)	The role of the family member or other individual within the client, and the closeness of the relationship.
<b>Immediate Family of an Audit Team Member</b>		
521.4 A1	A self-interest, familiarity or intimidation threat is created when an immediate family member of an audit team member is an employee in a position to exert	

	significant influence over the client's financial position, financial performance or cash flows.
521.4 A2	Factors that are relevant in evaluating the level of such threats include — <p>(a) The position held by the immediate family member; and</p> <p>(b) The role of the audit team member.</p>
521.4 A3	An example of an action that might eliminate such a self-interest, familiarity or intimidation threat is removing the individual from the audit team.
521.4 A4	An example of an action that might be a safeguard to address such a self-interest, familiarity or intimidation threat is structuring the responsibilities of the audit team so that the audit team member does not deal with matters that are within the responsibility of the immediate family member.
<b>R521.5</b>	An individual shall not participate as an audit team member when any of that individual's immediate family —
	<p>(a) Is a director or officer of the audit client;</p> <p>(b) Is an employee in a position to exert significant influence over the preparation of the client's accounting records or the financial statements on which the firm will express an opinion; or</p> <p>(c) Was in such position during any period covered by the engagement or the financial statements.</p>
<b>Close Family of an Audit Team Member</b>	
521.6 A1	A self-interest, familiarity or intimidation threat is created when a close family member of an audit team member is — <p>(a) A director or officer of the audit client; or</p> <p>(b) An employee in a position to exert significant influence over the preparation of the client's accounting records or the financial statements on which the firm will express an opinion.</p>
521.6 A2	Factors that are relevant in evaluating the level of such threats include — <p>(a) The nature of the relationship between the audit team member and the close family member;</p> <p>(b) The position held by the close family member; and</p> <p>(c) The role of the audit team member.</p>
521.6 A3	An example of an action that might eliminate such a self-interest, familiarity or intimidation threat is removing the individual from the audit team.

521.6 A4	An example of an action that might be a safeguard to address such a self-interest, familiarity or intimidation threat is structuring the responsibilities of the audit team so that the audit team member does not deal with matters that are within the responsibility of the close family member.
<b>Other Close Relationships of an Audit Team Member</b>	
<b>R521.7</b>	An audit team member shall consult in accordance with firm policies and procedures if the audit team member has a close relationship with an individual who is not an immediate or close family member, but who is —  (a) A director or officer of the audit client; or  (b) An employee in a position to exert significant influence over the preparation of the client’s accounting records or the financial statements on which the firm will express an opinion.
521.7 A1	Factors that are relevant in evaluating the level of a self-interest, familiarity or intimidation threat created by such a relationship include —  (a) The nature of the relationship between the individual and the audit team member;  (b) The position the individual holds with the client; and  (c) The role of the audit team member.
521.7 A2	An example of an action that might eliminate such a self-interest, familiarity or intimidation threat is removing the individual from the audit team.
521.7 A3	An example of an action that might be a safeguard to address such a self-interest, familiarity or intimidation threat is structuring the responsibilities of the audit team so that the audit team member does not deal with matters that are within the responsibility of the individual with whom the audit team member has a close relationship.
<b>Relationships of Partners and Employees of the Firm</b>	
<b>R521.8</b>	Partners and employees of the firm shall consult in accordance with firm policies and procedures if they are aware of a personal or family relationship between —  (a) A partner or employee of the firm or network firm who is not an audit team member; and  (b) A director or officer of the audit client or an employee of the audit client in a position to exert significant influence over the preparation of the client’s accounting records or the financial statements on which the firm will express an opinion.
521.8 A1	Factors that are relevant in evaluating the level of a self-interest, familiarity or intimidation threat created by such a relationship include —

	<p>(a) The nature of the relationship between the partner or employee of the firm and the director or officer or employee of the client;</p> <p>(b) The degree of interaction of the partner or employee of the firm with the audit team;</p> <p>(c) The position of the partner or employee within the firm; and</p> <p>(d) The position the individual holds with the client.</p>
521.8 A2	<p>Examples of actions that might be safeguards to address such self-interest, familiarity or intimidation threats include —</p> <p>(a) Structuring the partner’s or employee’s responsibilities to reduce any potential influence over the audit engagement; and</p> <p>(b) Having an appropriate reviewer review the relevant audit work performed.</p>
<b>SECTION 522</b>	
<b>RECENT SERVICE WITH AN AUDIT CLIENT</b>

522.2	If an audit team member has recently served as a director or officer, or employee of the audit client, a self-interest, self-review or familiarity threat might be created. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirements and Application Material</b>	
<b>Service During Period Covered by the Audit Report</b>	
<b>R522.3</b>	<p>The audit team shall not include an individual who, during the period covered by the audit report —</p> <p>(a) Had served as a director or officer of the audit client; or</p> <p>(b) Was an employee in a position to exert significant influence over the preparation of the client’s accounting records or the financial statements on which the firm will express an opinion.</p>
<b>Service Prior to Period Covered by the Audit Report</b>	
522.4 A1	<p>A self-interest, self-review or familiarity threat might be created if, before the period covered by the audit report, an audit team member —</p> <p>(a) Had served as a director or officer of the audit client; or</p>

	<p>(b) Was an employee in a position to exert significant influence over the preparation of the client's accounting records or financial statements on which the firm will express an opinion.</p> <p>For example, a threat would be created if a decision made or work performed by the individual in the prior period, while employed by the client, is to be evaluated in the current period as part of the current audit engagement.</p>
522.4 A2	<p>Factors that are relevant in evaluating the level of such threats include —</p> <p>(a) The position the individual held with the client;</p> <p>(b) The length of time since the individual left the client; and</p> <p>(c) The role of the audit team member.</p>
522.4 A3	<p>An example of an action that might be a safeguard to address such a self-interest, self-review or familiarity threat is having an appropriate reviewer review the work performed by the audit team member.</p>
<b>SECTION 523</b>	
<b>SERVING AS A DIRECTOR OR OFFICER OF AN AUDIT CLIENT</b>	
<b>Introduction</b>	
523.1	<p>Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.</p>
523.2	<p>Serving as a director or officer of an audit client creates self-review and self-interest threats. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.</p>
<b>Requirements and Application Material</b>	
<b>Service as Director or Officer</b>	
<b>R523.3</b>	<p>A partner or employee of the firm or a network firm shall not serve as a director or officer of an audit client of the firm.</p>
<b>Service as Company Secretary</b>	
<b>R523.4</b>	<p>A partner or employee of the firm or a network firm shall not serve as Company Secretary for an audit client of the firm, unless —</p> <p>(a) This practice is specifically permitted under local law, professional rules or practice;</p> <p>(b) Management makes all relevant decisions; and</p> <p>(c) The duties and activities performed are limited to those of a routine and administrative nature, such as preparing minutes and maintaining statutory returns.</p>

523.4 A1	The position of Company Secretary has different implications in different jurisdictions. Duties might range from: administrative duties (such as personnel management and the maintenance of company records and registers) to duties as diverse as ensuring that the company complies with regulations or providing advice on corporate governance matters. Usually this position is seen to imply a close association with the entity. Therefore, a threat is created if a partner or employee of the firm or a network firm serves as Company Secretary for an audit client. (More information on providing non-assurance services to an audit client is set out in Section 600, <i>Provision of Non-assurance Services to an Audit Client</i> .)

<b>Requirements and Application Material</b>	
<b>All Audit Clients</b>	
524.3 A1	<p>A familiarity or intimidation threat might be created if any of the following individuals have been an audit team member or partner of the firm or a network firm:</p> <ul style="list-style-type: none"> <li>(a) A director or officer of the audit client;</li> <li>(b) An employee in a position to exert significant influence over the preparation of the client's accounting records or the financial statements on which the firm will express an opinion.</li> </ul>
<i>Former Partner or Audit Team Member Restrictions</i>	
<b>R524.4</b>	<p>The firm shall ensure that no significant connection remains between the firm or a network firm and —</p> <ul style="list-style-type: none"> <li>(a) A former partner who has joined an audit client of the firm; or</li> <li>(b) A former audit team member who has joined the audit client,</li> </ul> <p>if either has joined the audit client as —</p> <ul style="list-style-type: none"> <li>(i) A director or officer; or</li> </ul>

	<p>(ii) An employee in a position to exert significant influence over the preparation of the client's accounting records or the financial statements on which the firm will express an opinion.</p> <p>A significant connection remains between the firm or a network firm and the individual, unless —</p> <p>(a) The individual is not entitled to any benefits or payments from the firm or network firm that are not made in accordance with fixed pre-determined arrangements;</p> <p>(b) Any amount owed to the individual is not material to the firm or the network firm; and</p> <p>(c) The individual does not continue to participate or appear to participate in the firm's or the network firm's business or professional activities.</p>
524.4 A1	Even if the requirements of paragraph R524.4 are met, a familiarity or intimidation threat might still be created.
524.4 A2	A familiarity or intimidation threat might also be created if a former partner of the firm or network firm has joined an entity in one of the positions described in paragraph 524.3 A1 and the entity subsequently becomes an audit client of the firm.
524.4 A3	<p>Factors that are relevant in evaluating the level of such threats include —</p> <p>(a) The position the individual has taken at the client;</p> <p>(b) Any involvement the individual will have with the audit team;</p> <p>(c) The length of time since the individual was an audit team member or partner of the firm or network firm; and</p> <p>(d) The former position of the individual within the audit team, firm or network firm. An example is whether the individual was responsible for maintaining regular contact with the client's management or those charged with governance.</p>

<i>Audit Clients that are Public Interest Entities</i>	
<i>Key Audit Partners</i>

<b>R524.7</b>	<p>Subject to paragraph R524.8, if an individual who was the Senior or Managing Partner (Chief Executive or equivalent) of the firm joins an audit client that is a public interest entity as —</p> <p>(a) A director or officer; or</p> <p>(b) An employee in a position to exert significant influence over the preparation of the client’s accounting records or the financial statements on which the firm will express an opinion,</p> <p>independence is compromised, unless twelve months have passed since the individual was the Senior or Managing Partner (Chief Executive or equivalent)</p>

<b>TEMPORARY PERSONNEL ASSIGNMENTS</b>	
<b>Introduction</b>	
525.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
525.2	The loan of personnel to an audit client might create a self-review, advocacy or familiarity threat. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirements and Application Material</b>	
<b>General</b>	
525.3 A1	<p>Examples of actions that might be safeguards to address threats created by the loan of personnel by a firm or a network firm to an audit client include —</p> <p>(a) Conducting an additional review of the work performed by the loaned personnel might address a self-review threat;</p> <p>(b) Not including the loaned personnel as an audit team member might address a familiarity or advocacy threat; and</p> <p>(c) Not giving the loaned personnel audit responsibility for any function or activity that the personnel performed during the loaned personnel assignment might address a self-review threat.</p>

525.3 A2	When familiarity and advocacy threats are created by the loan of personnel by a firm or a network firm to an audit client, such that the firm or the network firm becomes too closely aligned with the views and interests of management, safeguards are often not available.
<b>R525.4</b>	<p>A firm or a network firm shall not loan personnel to an audit client unless the firm or network firm is satisfied that —</p> <p>(a) Such assistance is provided only for a short period of time;</p> <p>(b) Such personnel will not assume management responsibilities and the audit client will be responsible for directing and supervising the activities of such personnel;</p> <p>(c) Any threat to the independence of the firm or network firm arising from the professional services undertaken by such personnel is eliminated or safeguards are applied to reduce such threat to an acceptable level; and</p> <p>(d) Such personnel will not undertake or be involved in professional services that the firm or network firm is prohibited from performing by the Code.</p>
<b>SECTION 540</b>	
<b>LONG ASSOCIATION OF PERSONNEL (INCLUDING PARTNER ROTATION) WITH AN AUDIT CLIENT</b>	
<b>Introduction</b>	
540.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
540.2	When an individual is involved in an audit engagement over a long period of time, familiarity and self-interest threats might be created. This section sets out requirements and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirements and Application Material</b>	
<b>All Audit Clients</b>	
540.3 A1	Although an understanding of an audit client and its environment is fundamental to audit quality, a familiarity threat might be created as a result of an individual's long association as an audit team member with —

	<p>(a) The audit client and its operations;</p> <p>(b) The audit client's senior management; or</p> <p>(c) The financial statements on which the firm will express an opinion or the financial information which forms the basis of the financial statements.</p>
540.3 A2	A self-interest threat might be created as a result of an individual's concern about losing a longstanding client or an interest in maintaining a close personal relationship with a member of senior management or those charged with governance. Such a threat might influence the individual's judgment inappropriately.
540.3 A3	<p>Factors that are relevant to evaluating the level of such familiarity or self-interest threats include —</p> <p>(a) In relation to the individual —</p> <p>(i) The overall length of the individual's relationship with the client, including if such relationship existed while the individual was at a prior firm;</p> <p>(ii) How long the individual has been an engagement team member, and the nature of the roles performed;</p> <p>(iii) The extent to which the work of the individual is directed, reviewed and supervised by more senior personnel;</p> <p>(iv) The extent to which the individual, due to the individual's seniority, has the ability to influence the outcome of the audit, for example, by making key decisions or directing the work of other engagement team members;</p> <p>(v) The closeness of the individual's personal relationship with senior</p>

	<p>management or those charged with governance; and</p> <p>(vi) The nature, frequency and extent of the interaction between the individual and senior management or those charged with governance; and</p> <p>(b) In relation to the audit client —</p> <p>(i) The nature or complexity of the client’s accounting and financial reporting issues and whether they have changed;</p> <p>(ii) Whether there have been any recent changes in senior management or those charged with governance; and</p> <p>(iii) Whether there have been any structural changes in the client’s organisation which impact the nature, frequency and extent of interactions the individual might have with senior management or those charged with governance.</p>
540.3 A4	The combination of two or more factors might increase or reduce the level of the threats. For example, familiarity threats created over time by the increasingly close relationship between an individual and a member of the client’s senior management would be reduced by the departure of that member of the client’s senior management.
540.3 A5	An example of an action that might eliminate the familiarity and self-interest threats created by an individual being involved in an audit engagement over a long period of time would be rotating the individual off the audit team.
540.3 A6	<p>Examples of actions that might be safeguards to address such familiarity or self-interest threats include —</p> <p>(a) Changing the role of the individual on the audit team or the nature and extent</p>

	<p>of the tasks the individual performs;</p> <p>(b) Having an appropriate reviewer who was not an audit team member review the work of the individual; and</p> <p>(c) Performing regular independent internal or external quality reviews of the engagement.</p>
<b>R540.4</b>	<p>If a firm decides that the level of the threats created can only be addressed by rotating the individual off the audit team, the firm shall determine an appropriate period during which the individual shall not —</p> <p>(a) Be a member of the engagement team for the audit engagement;</p> <p>(b) Perform an engagement quality review, or a review consistent with the objective of an engagement quality review, for the engagement; or</p> <p>(c) Exert direct influence on the outcome of the audit engagement.</p> <p>The period shall be of sufficient duration to allow the familiarity and self-interest threats to be addressed. In the case of a public interest entity, paragraphs R540.5 to R540.20 also apply.</p>
<i>Audit Clients that are Public Interest Entities</i>	
<b>R540.5</b>	<p>Subject to paragraphs R540.7 to R540.9, in respect of an audit of a public interest entity, an individual shall not act in any of the following roles, or a combination of such roles, for a period of more than seven cumulative years (the “time on” period):</p> <p>(a) The engagement partner;</p> <p>(b) The individual appointed as responsible for performing the engagement quality review;</p> <p>(c) Any other key audit partner role.</p> <p>After the time-on period, the individual shall serve</p>

	a “cooling off” period in accordance with the provisions in paragraphs R540.11 to R540.19.
<b>R540.6</b>	In calculating the time-on period, the count of years shall not be restarted unless the individual ceases to act in any one of the roles in paragraph R540.5(a) to (c) for a minimum period. This minimum period is a consecutive period equal to at least the cooling-off period determined in accordance with paragraphs R540.11 to R540.13 as applicable to the role in which the individual served in the year immediately before ceasing such involvement.
540.6 A1	For example, an individual who served as engagement partner for four years followed by three years off can only act thereafter as a key audit partner on the same audit engagement for three further years (making a total of seven cumulative years). Thereafter, that individual is required to cool off in accordance with paragraph R540.14.
<b>R540.7</b>	As an exception to paragraph R540.5, key audit partners whose continuity is especially important to audit quality may, in rare cases due to unforeseen circumstances outside the firm’s control, and with the concurrence of those charged with governance, be permitted to serve an additional year as a key audit partner as long as the threat to independence can be eliminated or reduced to an acceptable level.
540.7 A1	For example, a key audit partner may remain in that role on the audit team for up to one additional year in circumstances where, due to unforeseen events, a required rotation was not possible, as might be the case due to serious illness of the intended engagement partner. In such circumstances, this will involve the firm discussing with those charged with governance the reasons why the planned rotation cannot take place and the need for any safeguards to reduce any threat created.
<b>R540.8</b>	If an audit client becomes a public interest entity, a firm shall take into account the length of time an individual has served the audit client as a key audit partner before the client becomes a public interest entity in determining the timing of the rotation. If the individual has served the audit client as a key

	<p>audit partner for a period of five cumulative years or less when the client becomes a public interest entity, the number of years the individual may continue to serve the client in that capacity before rotating off the engagement is seven years less the number of years already served. As an exception to paragraph R540.5, if the individual has served the audit client as a key audit partner for a period of six or more cumulative years when the client becomes a public interest entity, the individual may continue to serve in that capacity with the concurrence of those charged with governance for a maximum of two additional years before rotating off the engagement.</p>
<b>R540.9</b>	<p>When a firm has only a few people with the necessary knowledge and experience to serve as a key audit partner on the audit of a public interest entity, rotation of key audit partners might not be possible. As an exception to paragraph R540.5, if an independent regulatory body in the relevant jurisdiction has provided an exemption from partner rotation in such circumstances, an individual may remain a key audit partner for more than seven years, in accordance with such exemption. This is provided that the independent regulatory body has specified other requirements which are to be applied, such as the length of time that the key audit partner may be exempted from rotation or a regular independent external review.</p>
<i>Other Considerations Relating to the Time-on Period</i>	
<b>R540.10</b>	<p>In evaluating the threats created by an individual's long association with an audit engagement, a firm shall give particular consideration to the roles undertaken and the length of an individual's association with the audit engagement prior to the individual becoming a key audit partner.</p>
540.10 A1	<p>There might be situations where the firm, in applying the conceptual framework, concludes that it is not appropriate for an individual who is a key audit partner to continue in that role even though the length of time served as a key audit partner is less than seven years.</p>
<i>Cooling-off Period</i>	
<b>R540.11</b>	<p>If the individual acted as the engagement partner for seven cumulative years, the cooling-off period</p>

	shall be five consecutive years.
<b>R540.12</b>	Where the individual has been appointed as responsible for the engagement quality review and has acted in that capacity for seven cumulative years, the cooling-off period shall be three consecutive years.
<b>R540.13</b>	If the individual has acted as a key audit partner other than in the capacities set out in paragraphs R540.11 and R540.12 for seven cumulative years, the cooling-off period shall be two consecutive years.
540.13 A1	The partner rotation requirements in this section are distinct from, and do not modify, the cooling-off period required by SSQM 2 as a condition for eligibility before the engagement partner can assume the role of engagement quality reviewer (see paragraph 325.8 A4).
<i>Service in a Combination of Key Audit Partner Roles</i>	
<b>R540.14</b>	If the individual acted in a combination of key audit partner roles and served as the engagement partner for four or more cumulative years, the cooling-off period shall be five consecutive years.
<b>R540.15</b>	Subject to paragraph R540.16(a), if the individual acted in a combination of key audit partner roles and served as the key audit partner responsible for the engagement quality review for four or more cumulative years, the cooling-off period shall be three consecutive years.
<b>R540.16</b>	<p>If an individual has acted in a combination of engagement partner and engagement quality reviewer roles for four or more cumulative years during the time-on period, the cooling-off period shall —</p> <p>(a) As an exception to paragraph R540.15, be five consecutive years where the individual has been the engagement partner for three or more years; or</p> <p>(b) Be three consecutive years in the case of any other combination.</p>
<b>R540.17</b>	If the individual acted in any combination of key audit partner roles other than those addressed in paragraphs R540.14 to R540.16, the cooling-off



	period shall be two consecutive years.
<i>Service at a Prior Firm</i>	
<b>R540.18</b>	In determining the number of years that an individual has been a key audit partner as set out in paragraph R540.5, the length of the relationship shall, where relevant, include time while the individual was a key audit partner on that engagement at a prior firm.
<b>[Paragraph R540.19 is intentionally left blank]</b>	
<i>Restrictions on Activities During the Cooling-off Period</i>	
<b>R540.20</b>	<p>For the duration of the relevant cooling-off period, the individual shall not —</p> <ul style="list-style-type: none"> <li>(a) Be an engagement team member or perform an engagement quality review, or a review consistent with the objective of an engagement quality review for the audit engagement;</li> <li>(b) Consult with the engagement team or the client regarding technical or industry-specific issues, transactions or events affecting the audit engagement (other than discussions with the engagement team limited to work undertaken or conclusions reached in the last year of the individual’s time-on period where this remains relevant to the audit);</li> <li>(c) Be responsible for leading or coordinating the professional services provided by the firm or a network firm to the audit client, or overseeing the relationship of the firm or a network firm with the audit client; or</li> <li>(d) Undertake any other role or activity not referred to above with respect to the audit client, including the provision of non-assurance services that would result in the individual — <ul style="list-style-type: none"> <li>(i) Having significant or frequent interaction with senior</li> </ul> </li> </ul>

	<p>management or those charged with governance; or</p> <p>(ii) Exerting direct influence on the outcome of the audit engagement.</p>
540.20 A1	The provisions of paragraph R540.20 are not intended to prevent the individual from assuming a leadership role in the firm or a network firm, such as that of the Senior or Managing Partner (Chief Executive or equivalent).
<i>Effective Date and Transitional Provision</i>	
540.21	Subject to the transitional provision below, paragraphs 540.1 to 540.20 A1 are effective for audits of financial statements for periods beginning on or after 15 December 2018.
	For audits of financial statements for periods beginning prior to 15 December 2023, three consecutive years is substituted for the cooling-off period of five consecutive years specified in paragraphs R540.11, R540.14 and R540.16(a) provided that the applicable time-on period does not exceed seven years.
	For audits of financial statements for periods beginning on or after 15 December 2023, three consecutive years is substituted for the cooling-off period of five consecutive years specified in paragraphs R540.11, R540.14 and R540.16(a) provided that the applicable cooling-off period starts prior to 15 December 2023 and the applicable time-on period does not exceed seven years.
<b>SECTION 600</b>	
<b>PROVISION OF NON-ASSURANCE SERVICES TO AN AUDIT CLIENT</b>	
<b>Introduction</b>	
600.1	Firms are required to comply with the fundamental principles, be independent, and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
600.2	Firms and network firms might provide a range of non-assurance services to their audit clients, consistent with their skills and expertise. Providing

	non-assurance services to audit clients might create threats to compliance with the fundamental principles and threats to independence.
600.3	This section sets out requirements and application material relevant to applying the conceptual framework to identify, evaluate and address threats to independence when providing non-assurance services to audit clients. The subsections that follow set out specific requirements and application material that are relevant when a firm or a network firm provides certain types of non-assurance services to audit clients and indicate the types of threats that might be created as a result.
600.4	Some subsections include requirements that expressly prohibit a firm or a network firm from providing certain services to an audit client because the threats created cannot be eliminated and safeguards are not capable of being applied to reduce the threats to an acceptable level.
600.5	New business practices, the evolution of financial markets and changes in technology are some developments that make it impossible to draw up an all-inclusive list of non-assurance services that firms and network firms might provide to an audit client. The conceptual framework and the general provisions in this section apply when a firm proposes to a client to provide a non-assurance service for which there are no specific requirements and application material.
600.6	The requirements and application material in this section apply where a firm or a network firm —
	(a) Uses technology to provide a non-assurance service to an audit client; or
	(b) Provides, sells,

	resells or licenses technology resulting in the provision of a non-assurance service by the firm or a network firm —
	(i) To an audit client; or
	(ii) To an entity that provides services using such technology to audit clients of the firm or network firm.
<b>Requirements and Application Material</b>	
<b>General</b>	
<i>Non-Assurance Services Provisions in Laws or Regulations</i>	
600.7 A1	Paragraphs R100.6 to 100.7 A1 set out requirements and application material relating to compliance with the Code. If there are laws and regulations in a jurisdiction relating to the provision of non-assurance services to audit clients that differ from or go beyond those set out in this section, firms providing non-assurance services to which such provisions apply need to be aware of those differences and comply with the more stringent provisions.
<i>Risk of Assuming Management Responsibilities when Providing a Non-Assurance Service</i>	
600.8 A1	When a firm or a network firm provides a non-assurance service to an audit client, there is a risk that the firm or network firm will assume a management responsibility unless the firm or network firm is satisfied that the requirements in paragraph R400.21 have been complied with.
<i>Accepting an Engagement to Provide a Non-Assurance Service</i>	

<b>R600.9</b>	Before a firm or a network firm accepts an engagement to provide a non-assurance service to an audit client, the firm shall apply the conceptual framework to identify, evaluate and address any threat to independence that might be created by providing that service.
<i>Identifying and Evaluating Threats</i>	
All Audit Clients	
600.10 A1	A description of the categories of threats that might arise when a firm or a network firm provides a non-assurance service to an audit client is set out in paragraph 120.6 A3.
600.10 A2	<p>Factors that are relevant in identifying the different threats that might be created by providing a non-assurance service to an audit client, and evaluating the level of such threats include —</p> <ul style="list-style-type: none"> <li data-bbox="818 863 1414 930">(a) The nature, scope, intended use and purpose of the service;</li> <li data-bbox="818 968 1414 1066">(b) The manner in which the service will be provided, such as the personnel to be involved and their location;</li> <li data-bbox="1084 1104 1414 1371">(c) The client's dependency on the service, including the frequency with which the service will be provided;</li> <li data-bbox="1084 1409 1414 1604">(d) The legal and regulatory environment in which the service is provided;</li> <li data-bbox="1084 1642 1414 1740">(e) Whether the client is a public interest entity;</li> <li data-bbox="1084 1778 1414 1845">(f) The level of expertise of the</li> </ul>

	<p>amounts or treatment for those matters reflected in the financial statements;</p> <p>(i) The nature and extent of the impact of the service, if any, on the systems that generate information that forms a significant part of the client's —</p> <p>(i) Accounting records or financial statements on which the firm will express an opinion; and</p> <p>(ii) Internal controls over financial reporting;</p> <p>(j) The degree of reliance that will be placed on the outcome of the service as part of the audit; and</p>
	<p>(k) The fee relating to the provision of the non-assurance service.</p>
600.10 A3	Subsections 601 to 610 include examples of additional factors that are relevant in identifying threats to independence created by providing

	certain non-assurance services, and evaluating the level of such threats.
Materiality in relation to financial statements	
600.11 A1	Materiality is a factor that is relevant in evaluating threats created by providing a non-assurance service to an audit client. Subsections 601 to 610 refer to materiality in relation to an audit client's financial statements. The concept of materiality in relation to an audit is addressed in SSA 320, <i>Materiality in Planning and Performing an Audit</i> , and in relation to a review in SSRE 2400 (Revised), <i>Engagements to Review Historical Financial Statements</i> . The determination of materiality involves the exercise of professional judgment and is impacted by both quantitative and qualitative factors. It is also affected by perceptions of the financial information needs of users.
600.11 A2	Where the Code expressly prohibits the provision of a non-assurance service to an audit client, a firm or a network firm is not permitted to provide that service, regardless of the materiality of the outcome or results of the non-assurance service on the financial statements on which the firm will express an opinion.
Providing advice and recommendations	
600.12 A1	Providing advice and recommendations might create a self-review threat. Whether providing advice and recommendations creates a self-review threat involves making the determination set out in paragraph R600.15. Where the audit client is not a public interest entity and a self-review threat is identified, the firm is required to apply the conceptual framework to evaluate and address the threat. If the audit client is a public interest entity, paragraphs R600.17 and R600.18 apply.
Multiple non-assurance services provided to the same audit client	
<b>R600.13</b>	When a firm or a network firm provides multiple non-assurance services to an audit client, the firm shall consider whether, in addition to the threats created by each service individually, the combined effect of such services creates or impacts threats to independence.
	In addition to paragraph 600.10 A2, factors that are



600.13 A1	<p>relevant in a firm's evaluation of the level of threats to independence created where multiple non-assurance services are provided to an audit client might include whether —</p> <p>(a) The combined effect of providing multiple services increases the level of threat created by each service assessed individually; and</p> <p>(b) The combined effect of providing multiple services increases the level of any threat arising from the overall relationship with the audit client.</p>
Self-review threats	
600.14 A1	<p>When a firm or a network firm provides a non-assurance service to an audit client, there might be a risk of the firm auditing its own or the network firm's work, thereby giving rise to a self-review threat. A self-review threat is the threat that a firm or a network firm will not appropriately evaluate the results of a previous judgment made or an activity performed by an individual within the firm or network firm as part of a non-assurance service on which the audit team will rely when forming a judgment as part of an audit.</p>
<b>R600.15</b>	<p>Before providing a non-assurance service to an audit client, a firm or a network firm shall determine whether the provision of that service might create a self-review threat by evaluating whether there is a risk that —</p> <p>(a) The results of the service will form part of or affect the accounting records, the internal controls over financial reporting, or the financial statements on which the firm will express an opinion; and</p> <p>(b) In the course of the audit of those financial statements on which the firm will express an opinion, the audit team will evaluate or rely on any judgments made or activities performed by the firm or network firm when providing the service.</p>

Audit Clients that are Public Interest Entities	
600.16 A1	When the audit client is a public interest entity, stakeholders have heightened expectations regarding the firm's independence. These heightened expectations are relevant to the reasonable and informed third party test used to evaluate a self-review threat created by providing a non-assurance service to an audit client that is a public interest entity.
600.16 A2	Where the provision of a non-assurance service to an audit client that is a public interest entity creates a self-review threat, that threat cannot be eliminated, and safeguards are not capable of being applied to reduce that threat to an acceptable level.
Self-review threats	
<b>R600.17</b>	A firm or a network firm shall not provide a non-assurance service to an audit client that is a public interest entity if the provision of that service might create a self-review threat in relation to the audit of the financial statements on which the firm will express an opinion. (Ref: Paras. 600.14 A1 and R600.15).
Providing advice and recommendations	
<b>R600.18</b>	As an exception to paragraph R600.17, a firm or a network firm may provide advice and recommendations to an audit client that is a public interest entity in relation to information or matters arising in the course of an audit provided that the firm — <ul style="list-style-type: none"> <li>(a) Does not assume a management responsibility (Ref: Paras. R400.20 and R400.21); and</li> <li>(b) Applies the conceptual framework to identify, evaluate and address threats, other than self-review threats, to independence that might be created by the provision of that advice.</li> </ul>
600.18 A1	Examples of advice and recommendations that might be provided in relation to information or matters arising in the course of an audit include — <ul style="list-style-type: none"> <li>(a) Advising on accounting and financial</li> </ul>

	<p>reporting standards or policies and financial statement disclosure requirements;</p> <p>(b) Advising on the appropriateness of financial and accounting control and the methods used in determining the stated amounts in the financial statements and related disclosures;</p> <p>(c) Proposing adjusting journal entries arising from audit findings;</p> <p>(d) Discussing findings on internal controls over financial reporting and processes and recommending improvements;</p> <p>(e) Discussing how to resolve account reconciliation problems; and</p> <p>(f) Advising on compliance with group accounting policies.</p>
<i>Addressing Threats</i>	
All Audit Clients	
600.19 A1	Paragraphs R120.10 to 120.10 A2 include a requirement and application material that are relevant when addressing threats to independence, including a description of safeguards.
600.19 A2	Threats to independence created by providing a non-assurance service or multiple services to an audit client vary depending on the facts and circumstances of the audit engagement and the nature of the service. Such threats might be addressed by applying safeguards or by adjusting the scope of the proposed service.
600.19 A3	<p>Examples of actions that might be safeguards to address such threats include —</p> <p>(a) Using professionals who are not audit team members to perform the service;</p> <p>(b) Having an appropriate reviewer who was not involved in providing the service review the audit work or</p>

600.20 A1	Paragraphs 400.40 A1 and 400.40 A2 are relevant to a firm's communication with those charged with governance in relation to the provision of non-assurance services.
Audit Clients that are Public Interest Entities	
600.21 A1	Paragraphs R600.22 to R600.24 require a firm to communicate with those charged with governance of a public interest entity before the firm or network firm provides non-assurance services to entities within the corporate structure of which the public interest entity forms part that might create threats to the firm's independence from the public interest entity. The purpose of the communication is to enable those charged with governance of the public interest entity to have effective oversight of the independence of the firm that audits the financial statements of that public interest entity.
600.21 A2	To facilitate compliance with such requirements, a firm might agree with those charged with governance of the public interest entity a process that addresses when and with whom the firm is to communicate. Such a process might —

	<p>(a) Establish the procedure for the provision of information about a proposed non-assurance service which might be on an individual engagement basis, under a general policy, or on any other agreed basis;</p> <p>(b) Identify the entities to which the process would apply, which might include other public interest entities within the corporate structure;</p> <p>(c) Identify any services that can be provided to the entities identified in paragraph R600.22 without specific approval of those charged with governance if they agree as a general policy that these services are not prohibited under this section and would not create threats to the firm's independence or, if any such threats are created, they would be at an acceptable level;</p> <p>(d) Establish how those charged with governance of multiple public interest entities within the same corporate structure have determined that authority for approving services is to be allocated;</p> <p>(e) Establish a procedure to be followed where the provision of information necessary for those charged with governance to evaluate whether a proposed service might create a threat to the firm's independence is prohibited or limited by professional standards, laws or regulations, or might result in the disclosure of sensitive or confidential information; or</p> <p>(f) Specify how any issues not covered by the process might be resolved.</p>
<b>R600.22</b>	Before a firm that audits the financial statements of a public interest entity, or a network firm accepts an engagement to provide a non-assurance service

	<p>to —</p> <ul style="list-style-type: none"> <li>(A) That public interest entity;</li> <li>(B) Any entity that controls, directly or indirectly, that public interest entity; or</li> <li>(C) Any entity that is controlled directly or indirectly by that public interest entity,</li> </ul> <p>the firm shall, unless already addressed when establishing a process agreed with those charged with governance —</p> <ul style="list-style-type: none"> <li>(a) Inform those charged with governance of the public interest entity that the firm has determined that the provision of the service — <ul style="list-style-type: none"> <li>(i) Is not prohibited; and</li> <li>(ii) Will not create a threat to the firm’s independence as auditor of the public interest entity or that any identified threat is at an acceptable level or, if not, will be eliminated or reduced to an acceptable level; and</li> </ul> </li> <li>(b) Provide those charged with governance of the public interest entity with information to enable them to make an informed assessment about the impact of the provision of the service on the firm’s independence.</li> </ul>

**REPORTS ON SPECIAL PURPOSE FINANCIAL STATEMENTS THAT INCLUDE A RESTRICTION ON USE AND DISTRIBUTION (AUDIT AND REVIEW ENGAGEMENTS)**

**Introduction**

800.1 Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.

800.2 This section sets out certain modifications to Part 4A which are permitted in certain circumstances involving audits of special purpose financial statements where the report includes a restriction on use and distribution. In this section, an engagement to issue a restricted use and distribution report in the circumstances set out in paragraph R800.3 is referred to as an “eligible audit engagement”.

**Requirements and Application Material**

**General**

**R800.3** When a firm intends to issue a report on an audit of special purpose financial statements which includes a restriction on use and distribution, the independence requirements set out in Part 4A shall be eligible for the modifications that are permitted by this section, but only if —

- (a) The firm communicates with the intended users of the report regarding the modified independence requirements that are to be applied in providing the service; and
- (b) The intended users of the report understand the purpose and limitations of the report and explicitly agree to the application of the modifications.

800.3 A1 The intended users of the report might obtain an understanding of the purpose and limitations of the report by participating, either directly, or indirectly through a representative who has authority to act for the intended users, in establishing the nature and scope of the engagement. In either case, this participation helps the firm to communicate with intended users about independence matters,

	including the circumstances that are relevant to applying the conceptual framework. It also allows the firm to obtain the agreement of the intended users to the modified independence requirements.
<b>R800.4</b>	Where the intended users are a class of users who are not specifically identifiable by name at the time the engagement terms are established, the firm shall subsequently make such users aware of the modified independence requirements agreed to by their representative.
800.4 A1	For example, where the intended users are a class of users such as lenders in a syndicated loan arrangement, the firm might describe the modified independence requirements in an engagement letter to the representative of the lenders. The representative might then make the firm's engagement letter available to the members of the group of lenders to meet the requirement for the firm to make such users aware of the modified independence requirements agreed to by the representative.
<b>R800.5</b>	When the firm performs an eligible audit engagement, any modifications to Part 4A shall be limited to those set out in paragraphs R800.7 to R800.14. The firm shall not apply these modifications when an audit of financial statements is required by law or regulation.
<b>R800.6</b>	If the firm also issues an audit report that does not include a restriction on use and distribution for the same client, the firm shall apply Part 4A to that audit engagement.
<b>Public Interest Entities</b>	
<b>R800.7</b>	When the firm performs an eligible audit engagement, the firm does not need to apply the independence requirements set out in Part 4A that apply only to public interest entity audit engagements.
<b>Related Entities</b>	
<b>R800.8</b>	When the firm performs an eligible audit engagement, references to "audit client" in Part 4A do not need to include its related entities. However, when the audit team knows or has reason to believe that a relationship or circumstance involving a related entity of the client is relevant to the

	evaluation of the firm's independence of the client, the audit team shall include that related entity when identifying, evaluating and addressing threats to independence.
<b>Networks and Network Firms</b>	
<b>R800.9</b>	When the firm performs an eligible audit engagement, the specific requirements regarding network firms set out in Part 4A do not need to be applied. However, when the firm knows or has reason to believe that threats to independence are created by any interests and relationships of a network firm, the firm shall evaluate and address any such threat.
<b>Financial Interests, Loans and Guarantees, Close Business Relationships, and Family and Personal Relationships</b>	
<b>R800.10</b>	<p>When the firm performs an eligible audit engagement —</p> <p>(a) The relevant provisions set out in Sections 510, 511, 520, 521, 522, 524 and 525 need apply only to the members of the engagement team, their immediate family members and, where applicable, close family members;</p> <p>(b) The firm shall identify, evaluate and address any threats to independence created by interests and relationships, as set out in Sections 510, 511, 520, 521, 522, 524 and 525, between the audit client and the following audit team members:</p> <p>(i) Those who provide consultation regarding technical or industry specific issues, transactions or events; and</p> <p>(ii) Those who perform an engagement quality review, or a review consistent with the objective of an engagement quality review, for the engagement; and</p> <p>(c) The firm shall evaluate and address any threats that the engagement team has</p>



	reason to believe are created by interests and relationships between the audit client and others within the firm who can directly influence the outcome of the audit engagement.
800.10 A1	Others within a firm who can directly influence the outcome of the audit engagement include those who recommend the compensation, or who provide direct supervisory, management or other oversight, of the audit engagement partner in connection with the performance of the audit engagement including those at all successively senior levels above the engagement partner through to the individual who is the firm's Senior or Managing Partner (Chief Executive or equivalent).
<b>R800.11</b>	When the firm performs an eligible audit engagement, the firm shall evaluate and address any threats that the engagement team has reason to believe are created by financial interests in the audit client held by individuals, as set out in paragraphs R510.4(c) and (d), R510.5, R510.7 and 510.10 A5 and A9.
<b>R800.12</b>	When the firm performs an eligible audit engagement, the firm, in applying the provisions set out in paragraphs R510.4(a), R510.6 and R510.7 to interests of the firm, shall not hold a material direct or a material indirect financial interest in the audit client.
<b>Employment with an Audit Client</b>	
<b>R800.13</b>	When the firm performs an eligible audit engagement, the firm shall evaluate and address any threats created by any employment relationships as set out in paragraphs 524.3 A1 to 524.5 A3.
<b>Providing Non-Assurance Services</b>	
<b>R800.14</b>	If the firm performs an eligible audit engagement and provides a non-assurance service to the audit client, the firm shall comply with Sections 410 to 430 and Section 600, including its subsections, subject to paragraphs R800.7 to R800.9.

<b>SECTION 900</b>	
<b>APPLYING THE CONCEPTUAL FRAMEWORK TO INDEPENDENCE FOR ASSURANCE ENGAGEMENTS OTHER THAN AUDIT AND REVIEW ENGAGEMENTS</b>	
<b>Introduction</b>	
<b>General</b>	
900.1	<p>This Part applies to assurance engagements other than audit engagements and review engagements. Examples of such engagements include —</p> <p>(a) Assurance on an entity’s key performance indicators;</p> <p>(b) Assurance on an entity’s compliance with law or regulation;</p>

	<p>(c) Assurance on performance criteria, such as value for money, achieved by a public sector body;</p> <p>(d) Assurance on the effectiveness of an entity's system of internal control;</p> <p>(e) Assurance on an entity's non-financial information, for example, environmental, social and governance disclosures, including greenhouse gas statement; and</p> <p>(f) An audit of specific elements, accounts or items of a financial statement.</p>
900.2	In this Part, the term "public accountant" refers to individual public accountants and their firms.
900.3	<p>SSQM 1 requires a firm to design, implement and operate a system of quality management for assurance engagements performed by the firm. As part of this system of quality management, SSQM 1 requires the firm to establish quality objectives that address the fulfilment of responsibilities in accordance with relevant ethical requirements, including those related to independence. Under SSQM 1, relevant ethical requirements are those related to the firm, its personnel and, when applicable, others subject to the independence requirements to which the firm and the firm's engagements are subject. In addition, Singapore Standards on Assurance Engagements (SSAEs) and SSAs establish responsibilities for engagement partners and engagement teams at the level of the engagement. The allocation of responsibilities within a firm will depend on its size, structure and organisation. Many of the provisions of Part 4B do not prescribe the specific responsibility of individuals within the firm for actions related to independence, instead referring to "firm" for ease of reference. A firm assigns operational responsibility for compliance with independence requirements to an individual(s) in accordance with SSQM 1. Additionally, an individual professional accountant remains responsible for compliance with any provisions that apply to that accountant's activities, interests or relationships.</p>

900.4	<p>Independence is linked to the principles of objectivity and integrity. It comprises —</p> <p>(a) Independence of mind — the state of mind that permits the expression of a conclusion without being affected by influences that compromise professional judgment, thereby allowing an individual to act with integrity, and exercise objectivity and professional scepticism;</p> <p>(b) Independence in appearance — the avoidance of facts and circumstances that are so significant that a reasonable and informed third party would be likely to conclude that a firm’s or an assurance team member’s integrity, objectivity or professional scepticism has been compromised.</p> <p>In this Part, references to an individual or firm being “independent” mean that the individual or firm has complied with the provisions of this Part.</p>
900.5	<p>When performing assurance engagements, the Code requires firms to comply with the fundamental principles and be independent. This Part sets out specific requirements and application material on how to apply the conceptual framework to maintain independence when performing assurance engagements other than audit or review engagements. The conceptual framework set out in Section 120 applies to independence as it does to the fundamental principles set out in Section 110.</p>
900.6	<p>This Part describes —</p> <p>(a) Facts and circumstances, including professional activities, interests and relationships, that create or might create threats to independence;</p> <p>(b) Potential actions, including safeguards, that might be appropriate to address any such threats; and</p> <p>(c) Some situations where the threats</p>

	cannot be eliminated or there can be no safeguards to reduce the threats to an acceptable level.
<b>Description of Assurance Engagements</b>	
900.7	In an assurance engagement, the firm aims to obtain sufficient appropriate evidence in order to express a conclusion designed to enhance the degree of confidence of the intended users other than the responsible party about the subject matter information. SSAE 3000 (Revised) describes the elements and objectives of an assurance engagement conducted under that Standard, and the Assurance Framework provides a general description of assurance engagements. An assurance engagement might either be an attestation engagement or a direct engagement.
900.8	In this Part, the term “assurance engagement” refers to assurance engagements other than audit engagements or review engagements.
<b>Reports that Include a Restriction on Use and Distribution</b>	
900.9	An assurance report might include a restriction on use and distribution. If it does and the conditions set out in Section 990 are met, then the independence requirements in this Part may be modified as provided in Section 990.
<b>Audit and Review Engagements</b>	
900.10	Independence standards for audit and review engagements are set out in Part 4A — <i>Independence for Audit and Review Engagements</i> . If a firm performs both an assurance engagement and an audit or review engagement for the same client, the requirements in Part 4A continue to apply to the firm, a network firm and the audit or review team members.
<b>Requirements and Application Material</b>	
<b>General</b>	
<b>R900.11</b>	A firm performing an assurance engagement shall be independent of the assurance client.
900.11 A1	For the purposes of this Part, the assurance client in an assurance engagement is the responsible party and also, in an attestation engagement, the party taking responsibility for the subject matter

	information (who might be the same as the responsible party).
900.11 A2	The roles of the parties involved in an assurance engagement might differ and affect the application of the independence provisions in this Part. In the majority of attestation engagements, the responsible party and the party taking responsibility for the subject matter information are the same. This includes those circumstances where the responsible party involves another party to measure or evaluate the underlying subject matter against the criteria (the measurer or evaluator) where the responsible party takes responsibility for the subject matter information as well as the underlying subject matter. However, the responsible party or the engaging party might appoint another party to prepare the subject matter information on the basis that this party is to take responsibility for the subject matter information. In this circumstance, the responsible party and the party responsible for the subject matter information are both assurance clients for the purposes of this Part.
900.11 A3	In addition to the responsible party and, in an attestation engagement, the party taking responsibility for the subject matter information, there might be other parties in relation to the engagement. For example, there might be a separate engaging party or a party who is a measurer or evaluator other than the party taking responsibility for the subject matter information. In these circumstances, applying the conceptual framework requires the public accountant to identify and evaluate threats to the fundamental principles created by any interests or relationships with such parties, including whether any conflicts of interest might exist as described in Section 310.
<b>R900.12</b>	A firm shall apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence in relation to an assurance engagement.
<b>Prohibition on Assuming Management Responsibilities</b>	
<b>R900.13</b>	A firm shall not assume a management responsibility related to the underlying subject matter and, in an attestation engagement, the subject matter information of an assurance

	<p>engagement provided by the firm. If the firm assumes a management responsibility as part of any other service provided to the assurance client, the firm shall ensure that the responsibility is not related to the underlying subject matter and, in an attestation engagement, the subject matter information of the assurance engagement provided by the firm.</p>
900.13 A1	<p>Management responsibilities involve controlling, leading and directing an entity, including making decisions regarding the acquisition, deployment and control of human, financial, technological, physical and intangible resources.</p>
900.13 A2	<p>When a firm assumes a management responsibility related to the underlying subject matter and, in an attestation engagement, the subject matter information of an assurance engagement, self-review, self-interest and familiarity threats are created. Assuming a management responsibility might create an advocacy threat because the firm becomes too closely aligned with the views and interests of management.</p>
900.13 A3	<p>Determining whether an activity is a management responsibility depends on the circumstances and requires the exercise of professional judgment. Examples of activities that would be considered a management responsibility include —</p> <ul style="list-style-type: none"> <li>(a) Setting policies and strategic direction;</li> <li>(b) Hiring or dismissing employees;</li> <li>(c) Directing and taking responsibility for the actions of employees in relation to the employees' work for the entity;</li> <li>(d) Authorising transactions;</li> <li>(e) Controlling or managing bank accounts or investments;</li> <li>(f) Deciding which recommendations of the firm or other third parties to implement;</li> <li>(g) Reporting to those charged with</li> </ul>

	<p>governance on behalf of management; and</p> <p>(h) Taking responsibility for designing, implementing, monitoring and maintaining internal control.</p>
<p>900.13 A4</p>	<p>Examples of IT systems services that result in the assumption of a management responsibility in relation to the underlying subject matter and, in an attestation engagement, the subject matter information of an assurance engagement, include where a firm —</p> <p>(a) Stores data or manages (directly or indirectly) the hosting of data related to the underlying subject matter or subject matter information. Such services include —</p> <p>(i) Acting as the only access to the data or records related to the underlying subject matter or subject matter information;</p> <p>(ii) Taking custody of or storing the data or records</p>



related to the underlying subject matter or subject matter information such that the assurance client's data or records are otherwise incomplete; and

(iii) Providing electronic security or back-up services, such as business continuity or a disaster recovery function, for the assurance client's data or records related to the underlying subject matter or subject matter information; and

(b) Operates, maintains, or monitors an assurance client's IT systems, network or website related to the underlying subject matter or

	subject matter information.
900.13 A5	The collection, receipt, transmission and retention of data provided by an assurance client in the course of an assurance engagement or to enable the provision of a permissible non-assurance service to the assurance client does not result in an assumption of management responsibility.
900.13 A6	Subject to compliance with paragraph R900.14, providing advice and recommendations to assist the management of an assurance client in discharging its responsibilities is not assuming a management responsibility.
<b>R900.14</b>	<p>When performing a professional activity for an assurance client that is related to the underlying subject matter and, in an attestation engagement, the subject matter information of the assurance engagement, the firm shall be satisfied that client management makes all related judgments and decisions that are the proper responsibility of management. This includes ensuring that the client's management —</p> <p>(a) Designates an individual who possesses suitable skill, knowledge and experience to be responsible at all times for the client's decisions and to oversee the activities. Such an individual, preferably within senior management, would understand —</p> <p>(i) The objectives, nature and results of the activities; and</p> <p>(ii) The respective client and firm responsibilities.</p> <p>However, the individual is not required to possess the expertise to perform or re-perform the activities.</p>

	<p>(b) Provides oversight of the activities and evaluates the adequacy of the results of the activity performed for the client’s purpose; and</p> <p>(c) Accepts responsibility for the actions, if any, to be taken arising from the results of the activities.</p>
900.14 A1	When technology is used in performing a professional activity for an assurance client, the requirements in paragraphs R900.13 and R900.14 apply regardless of the nature or extent of such use of the technology.
<i>Multiple Responsible Parties and Parties Taking Responsibility for the Subject Matter Information</i>	
900.15 A1	<p>In some assurance engagements, whether an attestation engagement or direct engagement, there might be several responsible parties or, in an attestation engagement, several parties taking responsibility for the subject matter information. In determining whether it is necessary to apply the provisions in this Part to each individual responsible party or each individual party taking responsibility for the subject matter information in such engagements, the firm may take into account certain matters. These matters include whether an interest or relationship between the firm, or an assurance team member, and a particular responsible party or party taking responsibility for the subject matter information would create a threat to independence that is not trivial and inconsequential in the context of the subject matter information. This determination will take into account factors such as —</p> <p>(a) The materiality of the underlying subject matter or subject matter information for which the particular party is responsible in the context of the overall assurance engagement;</p> <p>(b) The degree of public interest associated with the assurance engagement.</p>

	If the firm determines that the threat created by any such interest or relationship with a particular party would be trivial and inconsequential, it might not be necessary to apply all of the provisions of this section to that party.
<b>Network firms</b>	
<b>R900.16</b>	When a firm knows or has reason to believe that interests and relationships of a network firm create a threat to the firm's independence, the firm shall evaluate and address any such threat.
900.16 A1	Network firms are discussed in paragraphs 400.50 A1 to 400.54 A1.
<b>Related Entities</b>	
<b>R900.17</b>	When the assurance team knows or has reason to believe that a relationship or circumstance involving a related entity of the assurance client is relevant to the evaluation of the firm's independence from the client, the assurance team shall include that related entity when identifying, evaluating and addressing threats to independence.
<b>[Paragraphs 900.17 to 900.29 are intentionally left blank]</b>

900.32 A1	<p>Examples of actions that might be safeguards to address such threats include —</p> <p>(a) Using professionals who are not assurance team members to perform the service; and</p> <p>(b) Having an appropriate reviewer review the assurance and non-assurance work as appropriate.</p>
<b>R900.33</b>	<p>If a non-assurance service that would not be permitted during the engagement period has not been completed and it is not practical to complete or end the service before the commencement of professional services in connection with the assurance engagement, the firm shall only accept the assurance engagement if —</p> <p>(a) The firm is satisfied that —</p> <p>(i) The non-assurance service will be completed within a short period of time; or</p> <p>(ii) The client has arrangements in place to transition the service to</p>

	<p>another provider within a short period of time;</p> <p>(b) The firm applies safeguards when necessary during the service period; and</p> <p>(c) The firm discusses the matter with the party engaging the firm or those charged with governance of the assurance client.</p>
<b>Communication with Those Charged with Governance</b>	
900.34 A1	Paragraphs R300.9 to 300.9 A2 set out requirements and application material that is relevant to communications with a party engaging the firm or those charged with governance of the assurance client.
900.34 A2	Communication with a party engaging the firm or those charged with governance of the assurance client might be appropriate when significant judgments are made, and conclusions reached, to address threats to independence in relation to an assurance engagement because the subject matter information of that engagement is the outcome of a previously performed non-assurance service.
<b>[Paragraphs 900.35 to 900.39 are intentionally left blank]</b>	
<b>General Documentation of Independence for Assurance Engagements</b>	
<b>R900.40</b>	<p>A firm shall document conclusions regarding compliance with this Part, and the substance of any relevant discussions that support those conclusions. In particular —</p> <p>(a) When safeguards are applied to address a threat, the firm shall document the nature of the threat and the safeguards in place or applied; and</p> <p>(b) When a threat required significant analysis and the firm concluded that the threat was already at an acceptable level, the firm shall document the nature of the threat and the rationale for the conclusion.</p>

<b>SECTION 905</b>

<b>Introduction</b>	
905.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to

905.2	Fees or other types of remuneration might create a self-interest or intimidation threat. This section sets out specific requirements and application material relevant to applying the conceptual framework to identify, evaluate and address threats to independence arising from fees charged to assurance clients.
<b>Requirements and Application Material</b>	
<b>Fees Paid by an Assurance Client</b>	
905.3 A1	When fees are negotiated with and paid by an assurance client, this creates a self-interest threat and might create an intimidation threat to independence.
905.3 A2	The application of the conceptual framework requires that before a firm accepts an assurance engagement for an assurance client, the firm determines whether the threats to independence created by the fees proposed to the client are at an acceptable level. The application of the conceptual framework also requires the firm to re-evaluate such threats when facts and circumstances change during the engagement period.
905.3 A3	<p>Factors that are relevant in evaluating the level of threats created when fees are paid by the assurance client include —</p> <ul style="list-style-type: none"> <li>(a) The level of the fees for the assurance engagement and the extent to which they have regard to the resources required, taking into account the firm’s commercial and market priorities;</li> <li>(b) The extent of any dependency between the level of the fee for, and the outcome of, the service;</li> <li>(c) The level of the fee in the context of the service to be provided by the firm or a network firm;</li> <li>(d) The significance of the client to the firm or partner;</li> <li>(e) The nature of the client;</li> </ul>

	<p>(f) The nature of the assurance engagement;</p> <p>(g) The involvement of those charged with governance in agreeing fees; and</p> <p>(h) Whether the level of the fee is set by an independent third party, such as a regulatory body.</p>
905.3 A4	The conditions, policies and procedures described in paragraph 120.15 A3 (particularly the existence of a quality management system designed and implemented by a firm in accordance with quality management standards issued by the Institute of Singapore Chartered Accountants) might also impact the evaluation of whether the threats to independence are at an acceptable level.
905.3 A5	The requirements and application material that follow identify circumstances which might need to be further evaluated when determining whether the threats are at an acceptable level. For those circumstances, application material includes examples of additional factors that might be relevant in evaluating the threats.
<b>Level of Fees for Assurance Engagements</b>	
905.4 A1	Determining the fees to be charged to an assurance client, whether for assurance or other services, is a business decision of the firm taking into account the facts and circumstances relevant to that specific engagement, including the requirements of technical and professional standards.
905.4 A2	<p>Factors that are relevant in evaluating the level of self-interest and intimidation threats created by the level of the fee for an assurance engagement when paid by the assurance client include —</p> <p>(a) The firm’s commercial rationale for the fee for the assurance engagement; and</p> <p>(b) Whether undue pressure has been, or is being, applied by the client to reduce the fee for the assurance engagement.</p>
905.4 A3	Examples of actions that might be safeguards to address such threats include —

	<p>(a) Having an appropriate reviewer who does not take part in the assurance engagement assess the reasonableness of the fee proposed, having regard to the scope and complexity of the engagement; and</p> <p>(b) Having an appropriate reviewer who did not take part in the assurance engagement review the work performed.</p>
<b>Contingent Fees</b>	
905.5 A1	Contingent fees are fees calculated on a predetermined basis relating to the outcome of a transaction or the result of the services performed. A contingent fee charged through an intermediary is an example of an indirect contingent fee. In this section, a fee is not regarded as being contingent if established by a court or other public authority.
<b>R905.6</b>	A firm shall not charge directly or indirectly a contingent fee for an assurance engagement.
<b>R905.7</b>	A firm shall not charge directly or indirectly a contingent fee for a non-assurance service provided to an assurance client if the outcome of the non-assurance service, and therefore, the amount of the fee, is dependent on a future or contemporary judgment related to a matter that is material to the subject matter information of the assurance engagement.
905.7 A1	Paragraphs R905.6 and R905.7 preclude a firm from entering into certain contingent fee arrangements with an assurance client. Even if a contingent fee arrangement is not precluded when providing a non-assurance service to an assurance client, it might still impact the level of the self-interest threat.
905.7 A2	<p>Factors that are relevant in evaluating the level of such a threat include —</p> <p>(a) The range of possible fee amounts;</p> <p>(b) Whether an appropriate authority determines the outcome on which the contingent fee depends;</p>

	<p>(c) Disclosure to intended users of the work performed by the firm and the basis of remuneration;</p> <p>(d) The nature of the service; and</p> <p>(e) The effect of the event or transaction on the subject matter information.</p>
905.7 A3	<p>Examples of actions that might be safeguards to address such a self-interest threat include —</p> <p>(a) Having an appropriate reviewer who was not involved in performing the non-assurance service review the relevant assurance work; and</p> <p>(b) Obtaining an advance written agreement with the client on the basis of remuneration.</p>
<b>Total Fees — Overdue Fees</b>	
905.8 A1	The level of the self-interest threat might be impacted if fees payable by the assurance client for the assurance engagement or other services are overdue during the period of the assurance engagement.
905.8 A2	It is generally expected that the firm will obtain payment of such fees before the assurance report is issued.
905.8 A3	<p>Factors that are relevant in evaluating the level of such a self-interest threat include —</p> <p>(a) The significance of the overdue fees to the firm;</p> <p>(b) The length of time the fees have been overdue; and</p> <p>(c) The firm’s assessment of the ability and willingness of the client or other relevant party to pay the overdue fee.</p>
905.8 A4	<p>Examples of actions that might be safeguards to address such a threat include —</p> <p>(a) Obtaining partial payment of overdue</p>

	<p>fees; and</p> <p>(b) Having an appropriate reviewer who did not take part in the assurance engagement review the work performed.</p>
<b>R905.9</b>	<p>When a significant part of the fees due from an assurance client remains unpaid for a long time, the firm shall determine —</p> <p>(a) Whether the overdue fees might be equivalent to a loan to the client, in which case the requirements and application material set out in Section 911 are applicable; and</p> <p>(b) Whether it is appropriate for the firm to be re-appointed or continue the assurance engagement.</p>
<b>Total Fees — Fee Dependency</b>	
905.10 A1	When the total fees generated from an assurance client by the firm expressing the conclusion in an assurance engagement represent a large proportion of the total fees of that firm, the dependence on, and concern about the potential loss of, fees from that client impact the level of the self-interest threat and create an intimidation threat.
905.10 A2	A self-interest and intimidation threat is created in the circumstances described in paragraph 905.10 A1 even if the assurance client is not responsible for negotiating or paying the fees for the assurance engagement.
905.10 A3	In calculating the total fees of the firm, the firm might use financial information available from the previous financial year and estimate the proportion based on that information if appropriate.
905.10 A4	<p>Factors that are relevant in evaluating the level of such self-interest and intimidation threats include —</p> <p>(a) The operating structure of the firm; and</p> <p>(b) Where the firm is expected to diversify such that any dependence on the</p>

	assurance client is reduced.
905.10 A5	<p>Examples of actions that might be safeguards to address such threats include —</p> <p>(a) Reducing the extent of services other than assurance engagements provided to the client; and</p> <p>(b) Increasing the client base of the firm to reduce dependence on the assurance client.</p>
905.10 A6	A self-interest or intimidation threat is created when the fees generated by a firm from an assurance client represent a large proportion of the revenue from an individual partner's clients.
905.10 A7	<p>Factors that are relevant in evaluating the level of such threats include —</p> <p>(a) The qualitative and quantitative significance of the assurance client to the partner; and</p> <p>(b) The extent to which the compensation of the partner is dependent upon the fees generated from the client.</p>
905.10 A8	<p>Examples of actions that might be safeguards to address such a self-interest or intimidation threat include —</p> <p>(a) Having an appropriate reviewer who was not an assurance team member review the work;</p> <p>(b) Ensuring that the compensation of the partner is not significantly influenced by the fees generated from the assurance client; and</p> <p>(c) Increasing the client base of the partner to reduce dependence on the client.</p>
<b>SECTION 906</b>	
<b>GIFTS AND HOSPITALITY</b>	
<b>Introduction</b>	

906.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
906.2	Accepting gifts and hospitality from an assurance client might create a self-interest, familiarity or intimidation threat. This section sets out a specific requirement and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirement and Application Material</b>	
<b>R906.3</b>	A firm or an assurance team member shall not accept gifts and hospitality from an assurance client, unless the value is trivial and inconsequential.
906.3 A1	Where a firm or assurance team member is offering or accepting an inducement to or from an assurance client, the requirements and application material set out in Section 340 apply and non-compliance with these requirements might create threats to independence.
906.3 A2	The requirements set out in Section 340 relating to offering or accepting inducements do not allow a firm or assurance team member to accept gifts and hospitality where the intent is to improperly influence behaviour even if the value is trivial and inconsequential.
<b>SECTION 907</b>	
<b>ACTUAL OR THREATENED LITIGATION</b>	
<b>Introduction</b>	
907.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
907.2	When litigation with an assurance client occurs, or appears likely, self-interest and intimidation threats are created. This section sets out specific application material relevant to applying the conceptual framework in such circumstances.
<b>Application Material</b>	

<b>General</b>	
907.3 A1	The relationship between client management and assurance team members must be characterised by complete candour and full disclosure regarding all aspects of a client’s operations. Adversarial positions might result from actual or threatened litigation between an assurance client and the firm or an assurance team member. Such adversarial positions might affect management’s willingness to make complete disclosures and create self-interest and intimidation threats.
907.3 A2	Factors that are relevant in evaluating the level of such threats include —  (a) The materiality of the litigation; and  (b) Whether the litigation relates to a prior assurance engagement.
907.3 A3	If the litigation involves an assurance team member, an example of an action that might eliminate such self-interest and intimidation threats is removing that individual from the assurance team.
907.3 A4	An example of an action that might be a safeguard to address such self-interest and intimidation threats is having an appropriate reviewer review the work performed.
<b>SECTION 910</b>	
<b>FINANCIAL INTERESTS</b>	
<b>Introduction</b>	
910.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
910.2	Holding a financial interest in an assurance client might create a self-interest threat. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirements and Application Material</b>	
<b>General</b>	



910.3 A1	A financial interest might be held directly or indirectly through an intermediary such as a collective investment vehicle, an estate or a trust. When a beneficial owner has control over the intermediary or ability to influence its investment decisions, the Code defines that financial interest to be direct. Conversely, when a beneficial owner has no control over the intermediary or ability to influence its investment decisions, the Code defines that financial interest to be indirect.
910.3 A2	This section contains references to the “materiality” of a financial interest. In determining whether such an interest is material to an individual, the combined net worth of the individual and the individual’s immediate family members may be taken into account.
910.3 A3	<p>Factors that are relevant in evaluating the level of a self-interest threat created by holding a financial interest in an assurance client include —</p> <ul style="list-style-type: none"> <li>(a) The role of the individual holding the financial interest;</li> <li>(b) Whether the financial interest is direct or indirect; and</li> <li>(c) The materiality of the financial interest.</li> </ul>
<b>Financial Interests Held by the Firm, Assurance Team Members and Immediate Family</b>	
<b>R910.4</b>	<p>A direct financial interest or a material indirect financial interest in the assurance client shall not be held by —</p> <ul style="list-style-type: none"> <li>(a) The firm; or</li> <li>(b) An assurance team member or any of that individual’s immediate family.</li> </ul>
<b>Financial Interests in an Entity Controlling an Assurance Client</b>	
<b>R910.5</b>	When an entity has a controlling interest in the assurance client and the client is material to the entity, neither the firm, nor an assurance team member, nor any of that individual’s immediate family shall hold a direct or material indirect financial interest in that entity.
<b>Financial Interests Held as Trustee</b>	

**R910.6**

Paragraph R910.4 shall also apply to a financial interest in an assurance client held in a trust for which the firm or individual acts as trustee unless —

- (a) None of the following is a beneficiary of the trust: the trustee, the assurance team member or any of that individual's immediate family, or the firm;
- (b) The interest in the assurance client held by the trust is not material to the trust;
- (c) The trust is not able to exercise significant influence over the assurance client; and
- (d) None of the following can significantly influence any investment decision involving a financial interest in the assurance client: the trustee, the assurance team member or any of that individual's immediate family, or the firm.

**Financial Interests Received Unintentionally**

**R910.7**

If a firm, an assurance team member, or any of that individual's immediate family, receives a direct financial interest or a material indirect financial interest in an assurance client by way of an inheritance, gift, as a result of a merger, or in similar circumstances and the interest would not otherwise be permitted to be held under this section, then —

- (a) If the interest is received by the firm, the financial interest shall be disposed of immediately, or enough of an indirect financial interest shall be disposed of so that the remaining interest is no longer material; or
- (b) If the interest is received by an assurance team member, or by any of that individual's immediate family, the individual who received the financial interest shall immediately dispose of

	the financial interest, or dispose of enough of an indirect financial interest so that the remaining interest is no longer material.
<b>Financial Interests — Other Circumstances</b>	
<i>Close Family</i>	
910.8 A1	A self-interest threat might be created if an assurance team member knows that a close family member has a direct financial interest or a material indirect financial interest in the assurance client.
910.8 A2	Factors that are relevant in evaluating the level of such a threat include — <ul style="list-style-type: none"> <li>(a) The nature of the relationship between the assurance team member and the close family member;</li> <li>(b) Whether the financial interest is direct or indirect; and</li> <li>(c) The materiality of the financial interest to the close family member.</li> </ul>
910.8 A3	Examples of actions that might eliminate such a self-interest threat include — <ul style="list-style-type: none"> <li>(a) Having the close family member dispose, as soon as practicable, of all of the financial interest or dispose of enough of an indirect financial interest so that the remaining interest is no longer material; and</li> <li>(b) Removing the individual from the assurance team.</li> </ul>
910.8 A4	An example of an action that might be a safeguard to address such a self-interest threat is having an appropriate reviewer review the work of the assurance team member.
<i>Other Individuals</i>	
910.8 A5	A self-interest threat might be created if an assurance team member knows that a financial interest is held in the assurance client by individuals such as —

	<p>(a) Partners and professional employees of the firm, apart from those who are specifically not permitted to hold such financial interests by paragraph R910.4, or their immediate family members; and</p> <p>(b) Individuals with a close personal relationship with an assurance team member.</p>
910.8 A6	An example of an action that might eliminate such a self-interest threat is removing the assurance team member with the personal relationship from the assurance team.
910.8 A7	<p>Examples of actions that might be safeguards to address such a self-interest threat include —</p> <p>(a) Excluding the assurance team member from any significant decision-making concerning the assurance engagement; and</p> <p>(b) Having an appropriate reviewer review the work of the assurance team member.</p>
<b>SECTION 911</b>	
<b>LOANS AND GUARANTEES</b>	
<b>Introduction</b>	
911.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
911.2	A loan or a guarantee of a loan with an assurance client might create a self-interest threat. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirements and Application Material</b>	
<b>General</b>	
911.3 A1	This section contains references to the “materiality” of a loan or guarantee. In determining

	whether such a loan or guarantee is material to an individual, the combined net worth of the individual and the individual's immediate family members may be taken into account.
<b>Loans and Guarantees with an Assurance Client</b>	
<b>R911.4</b>	A firm, an assurance team member, or any of that individual's immediate family shall not make or guarantee a loan to an assurance client unless the loan or guarantee is immaterial to both —  (a) The firm or the individual making the loan or guarantee, as applicable; and  (b) The client.
<b>Loans and Guarantees with an Assurance Client that is a Bank or Similar Institution</b>	
<b>R911.5</b>	A firm, an assurance team member, or any of that individual's immediate family shall not accept a loan, or a guarantee of a loan, from an assurance client that is a bank or a similar institution unless the loan or guarantee is made under normal lending procedures, terms and conditions.
911.5 A1	Examples of loans include mortgages, bank overdrafts, car loans and credit card balances.
911.5 A2	Even if a firm receives a loan from an assurance client that is a bank or similar institution under normal lending procedures, terms and conditions, the loan might create a self-interest threat if it is material to the assurance client or firm receiving the loan.
911.5 A3	An example of an action that might be a safeguard to address such a self-interest threat is having the work reviewed by an appropriate reviewer, who is not an assurance team member, from a network firm that is not a beneficiary of the loan.
<i>Deposit or Brokerage Accounts</i>	
<b>R911.6</b>	A firm, an assurance team member, or any of that individual's immediate family shall not have deposits or a brokerage account with an assurance client that is a bank, broker, or similar institution, unless the deposit or account is held under normal commercial terms.
<b>Loans and Guarantees with an Assurance Client that is not a Bank or Similar Institution</b>	

<p><b>R911.7</b></p>	<p>A firm or an assurance team member, or any of that individual’s immediate family, shall not accept a loan from, or have a borrowing guaranteed by, an assurance client that is not a bank or similar institution, unless the loan or guarantee is immaterial to both —</p> <p>(a) The firm, or the individual receiving the loan or guarantee, as applicable; and</p> <p>(b) The client.</p>
<p><b>SECTION 920</b></p>	
<p><b>BUSINESS RELATIONSHIPS</b></p>	
<p><b>Introduction</b></p>	
<p>920.1</p>	<p>Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.</p>
<p>920.2</p>	<p>A close business relationship with an assurance client or its management might create a self-interest or intimidation threat. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.</p>
<p><b>Requirements and Application Material</b></p>	
<p><b>General</b></p>	
<p>920.3 A1</p>	<p>This section contains references to the “materiality” of a financial interest and the “significance” of a business relationship. In determining whether such a financial interest is material to an individual, the combined net worth of the individual and the individual’s immediate family members may be taken into account.</p>
<p>920.3 A2</p>	<p>Examples of a close business relationship arising from a commercial relationship or common financial interest include —</p> <p>(a) Having a financial interest in a joint venture with either the assurance client or a controlling owner, director or officer or other individual who</p>

920.5 A1	The purchase of goods and services, including the licensing of technology from an assurance client by a firm, or an assurance team member, or any of that individual's immediate family does not usually create a threat to independence if the transaction is in the normal course of business and at arm's length. 921.3 A1	A self-interest, familiarity or intimidation threat might be created by family and personal relationships between an assurance team member and a director or officer or, depending on their role, certain employees of the assurance client.
921.3 A2	Factors that are relevant in evaluating the level of such threats include — <ul style="list-style-type: none"> <li>(a) The individual’s responsibilities on the assurance team; and</li> <li>(b) The role of the family member or other individual within the assurance client, and the closeness of the relationship.</li> </ul>

921.4 A2	<p>Factors that are relevant in evaluating the level of such threats include —</p> <p>(a) The position held by the immediate family member; and</p> <p>(b) The role of the assurance team member.</p>
921.4 A3	An example of an action that might eliminate such a self-interest, familiarity or intimidation threat is removing the individual from the assurance team.
921.4 A4	An example of an action that might be a safeguard to address such a self-interest, familiarity or intimidation threat is structuring the responsibilities of the assurance team so that the assurance team member does not deal with matters that are within the responsibility of the immediate family member.
<b>R921.5</b>	<p>An individual shall not participate as an assurance team member when any of that individual's immediate family —</p> <p>(a) Is a director or officer of the assurance client;</p> <p>(b) In an attestation engagement, is an employee in a position to exert significant influence over the subject matter information of the assurance engagement; or</p> <p>(c) Was in such a position during any period covered by the engagement or the subject matter information.</p>
<b>Close Family of an Assurance Team Member</b>	
921.6 A1	<p>A self-interest, familiarity or intimidation threat is created when a close family member of an assurance team member is —</p> <p>(a) A director or officer of the assurance client; or</p> <p>(b) An employee in a position to exert significant influence over the underlying subject matter or, in an</p>

921.7 A2	An example of an action that might eliminate such a self-interest, familiarity or intimidation threat is removing the individual from the assurance team.
921.7 A3	An example of an action that might be a safeguard to address such a self-interest, familiarity or intimidation threat is structuring the responsibilities of the assurance team so that the assurance team member does not deal with matters that are within the responsibility of the individual with whom the assurance team member has a close relationship.
<b>Relationships of Partners and Employees of the Firm</b>	
921.8 A1	<p>A self-interest, familiarity or intimidation threat might be created by a personal or family relationship between —</p> <p>(a) A partner or employee of the firm who is not an assurance team member; and</p> <p>(b) Any of the following individuals at the assurance client:</p> <p style="padding-left: 40px;">(i) A director or officer;</p> <p style="padding-left: 40px;">(ii) An employee in a position to exert significant influence over the underlying subject matter, or in an attestation engagement, an employee in a position to exert significant influence over the subject matter information of the assurance engagement.</p>
921.8 A2	Factors that are relevant in evaluating the level of

	<p>such threats include —</p> <p>(a) The nature of the relationship between the partner or employee of the firm and the director or officer or employee of the client;</p> <p>(b) The degree of interaction of the partner or employee of the firm with the assurance team;</p> <p>(c) The position of the partner or employee within the firm; and</p> <p>(d) The role of the individual within the client.</p>
921.8 A3	<p>Examples of actions that might be safeguards to address such self-interest, familiarity or intimidation threats include —</p> <p>(a) Structuring the partner's or employee's responsibilities to reduce any potential influence over the assurance engagement; and</p> <p>(b) Having an appropriate reviewer review the relevant assurance work performed.</p>
<b>SECTION 922</b>	
<b>RECENT SERVICE WITH AN ASSURANCE CLIENT</b>	
<b>Introduction</b>	
922.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
922.2	If an assurance team member has recently served as a director or officer or employee of the assurance client, a self-interest, self-review or familiarity threat might be created. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirements and Application Material</b>	
<b>Service During the Period Covered by the Assurance Report</b>	

<p><b>R922.3</b></p>	<p>The assurance team shall not include an individual who, during the period covered by the assurance report —</p> <ul style="list-style-type: none"> <li>(a) Had served as a director or officer of the assurance client; or</li> <li>(b) Was an employee in a position to exert significant influence over the underlying subject matter or, in an attestation engagement, an employee in a position to exert significant influence over the subject matter information of the assurance engagement.</li> </ul>

<b>SERVING AS A DIRECTOR OR OFFICER OF AN ASSURANCE CLIENT</b>	
<b>Introduction</b>	
923.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
923.2	Serving as a director or officer of an assurance client creates self-review and self-interest threats. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirements and Application Material</b>	
<b>Service as Director or Officer</b>	
<b>R923.3</b>	A partner or employee of the firm shall not serve as a director or officer of an assurance client of the firm.
<b>Service as Company Secretary</b>	
<b>R923.4</b>	A partner or employee of the firm shall not serve as Company Secretary for an assurance client of the firm unless — <ul style="list-style-type: none"> <li>(a) This practice is specifically permitted under local law, professional rules or practice;</li> <li>(b) Management makes all decisions; and</li> <li>(c) The duties and activities performed are limited to those of a routine and administrative nature, such as preparing minutes and maintaining statutory returns.</li> </ul>
923.4 A1	The position of Company Secretary has different implications in different jurisdictions. Duties might range from: administrative duties (such as

	<p>personnel management and the maintenance of company records and registers) to duties as diverse as ensuring that the company complies with regulations or providing advice on corporate governance matters. Usually this position is seen to imply a close association with the entity. Therefore, a threat is created if a partner or employee of the firm serves as Company Secretary for an assurance client. (More information on providing non-assurance services to an assurance client is set out in Section 950, <i>Provision of Non-assurance Services to an Assurance Client</i>.)</p>

<b>EMPLOYMENT WITH AN ASSURANCE CLIENT</b>	
<b>Introduction</b>	
924.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
924.2	Employment relationships with an assurance client might create a self-interest, familiarity or intimidation threat. This section sets out specific requirements and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirements and Application Material</b>	
<b>General</b>	
924.3 A1	<p>A familiarity or intimidation threat might be created if any of the following individuals have been an assurance team member or partner of the firm:</p> <p>(a) A director or officer of the assurance client;</p> <p>(b) An employee in a position to exert significant influence over the underlying subject matter or, in an attestation engagement, an employee who is in a position to exert significant influence over the subject matter information of the assurance engagement.</p>



<i>Former Partner or Assurance Team Member Restrictions</i>	
<b>R924.4</b>	<p>If a former partner has joined an assurance client of the firm or a former assurance team member has joined the assurance client as —</p> <p>(a) A director or officer; or</p> <p>(b) An employee in a position to exert significant influence over the underlying subject matter or, in an attestation engagement, an employee in a position to exert significant influence over the subject matter information of the assurance engagement,</p> <p>the individual shall not continue to participate in the firm’s business or professional activities.</p>
924.4 A1	<p>Even if one of the individuals described in paragraph R924.4 has joined the assurance client in such a position and does not continue to participate in the firm’s business or professional activities, a familiarity or intimidation threat might still be created.</p>
924.4 A2	<p>A familiarity or intimidation threat might also be created if a former partner of the firm has joined an entity in one of the positions described in paragraph 924.3 A1 and the entity subsequently becomes an assurance client of the firm.</p>

<i>Assurance Team Members Entering Employment Negotiations with a Client</i>	
<b>R924.5</b>	A firm shall have policies and procedures that require assurance team members to notify the firm when entering employment negotiations with an assurance client.
924.5 A1	A self-interest threat is created when an assurance team member participates in the assurance engagement while knowing that the assurance team member will, or might, join the client sometime in the future.
924.5 A2	An example of an action that might eliminate such a self-interest threat is removing the individual from the assurance engagement.
924.5 A3	An example of an action that might be a safeguard to address such a self-interest threat is having an appropriate reviewer review any significant judgments made by that assurance team member while on the team.

<b>SECTION 940</b>	
<b>LONG ASSOCIATION OF PERSONNEL WITH AN ASSURANCE CLIENT</b>	
<b>Introduction</b>	
940.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
940.2	When an individual is involved in an assurance engagement of a recurring nature over a long period of time, familiarity and self-interest threats might be created. This section sets out requirements and application material relevant to applying the conceptual framework in such circumstances.
<b>Requirements and Application Material</b>	
<b>General</b>	
940.3 A1	A familiarity threat might be created as a result of an individual's long association with — <ul style="list-style-type: none"> <li>(a) The assurance client;</li> <li>(b) The assurance client's senior management; or</li> <li>(c) The underlying subject matter or, in an attestation engagement, subject matter information of the assurance engagement.</li> </ul>
940.3 A2	A self-interest threat might be created as a result of an individual's concern about losing a longstanding assurance client or an interest in maintaining a close personal relationship with a member of senior management or those charged with governance. Such a threat might influence the individual's judgment inappropriately.
940.3 A3	Factors that are relevant to evaluating the level of such familiarity or self-interest threats include — <ul style="list-style-type: none"> <li>(a) The nature of the assurance engagement;</li> <li>(b) How long the individual has been an</li> </ul>

	<p>assurance team member, the individual's seniority on the team, and the nature of the roles performed, including if such a relationship existed while the individual was at a prior firm;</p> <p>(c) The extent to which the work of the individual is directed, reviewed and supervised by more senior personnel;</p> <p>(d) The extent to which the individual, due to the individual's seniority, has the ability to influence the outcome of the assurance engagement, for example, by making key decisions or directing the work of other engagement team members;</p> <p>(e) The closeness of the individual's personal relationship with the assurance client or, if relevant, senior management;</p> <p>(f) The nature, frequency and extent of interaction between the individual and the assurance client;</p> <p>(g) Whether the nature or complexity of the underlying subject matter or subject matter information has changed; and</p> <p>(h) Whether there have been any recent changes in the individual or individuals at the assurance client who are responsible for the underlying subject matter or, in an attestation engagement, the subject matter information or, if relevant, senior management.</p>
940.3 A4	<p>The combination of two or more factors might increase or reduce the level of the threats. For example, familiarity threats created over time by the increasingly close relationship between an assurance team member and an individual at the assurance client who is in a position to exert significant influence over the underlying subject matter or, in an attestation engagement, the subject</p>

	matter information, would be reduced by the departure of that individual from the client.
940.3 A5	An example of an action that might eliminate the familiarity and self-interest threats in relation to a specific engagement would be rotating the individual off the assurance team.
940.3 A6	<p>Examples of actions that might be safeguards to address such familiarity or self-interest threats include —</p> <ul style="list-style-type: none"> <li>(a) Changing the role of the individual on the assurance team or the nature and extent of the tasks the individual performs;</li> <li>(b) Having an appropriate reviewer who was not an assurance team member review the work of the individual; and</li> <li>(c) Performing regular independent internal or external quality reviews of the engagement.</li> </ul>
<b>R940.4</b>	<p>If a firm decides that the level of the threats created can only be addressed by rotating the individual off the assurance team, the firm shall determine an appropriate period during which the individual shall not —</p> <ul style="list-style-type: none"> <li>(a) Be a member of the engagement team for the assurance engagement;</li> <li>(b) Perform an engagement quality review, or a review consistent with the objective of an engagement quality review, for the engagement; or</li> <li>(c) Exert direct influence on the outcome of the assurance engagement.</li> </ul> <p>The period shall be of sufficient duration to allow the familiarity and self-interest threats to be addressed.</p>
<b>SECTION 950</b>	
<b>PROVISION OF NON-ASSURANCE SERVICES TO ASSURANCE CLIENTS</b>	
<b>Introduction</b>	

950.1	Firms are required to comply with the fundamental principles, be independent, and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
950.2	Firms might provide a range of non-assurance services to their assurance clients, consistent with their skills and expertise. Providing certain non-assurance services to assurance clients might create threats to compliance with the fundamental principles and threats to independence.
950.3	This section sets out requirements and application material relevant to applying the conceptual framework to identify, evaluate and address threats to independence when providing non-assurance services to assurance clients.
950.4	New business practices, the evolution of financial markets and changes in technology are some developments that make it impossible to draw up an all-inclusive list of non-assurance services that firms might provide to an assurance client. The conceptual framework and the general provisions in this section apply when a firm proposes to a client to provide a non-assurance service for which there are no specific requirements and application material.
950.5	<p>The requirements and application material in this section apply where a firm —</p> <ul style="list-style-type: none"> <li>(a) Uses technology to provide a non-assurance service to an assurance client; or</li> <li>(b) Provides, sells, resells or licenses technology resulting in the provision of a non-assurance service by the</li> </ul>

	<p>firm —</p> <p>(i) To an assurance client; or</p> <p>(ii) To an entity that provides services using such technology to assurance clients of the firm.</p>
<b>Requirements and Application Material</b>	
<b>General</b>	
<i>Risk of Assuming Management Responsibilities When Providing a Non-Assurance Service</i>	
950.6 A1	When a firm provides a non-assurance service to an assurance client, there is a risk that a firm will assume a management responsibility in relation to the underlying subject matter and, in an attestation engagement, the subject matter information of the assurance engagement unless the firm is satisfied that the requirements in paragraphs R900.13 and R900.14 have been complied with.
<i>Accepting an Engagement to Provide a Non-Assurance Service</i>	
<b>R950.7</b>	Before a firm accepts an engagement to provide a non-assurance service to an assurance client, the firm shall apply the conceptual framework to identify, evaluate and address any threat to independence that might be created by providing that service.
<i>Identifying and Evaluating Threats</i>	
950.8 A1	A description of the categories of threats that might arise when a firm provides a non-assurance service to an assurance client is set out in paragraph 120.6 A3.
950.8 A2	<p>Factors that are relevant in identifying and evaluating the different threats that might be created by providing a non-assurance service to an assurance client include —</p> <p>(a) The nature, scope, intended use and</p>

purpose of the service;

(b) The manner in which the service will be provided, such as the personnel to be involved and their location;

(c) The client's dependency on the service, including the frequency with which the service will be provided;

(d) The legal and regulatory environment in which the service is provided;

(e) Whether the client is a public interest entity;

(f) The level of expertise of the client's management and employees with respect to the type of service provided;

(g) Whether the outcome of the service will affect the underlying subject matter and, in an attestation engagement, matters reflected in the subject matter

Materiality in Relation to an Assurance Client's Information	
950.9 A1	Materiality is a factor that is relevant in evaluating threats created by providing a non-assurance service to an assurance client. The concept of materiality in relation to an assurance client's subject matter information is addressed in <i>Singapore Standard on Assurance Engagements (SSAE) 3000 (Revised), Assurance Engagements other than Audits or Reviews of Historical Financial Information</i> . The determination of materiality involves the exercise of professional judgment and is impacted by both quantitative and qualitative factors. It is also affected by perceptions of the financial or other information needs of users.
Multiple Non-assurance Services Provided to the Same Assurance Client	
950.10 A1	A firm might provide multiple non-assurance services to an assurance client. In these circumstances the combined effect of threats created by providing those services is relevant to the firm's evaluation of threats.
Self-Review Threats	
950.11 A1	<p>A self-review threat might be created if, in an attestation engagement, the firm is involved in the preparation of subject matter information which subsequently becomes the subject matter information of an assurance engagement. Examples of non-assurance services that might create such self-review threats when providing services related to the subject matter information of an assurance engagement include —</p> <p>(a) Developing and preparing prospective information and subsequently issuing an assurance report on this information;</p> <p>(b) Performing a valuation that is related to or forms part of the subject matter information of an assurance engagement;</p>

	<p>(c) Designing, developing, implementing, operating, maintaining, monitoring, updating or upgrading IT systems or IT controls and subsequently undertaking an assurance engagement on a statement or report prepared about the IT systems or IT controls; and</p> <p>(d) Designing, developing, implementing, operating, maintaining, monitoring, updating or upgrading IT systems and subsequently issuing an assurance report on subject matter information, such as elements of non-financial information, that is prepared from information generated by such IT systems.</p>
Assurance clients that are public interest entities	
950.12 A1	Expectations about a firm's independence are heightened when an assurance engagement is undertaken by a firm for a public interest entity and the results of that engagement will be —

	<p>(a) Made available publicly, including to shareholders and other stakeholders; or</p> <p>(b) Provided to an entity or organisation established by law or regulation to oversee the operation of a business sector or activity.</p> <p>Consideration of these expectations forms part of the reasonable and informed third party test applied when determining whether to provide a non-assurance service to an assurance client.</p>
950.12 A2	<p>If a self-review threat exists in relation to an engagement undertaken in the circumstances described in paragraph 950.12 A1(b), the firm is encouraged to disclose the existence of that self-review threat and the steps taken to address it to the party engaging the firm or those charged with governance of the assurance client and to the entity or organisation established by law or regulation to oversee the operation of a business sector or activity to which the results of the engagement will be provided.</p>
<i>Addressing Threats</i>	
950.13 A1	<p>Paragraphs 120.10 to 120.10 A2 include a requirement and application material that are relevant when addressing threats to independence, including a description of safeguards.</p>
950.13 A2	<p>Threats to independence created by providing a non-assurance service or multiple services to an assurance client vary depending on facts and circumstances of the assurance engagement and the nature of the service. Such threats might be addressed by applying safeguards or by adjusting the scope of the proposed service.</p>

<b>Introduction</b>	
990.1	Firms are required to comply with the fundamental principles, be independent and apply the conceptual framework set out in Section 120 to identify, evaluate and address threats to independence.
990.2	This section sets out certain modifications to Part 4B which are permitted in certain circumstances involving assurance engagements where the report includes a restriction on use and distribution. In this section, an engagement to issue a restricted use and distribution assurance report in the circumstances set out in paragraph R990.3 is referred to as an “eligible assurance engagement”.
<b>Requirements and Application Material</b>	
<b>General</b>	
<b>R990.3</b>	<p>When a firm intends to issue a report on an assurance engagement which includes a restriction on use and distribution, the independence requirements set out in Part 4B shall be eligible for the modifications that are permitted by this section, but only if—</p> <p>(a) The firm communicates with the</p>

	<p>intended users of the report regarding the modified independence requirements that are to be applied in providing the service; and</p> <p>(b) The intended users of the report understand the purpose, subject matter information and limitations of the report and explicitly agree to the application of the modifications.</p>
990.3 A1	The intended users of the report might obtain an understanding of the purpose, subject matter information, and limitations of the report by participating, either directly, or indirectly through a representative who has authority to act for the intended users, in establishing the nature and scope of the engagement. In either case, this participation helps the firm to communicate with intended users about independence matters, including the circumstances that are relevant to applying the conceptual framework. It also allows the firm to obtain the agreement of the intended users to the modified independence requirements.
<b>R990.4</b>	Where the intended users are a class of users who are not specifically identifiable by name at the time the engagement terms are established, the firm shall subsequently make such users aware of the modified independence requirements agreed to by their representative.
990.4 A1	For example, where the intended users are a class of users such as lenders in a syndicated loan arrangement, the firm might describe the modified independence requirements in an engagement letter to the representative of the lenders. The representative might then make the firm's engagement letter available to the members of the group of lenders to meet the requirement for the firm to make such users aware of the modified independence requirements agreed to by the representative.
<b>R990.5</b>	When the firm performs an eligible assurance engagement, any modifications to Part 4B shall be limited to those modifications set out in paragraphs R990.7 and R990.8.

<b>Financial Interests, Loans and Guarantees, Close Business, Family and Personal Relationships</b>

Such an individual might be a professional accountant. This term is described in paragraph 300.8 A4.</i>
Assurance client	The responsible party and also, in an attestation engagement, the party taking responsibility for the subject matter information (who might be the same as the responsible party).
Assurance engagement	An engagement in which a public accountant aims to obtain sufficient appropriate evidence in order to express a conclusion designed to enhance the degree of confidence of the intended users other than the responsible party about the subject matter information (that is, the outcome of the measurement or evaluation of an underlying subject matter against criteria).

Eligible assurance engagement	<i>This term is described in paragraph 990.2 for the purposes of Section 990.</i>
Engagement partner	The partner or other person in the firm who is responsible for the engagement and its performance, and for the report that is issued on behalf of the firm, and who, where required, has
