



Changes to statutory requirements for AGM and filing of Annual Returns (AR) to take effect on 31 Aug 2018

Companies should take note of the following legislative changes to the Companies (Amendment) Act 2017 effective from 31 Aug 2018:

- Alignment of timelines for holding AGMs and filing ARs to the Financial Year-End (FYE)
- · Exemption for private companies from holding AGMs subject to specified safeguards

These changes are part of on-going efforts to reduce the regulatory burden for companies.



Three company directors convicted for false lodgement of information

In July and August, three company directors were convicted in the State Courts and levied with fines ranging from \$7,500 to \$9,500 for filing false or misleading information with ACRA. Company directors are reminded to take their statutory duties on filing true and accurate information with ACRA seriously. The business information that is lodged with ACRA is relied upon by the business community and general public for various purposes including checking on the health, status and officers of a company before making a business decision.
